APPLICATION TO EXTEND TIME FOR FILING REMAINING SCHEDULES, STATEMENTS AND OTHER REQUIRED DOCUMENTS

- 1. CareFocus Corporation ("Debtor"), as debtor in possession and through counsel in its chapter 11 case, files this application requesting the relief described below.
- 2. This Court has jurisdiction over this Application pursuant to 28 U.S.C. §§157 and 1334, Rule 5005 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and Local Rule 1070-1. This is a core proceeding pursuant to 28 U.S.C. §157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§1408 and 1409. The Debtor filed a voluntary petition under chapter 11 of title 11 of the United States Code on August 18, 2017. The case is currently pending in this Court.
- 3. This Application arises under 11 U.S.C. §§105, 521, 1107 and 1108 and Bankruptcy Rule 1007 and Local Rule 1007-I. Debtor requests an order allowing additional time to file its schedules, statements and other required documents with the Court.

RELIEF REQUESTED

- 4. Under Fed. R. Bankr. Procedure 1007(c), all schedules, statements and other documents not filed with the petition are to be filed within 14 days of the petition date or on or before September 1, 2017. Debtor seeks to extend that date by 7 days, to September 8, 2017.
- 5. Debtor's financial affairs and its books and records are not up to date. Therefore, Debtor is having difficulty completing and filing the required schedules and statements. It will be unlikely, if not impossible, for Debtor to complete its schedules and statements carefully, thoroughly and accurately

within the proscribed 14 days. Debtor expects to have all information necessary to enable it to complete the preparation of the required documents within the additional 7-day time period.

WHEREFORE, Debtor respectfully requests that the Court grant the Application to extend the time for filing the schedules and other documents consistent with the attached proposed order.
