Introduction

The Schedules of Assets and Liabilities (the "Schedules") and the Statement of Financial Affairs (the "Statement," and collectively with the Schedules, the "Schedules and Statement") of 1250 OCEANSIDE PARTNERS in this Chapter 11 case (the "Debtor") have been prepared by the Debtor's officer and representative.

These Notes and Qualifications are filed in support of the Schedules and Statement in order to explain the basis for certain responses, the limitations on the Debtor's knowledge and information (which may require that the Schedules and Statements be amended or supplemented), and to reserve rights for the benefit of the estate (and, to the extent applicable, the Debtor) which may be evidenced by further information.

While the Debtor has made every reasonable effort to ensure that the Schedules and Statement are accurate and complete based on information that was available to it at the time of preparation, subsequent information or discovery may result in material changes to these Schedules and Statement, and inadvertent errors or omissions may exist. Moreover, because the Schedules and Statement contain unaudited information which is subject to further review and potential adjustment, the Schedules and Statement may be incomplete (although the Debtor believes them to be complete). Nothing contained in the Schedules and Statement shall constitute a waiver of any of the Debtor's rights (or the rights of an appointed trustee or the bankruptcy estate), including specifically rights with respect to any issues involving equitable subordination and/or causes of action arising under the various provisions of the Bankruptcy Code and other relevant non-bankruptcy laws to recover assets or avoid transfers. Any reservation or rights in these Notes and Qualifications by the Debtor shall also be deemed a reservation for the benefit of any appointed trustee and the bankruptcy estate.

Amendment

While every reasonable effort has been made to file complete and accurate Schedules and Statement, inadvertent errors or omissions may exist. The Debtor reserves all rights to amend and/or supplement its Schedules and Statement as may be necessary or appropriate (including the right to amend the Schedules and Statement to be consistent with any rights reserved herein).

Basis of Presentation

These Schedules and Statement do not purport to represent financial statements prepared in accordance with Generally Accepted Accounting Principles ("GAAP").

Causes of Action

The Debtor, despite reasonable efforts, may not have set forth all of its causes of action against third parties as assets in its Schedules and Statement. The Debtor reserves all of its rights with respect to any causes of action it may have and neither these Notes and Qualifications nor the Schedules and Statement shall be deemed a waiver of any such causes of action. All of the Debtor's claims, rights of offset (whether stated or not), avoidance powers, and defenses and objections to claims are reserved.

Claims

Any failure to designate a claim on the Debtor's Schedules and Statement as "disputed," "contingent," or "unliquidated" does not constitute an admission by the Debtor that such amount is not "disputed," "contingent," or "unliquidated." The Debtor reserves the right to dispute any claim reflected on its Schedules or Statement on any grounds, including but not limited to amount, liability, or classification, or otherwise to designate subsequently such claims as "disputed," "contingent," or "unliquidated." The Debtor also reserves the right to re-designate any claim, previously listed as "disputed," "contingent," or "unliquidated." "unliquidated."

The Debtor has designated as "disputed" all claims of which the Debtor is currently aware that appear to be barred by the statute of limitations even if the claim was not previously disputed prior to the expiration of the applicable limitations period.

Any claim amounts that could not be fairly quantified by the Debtor has been scheduled as "unknown" or undetermined," or words of similar qualification.

Current Market Value

Unless otherwise indicated, net book values (if considered to be consistent with current value) or estimates of current value are reflected on the Debtor's Schedules and Statement. With respect to vehicles (if any), common references (such as Kelley Blue Book and Edmonds), were used to determine estimated values. Unless otherwise indicated, all amounts are reflected in U.S. dollars.

Petition Date

March 6, 2013, the day the Debtor commenced its Chapter 11 case, is the Petition Date.

Schedule D - Creditors Holding Secured Claims

Except as otherwise agreed pursuant to a stipulation or agreed order or general order entered by the Bankruptcy Court, the Debtor reserves its right to dispute or challenge the validity, extent, perfection, priority, or amount, or immunity from avoidance of any lien purported to have been granted or perfected with respect to any creditor or asset listed on Schedule D. Moreover, although the Debtor may have scheduled claims of various creditors as secured claims, the Debtor reserves all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any transaction or any document or instrument related to such creditor's claim.

Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent, and priority of any liens. Nothing in these Notes and Qualifications or the Schedules and Statement shall be deemed a modification or interpretation of the terms of such agreements. Except as specifically stated herein, real property lessors, utility companies, and other parties that may hold security deposits have not been listed on Schedule D.

Schedule E - Creditors Holding Unsecured Priority Claims

Schedule E is subject to reconciliation and, if necessary, amendment by the Debtor. The Debtor reserves the right to dispute or challenge the priority status of any creditors listed in such schedule.

The amount, if any, listed in Schedule E with respect to any employee benefit or pension plan is subject to the limitations set forth in 11 U.S.C. section 507(a)(4).

In preparing and executing the Schedules and Statement, the officer has necessarily relied on the Debtor's records, staff, and consultants.

NOTES:

- 1. In 2002, certain undeveloped house lots within the Hokuli'a Project (part of which is owned by 1250 Oceanside Partners ["1250 Oceanside"], the Debtor in this case, and part of which is owned by Front Nine, LLC ["Front Nine"]) were conveyed from 1250 Oceanside to Front Nine. The roadway lots within Hokuli'a were, and continue to be, owned by 1250 Oceanside. At various times after 2002, the Hokuli'a subdivision maps were modified, altering the course of some roadway lots and the configuration of certain undeveloped adjacent house lots. The intent of 1250 Oceanside and Front Nine is that 1250 Oceanside shall retain sole ownership of the roadway lots and Front Nine shall retain sole ownership of the undeveloped house lots conveyed to it, but the documentation to reflect the reconfiguration of various adjacent parcels may not have been completed. The real property records of the County of Hawaii indicate that 1250 Oceanside may have an interest in some of the Front Nine house lots, and that Front Nine may have an interest in some of the 1250 Oceanside roadway lots. 1250 Oceanside and Front Nine believe that the value of the property interest, if any, reflected on the County records as held by the other in its property is not material.
- 2. The Debtor's real property may be subject to rights or interests under Hawaii law that may be asserted by certain owners of abutting or neighboring property to passage over the Debtor's real property (commonly referred to as "kuleana" rights or interests). The Debtor knows of no "claim" (as defined by the Bankruptcy Code) of any holder of a kuleana right or interest but has included all such known parcel owners in the mailing matrix for the Debtor's case and, accordingly, has provided notice to them of this proceeding.
