**GLOBAL STATEMENT OF LIMITATIONS AND DISCLAIMER REGARDING

In preparing the Schedules and SOFAs, the CRO has relied on information provided by the Debtors' principals and their agents, as well as the Receiver appointed by the Supreme Court of the State of New York in a pending foreclosure action and his agents and advisors including court appointed accountants, without the aid of audits or other independent verification, and the information provided in the Schedules and SOFAs is presented to the best of the Debtors' and CRO's knowledge, information and belief as of the time of filing. While the CRO has made every effort to ensure that the Schedules and SOFAs are accurate and complete based on the information available to him at the time of preparation, inadvertent errors or omissions may have

occurred. The Schedules and SOFAs remain subject to further review and verification by the Debtors and the CRO, and subsequently discovered information may result in material changes in financial and other data contained in the Schedules and SOFAs. The Debtors reserve their right to amend their Schedules and SOFAs from time to time as may be necessary or appropriate. Nothing in the Schedules and SOFAs shall constitute a waiver of any of the Debtors' rights or an admission with respect to their cases.

This Global Statement of Limitations and Disclaimer Regarding Debtors' Schedules of Assets and Liabilities and Statements of Financial Affairs is incorporated by reference in, and comprises an integral part of, the Schedules and SOFAs.
