**Review of operations for the quarter ending 30 September 2003  
and Appendix 4C**

Analytica's strategy is to grow through mergers and acquisitions of under performing trading businesses in the life sciences industry to create critical mass in this sector. In July the Company made a takeover bid for the listed medical device company SSH Medical Limited. Analytica subsequently withdrew this takeover bid when the Board of SSH proposed a debt funding facility for that company. Analytica's interest in SSH however remains.

During the quarter, the Company has:

- Paid out the Deed of Company Arrangement;
- Strengthened its balance sheet by Psiron converting its preference shares to ordinary shares;
- Completed a small placement raising approximately \$350,000.

Cash at the end of the quarter was \$462,000. Cash outflow from operating activities was exceptionally high due to the final Deed of Company Arrangement payment of \$200,000. Excluding this payment the cash outflow of normal activities is reduced to \$126,000 for the quarter.
