On June 23, 2017, the above captioned debtors filed petitions for relief under Chapter 11 of the Bankruptcy Code, as set forth in note 1, *supra*. The debtors continue to manage and operate their businesses as debtors-in-possession pursuant to 11 U.S.C. §§ 1107 and 1108. The debtors' Chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered. An

Debtor plans to deposit all proceeds of this equipment sale into the Tulsa-AMG Specialty Hospital, LLC, segregated account.

WHEREFORE, Tulsa-AMG Specialty Hospital, LLC, prays that this Court grant its motion to allow it to sell the enumerated hospital equipment under the terms and conditions outlined in this motion, and for such other and further relief as is justified in the premises.
