NOW COMES, Advanced Solids Control, LLC, Debtor-in-Possession in the above styled

and numbered Chapter 11 bankruptcy case, and files this its Motion For Authorization to Sell

Remaining Personal Property Free and Clear of All Liens, Claims and Encumbrances at Reduced

Minimum Prices, and in support thereof would respectfully show the Court the following:

1. On December 2, 2016, Advanced Solids Control, LLC (hereinafter called "Debtor") filed its voluntary Petition for Relief under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Western District of Texas, San Antonio Division.

2. The assets proposed to be sold consists of the remaining personal property described as residential furniture from multiple real properties the Debtor owns/owned in New Mexico. The majority of the real properties have been sold, with one final property being put on the market at the end of the month, and the furniture must be liquidated. The Debtor has previously attempted to sell the furniture as a package with the real property with no success.

3. The Debtor previously filed a Motion to Sell the personal property pursuant to a Consignment Agreement with H. Lancaster Co. (whom is not related to the Debtor). Pursuant to the Consignment Agreement, the Debtor is to receive seventy percent (70%) of the gross sales proceeds.

4. On May 5, 2017, the Debtor filed a Motion to Sell furniture free and clear of all liens, claims and encumbrances at minimum prices. The Court approved the Motion, and on May 12, 2017, the Order Granting Authority to Sell Personal Property Free and Clear of All Liens, Claims and Encumbrances at Minimum Prices was entered authorizing the Debtor to sell furniture at minimum prices.

5. Pursuant to the Order authorizing sale of furniture, the Debtor has sold the furniture set forth on Exhibit "A" attached hereto in the total amount of \$14,867.25.

6. H. Lancaster Co. attempted to sell some of the furniture and was unable to sell a single piece of furniture.

7. The Debtor has the remaining furniture (including the furniture located in the final house in Carlsbad - 4004 North Pat Garrett), as set forth on Exhibit "B" attached hereto, left for sale.

8. The Debtor is not in a position to spend any more time and does not believe it will be cost effective to spend more time selling the remaining items of furniture.

9. The Debtor believes it is better to lower the minimum price in an effort to efficiently liquidate the remaining furniture. The new proposed minimum prices are set forth on Exhibit "B" attached hereto.

10. Most of the remaining furniture is more worn than other pieces, and has proven to be harder to sell than expected.

11. The Debtor's plan to liquidate the furniture as quickly as possible to generate what it believes to be the best value for the remaining pieces of furniture.

12. The Debtor believes that the proposed sale of the furniture will generate a reasonable value based upon the assets proposed to be sold and its marketability.

13. The proceeds from the sale will be used by the Debtor in its reorganization efforts/payment of creditors of the Estate.

14. The Debtor is requesting that the sale of the remaining furniture for the reduced minimum prices set forth on Exhibit "B" be free and clear of all liens, claims and encumbrances pursuant to §363 of the U.S. Bankruptcy Code.

15. A copy of the Order uploaded with this Motion is attached hereto.

WHEREFORE, PREMISES CONSIDERED, Debtor requests that the Court authorize it to sell free and clear of all liens, claims and encumbrances pursuant to §363 of the U.S. Bankruptcy Code the remaining personal property at the reduced minimum prices set forth on Exhibit "B" and pursuant to the terms set forth above, and for such other and further relief to which the Debtor may show itself entitled.
