

**ORDER GRANTING ADVANCED SOLIDS CONTROL, LLC AUTHORITY TO SELL
PERSONAL PROPERTY FREE AND CLEAR OF ALL LIENS, CLAIMS AND
ENCUMBRANCES TO PORTABLE MUD SYSTEMS, INC.**

On this day, came on to be considered the Motion of Advanced Solids Control, LLC for Authorization to Sell Personal Property Free and Clear of All Liens, Claims and Encumbrances to Portable Mud Systems, Inc., and it appearing to the Court that proper notice has been given to all parties and that no objections to the proposed sale have been filed, and further that such sale is in the best interest of the Debtor and its creditors, and accordingly, the Motion should be granted; it is therefore

ORDERED, ADJUDGED and DECREED that the sale of the equipment as set forth in Exhibit "A" attached hereto to Portable Mud Systems, Inc. is free and clear of all liens, claims and encumbrances pursuant to §363 of the U.S. Bankruptcy Code; and it is further

ORDERED, ADJUDGED and DECREED that the proceeds from the sale of the 2011 2500 Chevrolet Silverado Truck (Vin # xxxxxxxxx2484) shall be used by the Debtor in its reorganization efforts/payment of creditors of the Estate; and it is further

ORDERED, ADJUDGED and DECREED that all additional sale proceeds are to be paid to WTF Rentals, LLC as a partial payment on WTF Rentals, LLC's secured claim.
