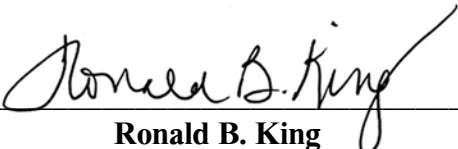

**ORDER GRANTING ADVANCED SOLIDS CONTROL, LLC AUTHORITY TO SELL  
PERSONAL PROPERTY FREE AND CLEAR OF ALL LIENS, CLAIMS AND

ORDERED, ADJUDGED and DECREED that the sale of the two (2) 4' Shale Bins as set forth in Exhibit "A" attached hereto to Closed Loop Specialties is free and clear of all liens, claims and encumbrances pursuant to §363 of the U.S. Bankruptcy Code, with the transfer to be accomplished through a Bill of Sale which specifically identifies the two (2) 4' Shale Bins being transferred to Closed Loop Specialties; and it is further

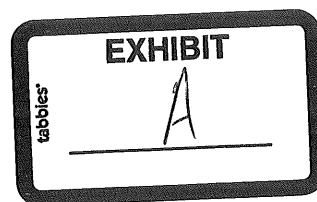
