## ORDER GRANTING ADVANCED SOLIDS CONTROL, LLC AUTHORITY TO SELL PERSONAL PROPERTY FREE AND CLEAR OF ALL LIENS, CLAIMS AND ENCUMBRANCES TO PORTABLE MUD SYSTEMS, INC.

On this day, came on to be considered the Motion of Advanced Solids Control, LLC for Authorization to Sell Personal Property Free and Clear of All Liens, Claims and Encumbrances to Portable Mud Systems, Inc. (the "Motion"), and it appearing to the Court that proper notice has been given to all parties and that no objections to the proposed sale have been filed, and further that such sale is in the best interest of the Debtor and its creditors, and accordingly, the Motion should be granted; it is therefore

ORDERED, ADJUDGED and DECREED that the Debtor is hereby granted authority to sell the personal property described on Exhibit "A" attached hereto, to Portable Mud Systems, Inc. in exchange for a lump sum payment in the amount of \$570,676.00. The sale shall be made pursuant to the terms of the Equipment Sale, Settlement and Release Agreement (the "Sale Agreement") attached to the Motion as Exhibit "B". To the extent the terms of the Motion or this Order differ from those of the Sale Agreement, the terms of the Asset Purchase Agreement shall control; and it is further

ORDERED, ADJUDGED and DECREED that the sale of the equipment described on Exhibit "A" attached hereto to Portable Mud Systems, Inc. is as is, where is; and it is further

ORDERED, ADJUDGED and DECREED that the sale of the equipment as set forth in Exhibit "A" attached hereto to Portable Mud Systems, Inc. is free and clear of all liens, claims and encumbrances pursuant to §363 of the U.S. Bankruptcy Code; and it is further

ORDERED, ADJUDGED and DECREED that the sale proceeds are to be paid to WTF Rentals, LLC as a partial payment towards WTF Rentals, LLC's secured claim; and it is further

ORDERED, ADJUDGED and DECREED that Portable Mud Systems, Inc. is not a "successor" to the Debtor or its estate by reason of any theory of law or equity, and Portable Mud Systems, Inc. shall not assume, or be deemed to assume, or in any way be responsible for any liability or obligation of the Debtor or its estate with respect to the equipment described in Exhibit

"A" or otherwise, including, but not limited to, under any bulk sales law, doctrine or theory of

successor liability, or similar theory or basis of liability. Neither the purchase of the equipment

described on Exhibit "A" attached hereto nor the fact that Portable Mud Systems, Inc. uses any of

the equipment previously used by the Debtor will cause Portable Mud Systems, Inc. to be deemed

a successor in any respect to the Debtor's business or incur any liability to arise therefrom within the

meaning of any foreign, federal, state or local law, rule, or regulation, or under any products liability

law or doctrine with respect to the Debtor's liability under such law, rule, regulation or doctrine.
