OMNIBUS NOTE REGARDING SCHEDULE "D"

The Debtors note the following regarding each of their Schedule "D."

One or more of the Debtors are obligated for the following: (i) an allocated portion of bond payments on account of bonds issued by the City of Frisco and/or the Frisco Square Management District; (ii) development agreements regarding the development and construction of improvements; and (iii) assessments and other charges payable to the Frisco Square Property Owners Association.

The foregoing are governed by numerous documents and instruments, including ordinances of the City of Frisco. The foregoing may also be chargeable against the Debtors or their properties pursuant to agreement, recorded instruments, and operation of law. Given these issues, prior owners of record, and the necessity of the Bankruptcy Case to date, the issues are complex and require further review and analysis.

The Debtors have not completed their analysis of which of the Debtors some or all of the foregoing are chargeable against and whether the same constitutes a lien or encumbrance against their real properties. The Debtors have also not finalized their analysis of which entity any of the foregoing are payable to (for example, MMD bond payments have previously been paid to the Property Owners Association, although this appears to have been for convenience). Furthermore, given the automatic acceleration of debt under the Bankruptcy Code, it is difficult to estimate the size of any secured claim. For similar reasons, it is unclear at present which of the foregoing obligations are subject to guarantees or other obligations from third parties, including prior owners.

Accordingly, the Debtors have scheduled potential secured creditors consisting of the foregoing on Schedule "D", together with disputed, contingent, and/or unliquidated claims based on the Debtors' preliminary analysis and good faith understanding of the issues. The Debtors make no admission concerning the same. Interested parties and secured creditors, including any of the foregoing, are cautioned to file proofs of claims if appropriate, to preserve their rights. The Debtors will endeavor to amend their Schedules "D" (and if appropriate any resulting amendments to Schedule "F", "G", and/or "H") once their analysis is completed.
