STIPULATION FOR CONTINUED USE OF CASH COLLATERAL

This Stipulation for Continued Use of Cash Collateral (the "<u>October Stipulation</u>") is made effective as of September 30, 2011, and entered into by and between (i) Boca Bridge, LLC (the "<u>Debtor</u>") and (ii) JMP Boca Bridge Lender, LLC, as assignee of NS/CS Boca, LLC ("<u>JMP</u>"), (the Debtor and JMP are together referred to herein as the "<u>Parties</u>").

WHEREAS, on August 19, 2010, RLC Communications Plus, Cintas Corporation, O.D.A., Inc., Sapphire Hospitality, Inc., Always Perfect Marble and Granite, Brothers Bake Shop, Project Management Consultant, Inc., RLC Architects, P.A., Arrow Security Corp., and Lundy Shacter, P.A. filed an involuntary petition under Chapter 11 of Title 11 of the United States Code;

WHEREAS, on October 15, 2010, the Court entered an Order for Relief in Involuntary Case and Order Setting Deadlines for Filing Schedules, Statements and Other Documents [Docket No. 31];

WHEREAS, on December 16, 2010, the Court entered a *Final Order Authorizing Debtor* to Use Cash Collateral and Granting Adequate Protection Liens (the "<u>Final Order</u>") [Docket No. 87];

WHEREAS, pursuant to the Final Order, the Debtor is authorized to use cash collateral pursuant to the approved budget attached as Exhibit A to the Final Order, through and until December 31, 2010;

WHEREAS, the Final Order provides, *inter alia*, that in the event that JMP's predecessor in interest NS/CSE Finance LLC ("<u>NorthStar</u>") is agreeable to the proposed budget, a stipulation may be filed by the Debtor and NorthStar which shall incorporate the proposed budget, and such budget will become Exhibit A of the Final Order for all purposes under this Final Order;

WHEREAS, the Debtor and NorthStar entered into a *Stipulation for Continued Use of Cash Collateral*, dated December 30, 2010 [Docket No. 92] (the "<u>January Stipulation</u>"), providing for the Debtor's use of cash collateral during January 2011 as set forth in Exhibit A attached to the January Stipulation;

WHEREAS, JMP Boca Bridge Lender, LLC, as assignee of NS/CS Boca, LLC, is the successor in interest to the claims against the Debtor previously held by NorthStar;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated February 1, 2011 [Docket No. 104] the ("February Stipulation"), providing for the Debtor's use of cash collateral during February 2011 as set forth in the Exhibit A attached to the February Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated February 28, 2011 [Docket No. 118] the ("<u>March Stipulation</u>"), providing for the Debtor's use of cash collateral during March 2011 as set forth in the Exhibit A attached to the March Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated March 21, 2011 [Docket No. 128] the ("<u>April Stipulation</u>"), providing for the Debtor's use of cash collateral during April 2011 as set forth in the Exhibit A attached to the April Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated April 30, 2011 [Docket No. 158] the ("<u>May Stipulation</u>"), providing for the Debtor's use of cash collateral during May 2011 as set forth in the Exhibit A attached to the May Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated May 31, 2011 [Docket No. 217] the ("June Stipulation"), providing for the Debtor's use of cash collateral during June 2011 as set forth in the Exhibit A attached to the June Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated June 30, 2011 [Docket No. 230] the ("July Stipulation"), providing for the Debtor's use of cash collateral during July 2011 as set forth in the Exhibit A attached to the July Stipulation;

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated July 26, 2011 [Docket No. 257] the ("<u>August Stipulation</u>"), providing for the Debtor's use of cash collateral during August 2011 as set forth in the Exhibit A attached to the August Stipulation; and

WHEREAS, the Parties entered into a *Stipulation for Continued Use of Cash Collateral*, dated July 26, 2011 [Docket No. 292] the ("<u>September Stipulation</u>"), providing for the Debtor's use of cash collateral during September 2011 as set forth in the Exhibit A attached to the September Stipulation.

NOW, THEREFORE, in consideration of the premises aforesaid and the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. <u>Authorization to Use Cash Collateral</u>. The Debtor is authorized to use Cash Collateral to make payments pursuant to the approved Budget through and until October 31, 2011, to pay the expenses shown on the approved Budget, attached hereto as **EXHIBIT A**.

2. <u>Applicable Provisions</u>. The additional applicable provisions agreed to by the Parties as set forth in the February Stipulation, March Stipulation, April Stipulation, May Stipulation, June Stipulation, July Stipulation, August Stipulation and September Stipulation remain in effect and all of the provisions in the Final Order entered on December 16, 2010 remain in effect.
