DECLARATION OF JUNG W. SONG ON BEHALF OF DONLIN, RECANO & COMPANY, INC. REGARDING VOTING AND TABULATION OF BALLOTS ACCEPTING AND REJECTING DEBTORS' SECOND AMENDED JOINT CHAPTER 11 PLAN

I, Jung W. Song, declare, under penalty of perjury to the best of my knowledge, information, and belief:²

1. I am the Managing Director at Donlin, Recano & Company, Inc. ("**DRC**") located

at 6201 15th Avenue Brooklyn, New York 11219. I am over the age of 18 years and competent to testify.

2. I submit this Declaration with respect to the *Debtors' Second Amended Joint Chapter 11 Plan*, dated December 29, 2015 [Docket No. 766] (together with all exhibits and as further amended, modified, and supplemented, the "**Plan**"). Except as otherwise indicated, all facts set forth herein are based upon my personal knowledge, information supplied to me by the Debtors or their advisors, including DRC, and my review of relevant documents. If I were called to testify, I could and would testify competently as to the facts set forth herein on that basis.

3. In accordance with the Order (A) Approving the Employment and Retention of Donlin, Recano & Company, Inc. as Administrative Advisor for the Debtors, Effective Nunc Pro Tunc to the Petition Date [Docket No. 211], DRC was authorized to assist the Debtors in connection with, *inter alia*, soliciting, receiving, and tabulating Ballots accepting or rejecting the Plan.

I. <u>Service and Transmittal of Solicitation Packages and Related Information</u>

4. Pursuant to the Plan, holders of Claims in Classes 3, 4, 5, and 6 as of the Voting Record Date were entitled to vote to accept or reject the Plan (collectively, the "**Voting Classes**").

5. The procedures for the solicitation and tabulation of votes on the Plan are set forth by the Order (A) Approving the Disclosure Statement on a Preliminary Basis, (B) Scheduling Combined Hearing on Approval of Disclosure Statement and Confirmation of Plan, (C) Establishing Procedures for Solicitation and Tabulation of Votes on Plan, and (D) Approving Related Matters [Docket No. 764] (the "Combined Hearing Order"). DRC was instructed to solicit, review, determine the validity of, and tabulate Ballots submitted to vote for the acceptance or rejection of the Plan by the holders of Claims in the Voting Classes in accordance with the Combined Hearing Order.

6. On or around December 31, 2015, DRC posted links on the Debtors' restructuring website maintained by DRC at <u>http://www.donlinrecano.com/bt</u> to provide parties with access to,

among other documents, copies of the Plan, the Amended Disclosure Statement for Debtors' Second Amended Joint Chapter 11 Plan, dated December 29, 2015 [Docket No. 767], the Combined Hearing Order, and the Combined Hearing Notice.

7. In accordance with the Combined Hearing Order, on December 31, 2015, DRC caused Solicitation Packages to be distributed to holders of Claims in the Voting Classes as of the Voting Record Date. DRC filed the *Affidavit of Donlin, Recano and Company, Inc. Regarding Service of Solicitation Packages with Respect to Amended Disclosure Statement for Debtors' Second Amended Joint Chapter 11 Plan (the "Affidavit of Service")* dated January 6, 2016 [Docket No. 788].

II. <u>General Tabulation Process</u>

8. As specified in the Combined Hearing Order, December 28, 2015 (the "**Voting Record Date**") was established as the record date for determining the holders of Claims in the Voting Classes who would be entitled to vote to accept or reject the Plan.

9. Pursuant to the Combined Hearing Order, DRC relied on the following information to identify and solicit Holders of Claims in the Voting Classes: (a) the *Schedules of Assets and Liabilities* filed with the Court by each Debtor on July 7, 2015 [Docket Nos. 169, 172, and 174]; and (b) the *Amended Schedules of Assets and Liabilities* filed with the Court by each Debtor on August 10, 2015 [Docket Nos. 359, 360, and 361]; (c) a lender list for holders of Term Loan Facility Claims provided by the Term Loan Agent; (d) a lender list for holders of ABL Facility Claims provided by the ABL Facility Agent; (e) the official claims register maintained by DRC as of December 28, 2015; and (f) claims information pertaining to the Debtors' chapter 11 cases as reflected in DRC's internal database to which this information was loaded. Using this information, and with guidance from the Debtors and their advisors, DRC created a voting database reflecting

the name, address, voting amount, and classification of Claims and Interests in the Voting Classes, and prepared a listing of claims listed in the Schedules or entered on the official claims register that were not eligible to cast a vote on the Plan as determined by the Combined Hearing Order (referred to as "**Disputed Claim**" in the Combined Hearing Order and herein). Using this voting database, DRC generated Ballots for Holders of Claims entitled to vote to accept or reject the Plan. DRC also generated Disputed Claims Notices to be sent to each Holder of a Disputed Claim.

10. Ballots returned by mail, hand delivery, or overnight delivery were received by personnel of DRC at its office in Brooklyn, New York. Ballots received by DRC were processed in accordance with the Combined Hearing Order. Upon receiving Ballots, DRC took the following actions:

- a. The envelopes containing the Ballots were opened, and the contents were removed and stamped with the date and time received. Each Ballot was then scanned into DRC's system and sequentially numbered (the "**Sequence Number**"); and
- b. DRC then entered into a computer database all pertinent information from each of the Ballots, including among other things, the date and time the Ballot was received, the Sequence Number, the voting dollar amount, and whether the creditor submitting the Ballot voted to accept or reject the Plan.

11. In order for a Ballot to be counted as valid, the Ballot must have been properly completed in accordance with the Combined Hearing Order, executed by the relevant holder or such holder's authorized representative, and actually received by DRC by 5:00 p.m. (prevailing Eastern Time) on January 21, 2016, unless extended by the Debtors (the "**Voting Deadline**"). All Ballots were to be delivered to DRC as follows: (a) if by hand delivery or overnight courier, to Donlin, Recano & Company, Inc., c/o Boomerang Tube, LLC, et al., Attn: Voting Department, 6201 15th Avenue Brooklyn, New York 11219; or (b) if by regular mail, to Donlin, Recano & Company, Inc., c/o Boomerang Tube, LLC, et al., Attn: Voting Department, P.O. Box 2034, Murray Hill Station, New York, New York 10156-0701.

12. All validly executed Ballots cast by holders of Claims in Voting Classes received by DRC on or before the Voting Deadline were tabulated as outlined in the Combined Hearing Order.

13. DRC is in possession of the Ballots received by it, and copies of same are available for review during DRC's normal business hours at 6201 15th Avenue, Brooklyn, New York, 11219.

III. <u>The Voting Results</u>

14. The results of the aforesaid tabulation of properly executed Ballots received on or before the Voting Deadline are set forth below and in the report annexed hereto as **Exhibit A** (the

"Final Tabulation Results").

15. At the direction of the Debtors' counsel, the voting deadline for Creditor National Oilwell Varco, L.P. (Ballot ID 000490) to submit a Ballot to accept or reject the Plan was extended to January 22, 2016 (the "**Extended Voting Deadline**"). The Ballot submitted by National Oilwell Varco, L.P. prior to the Extended Voting Deadline was included in the Final Tabulation Results.

16. At the Debtors' authorization, the timely submitted Ballot by J.B. Fabricating LLC (Ballot ID. 000410) that corrected a defect in a prior Ballot was accepted via e-mail and included in the Final Tabulation Results.

17. In accordance with the Combined Hearing Order, any Ballot submitted on behalf of claims under objection⁴ was excluded from the Final Tabulation Results and was assigned a defect code "O."

18. In accordance with the Combined Hearing Order, any Ballot not bearing a signature was excluded from the Final Tabulation Results and was assigned a defect code "A."

19. A complete list of all defective Ballots with the above-mentioned defective codes is set forth on **Exhibit B**.
