## PLAN SUPPLEMENT<sup>1</sup>

## **Retained Causes of Action**

The Debtors hereby file this supplement (the "Plan Supplement") to the Second Amended Plan of Liquidation Under Chapter 11 of the Bankruptcy Code of Caritas Health Care, Inc., Et. Al., (as same may be further amended, supplemented or modified from time to time, the "Plan") in accordance with Section IX of the Second Amended Disclosure Statement Pursuant to Section 1125 of the bankruptcy Code for Second Amended Plan of Liquidation Under Chapter 11 of the Bankruptcy Code of Caritas Health Care Inc., Et Al., to preserve any and all Claims and Causes of Action not expressly waived, relinquished, exculpated, released, compromised, or settled in the Plan or other Order of the Court.

The Debtors and the Plan Administrator, as applicable, shall retain and may enforce all rights to commence and pursue, as appropriate, any and all Causes of Action, whether arising before or after the Petition Date, including, but not limited to, any actions enumerated or otherwise described or referenced in this Plan Supplement, the Plan or the Disclosure Statement, and the Debtors' and the Plan Administrator's rights to commence, prosecute, and/or settle such Causes of Action shall be preserved notwithstanding the occurrence of the Effective Date.

The Debtors expressly reserve the right, at any time prior to the Effective Date, to supplement, modify or amend this Plan Supplement. Defined terms not otherwise defined herein shall have the meaning ascribed to them in the Plan (as defined herein).

Unless expressly released pursuant to the Plan or a Final Order of the Court, the failure to identify a Person in this Plan Supplement shall not constitute a release of any Causes of Action against such Person.

In reviewing the Plan and Disclosure Statement, and determining whether to vote for or against the Plan, Creditors and other parties should review this Plan Supplement.

The Causes of Action retained by the Debtors and the Plan Administrator include<sup>2</sup>:

1. In the Debtors respective Chapter 11 Schedules of Assets and Liabilities ("SOAL") and/or Statements of Financial Affairs ("SOFA," and together with the SOAL, the "Schedules"), each of which is incorporated herein by reference, the Debtors listed (i) all payments made by the Debtors within ninety (90) days prior to the Petition Date to creditors (SOFA Section 3(b)), (ii) all payments made by the Debtors within one (1) year prior to the Petition Date to creditors who are or were insiders of the Debtors (SOFA Section 3(c)), (iii) prepetition lawsuits with respect to which the Debtors were parties (SOFA Section 4(a)), and (iv) pre-petition leases and contracts to which the Debtors were parties (SOAL Schedule G). The Schedules can be viewed at the Debtors' restructuring website at http://dm.epiq11.com/chi or through the website maintained by the United States Bankruptcy Court for the Eastern District of New York at http://www.nyeb.uscourts.gov. Except as otherwise barred by an applicable statute of limitations which has not been tolled, either by the commencement of these Chapter 11 cases, by agreement of the parties or otherwise, the rights of the Debtors to pursue Causes of Action related to any of the foregoing, including, without limitation, all Causes of Action for avoidance and recovery pursuant to Section 550 of the Bankruptcy Code of transfers avoidable by reason of Section 544, 545, 547, 548, 549 or 553(b) of the Bankruptcy Code, or otherwise, including,

without limitation, from the Defendants in the Adversary Proceedings listed on Exhibit A hereto, and whether or not such Causes of Action have been commenced prior to the Effective Date and whether or not such Persons have been identified on the Schedules as having received a payment made by the Debtors within ninety (90) days prior to the Petition Date or, if such person is an insider of the Debtors, within one (1) year prior to the Petition Date, as well as the rights of the Debtors to pursue Causes of Action related to any other transfer, lawsuit, lease or contract inadvertently omitted from the Schedules, are hereby retained and preserved. Recovery related to any Cause of Action shall not be limited to any amounts set forth in the Schedules.

- 2. Causes of Action retained by the Debtors or the Plan Administrator by a Final Order of the Court or as shall be set forth in the Confirmation Order.
- 3. Causes of Action arising out of or relating to the sale or sales of any of the Debtors' Assets or any agreements ancillary thereto.
- 4. Causes of Action to recover money or property from patients, customers, vendors and/or employees whether based on contract or tort, including, without limitation, all rights pursuant to section 502(d) of the Bankruptcy Code to assert and prosecute any Causes of Action against creditors solely for the purpose of establishing that a creditor's claim against the Debtors must be disallowed for failure to repay an avoidable transfer.
- 5. Causes of Action to recover accounts receivable or other receivables or rights to payment created or arising in the ordinary course of any of the Debtors' businesses.
- 6. Causes of Action against vendors, suppliers or goods or services, or other parties for overpayments, back charges, duplicate payments, improper holdbacks, deposits, warranties, guarantees, indemnities or setoff.

- 7. Causes of Action against utilities, vendors, suppliers of goods or services, or other parties for wrongful termination, suspension of services or supply of goods, or failure to meet other contractual or regulatory obligations.
- 8. Causes of Action against utilities, vendors, suppliers of goods or services, or other parties for failure to fully perform or to condition performance on additional requirements under contracts with any one or more of the Debtors before the assumption or rejection of the subject contracts.
- 9. Causes of Action for payments, deposits, holdbacks, reserves or other amounts owed by any creditor, lessor, utility, supplier, vendor, insurer, surety, lender, bondholder, lessor or other party.
- 10. Causes of Action against insurance carriers, reinsurance carriers, underwriters or surety bond issuers relating to coverage, indemnity, contribution, reimbursement or other matters.
- 11. Causes of Action which are counterclaims and/or defenses relating to any action brought against the Debtors or the Plan Administrator.
- 12. Causes of Action related to or in connection with pre-petition lawsuits with respect to which the Debtors were parties, whether or not identified on the Schedules.
- 13. Causes of Action against local, state, and federal taxing authorities for refunds of overpayments or other payments.
- 14. Contract, tort or equitable Causes of Action that may exist or subsequently arise, whether or not identified on the Schedules.
- 15. Equitable subordination Causes of Action arising under section 510 of the Bankruptcy Code or other applicable law.
