**VESTING ORDER IN RESPECT OF THE ELECTRICAL TRANSMISSION LINES (#383)**

---

- [1] **CONSIDERING** Petitioners' Motion for the Issuance of a Vesting Order (*Transmission Lines to Hydro-Québec Transénergie*) (the "Motion");
- [2] **CONSIDERING** the representations of the parties;

[3] **GIVEN** the provisions of the *Companies' Creditors Arrangement Act ("CCAA")*;

**FOR THESE REASONS, THE COURT:**

[1] **AUTHORIZES** Abitibi-Consolidated Company of Canada ("ACCC") to enter into the agreement entitled *Entente de Principe Relative au Transfert de Certaines Lignes de Transport d'Électricité* (the "**Hydro Lines Agreement**") by and between ACCC, as transferor, and Hydro-Québec Transénergie ("HQ-T"), as transferee, filed as Exhibit R-1 to the Motion and into all the transactions contemplated therein with such alterations, changes, amendments, deletions or additions thereto, as may be agreed to with the consent of the Monitor;

[2] **ORDERS** and **DECLARES** that upon all conditions to closing having been satisfied or waived, all obligations of HQ-T that are required to be satisfied at or prior to closing under the Hydro Lines Agreement having been satisfied and the delivery of a written confirmation of same by the Monitor (the "**Monitor's Confirmation**"), all right, title and interest in and to the assets described in the Hydro Lines Agreement (the "**Transferred Assets**"), shall vest absolutely and exclusively in and with HQ-T, free and clear of and from any and all claims, liabilities, obligations, interests, prior claims, hypothecs, security interests (whether contractual, statutory or otherwise), liens, assignments, judgments, executions, writs of seizure and sale, options, adverse claims, levies, charges, liabilities (direct, indirect, absolute or contingent), pledges, executions, rights of first refusal or other pre-emptive rights in favour of third parties, mortgages, hypothecs, trusts or deemed trusts (whether contractual, statutory or otherwise), restrictions on transfer of title, or other claims or encumbrances, whether or not they have attached or been perfected, registered, published or filed and whether secured, unsecured or otherwise (collectively, the "**Transferred Assets Encumbrances**"), including without limiting the generality of the foregoing: (i) any Transferred Assets Encumbrances created by the Order issued on April 17, 2009 by Justice Clément Gascon, J.S.C., as amended, and/or any other CCAA order; and (ii) all Transferred Assets Encumbrances evidenced by registration, publication or filing pursuant to the Civil Code of Québec, any other personal or movable property registry system, the Bank Act or any other applicable legislation and, for greater certainty, **ORDERS** that all of the Transferred Assets Encumbrances affecting or relating to the Transferred Assets be expunged and discharged as against the Transferred Assets, in each case effective as of the applicable time and date set out in the Asset Transfer Agreement;

[3] **DECLARES** that ACCC is authorized to grant real and perpetual servitudes referred to in the Hydro Lines Agreement over the 60 meters width land upon which the L1-L2 Hydro Lines (as defined in the Motion) are erected, the whole as shown on the plans attached to technical descriptions prepared by Raynald Babin, Quebec Land Surveyor, on November 26, 2009 and December 8, 2009 under his minute numbers 5799 and 5804, copies of which were filed as Exhibit R-4 to the Motion, with such alterations, changes, amendments, deletions or additions thereto, as may be agreed to with the consent of the Monitor;

[4] **ORDERS** the Land Registrar of the Land Registry Office for the Registry Division of Saguenay, upon payment of the prescribed fees and the filing of a true copy of this Order and the Monitor's Confirmation to proceed with the partial cancellation of any and all Encumbrances, including, without limitation, the following registrations published at the said Land Registry:

- 16 146 347; and
- 16 286 872;

only however to the extent that said Encumbrances encumber immovables forming part of the Transferred Assets, including without limitation, the following immovables:


[5] **ORDERS** that notwithstanding:

- i) the proceedings under the CCAA;
- ii) any petitions for a receiving order now or hereafter issued pursuant to the Bankruptcy and Insolvency Act ("BIA") and any order issued pursuant to any such petition; or
- iii) the provisions of any federal or provincial legislation;

the vesting of the Transferred Assets, contemplated in this Vesting Order, as well as the execution of the Hydro Lines Agreement, are to be binding on any trustee in bankruptcy that may be appointed, and shall not be void or voidable nor deemed to be a settlement, fraudulent preference, assignment, fraudulent conveyance, transfer at undervalue or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall it give rise to an oppression or any other remedy; and

[6] **ORDERS** the provisional execution of this Vesting Order notwithstanding any appeal and without the necessity of furnishing any security;

[7] **THE WHOLE WITHOUT COSTS.**
