CHAPTER 11

**AGREED ORDER FOR USE OF CASH COLLATERAL PURSUANT TO
11 U.S.C. § 363 AND PROVIDING ADEQUATE PROTECTION INCLUDING
GRANTING OF POST-PETITION LIENS AND SECURITY INTERESTS**

On November 3, 2016, the Court heard at final hearing the Motion of Circle Z Pressure Pumping, LLC (the “Motion”) pursuant to Sections 361, 363 and 364 of the United States Bankruptcy Code and Federal Rule of Bankruptcy Procedure 4001. The Court initially heard this matter on an emergency basis on October 19, 2016, at 2:00 p.m. At the emergency hearing the parties announced the terms of an Agreed Interim Order for Use of Cash Collateral which was entered on October 24, 2016 (the “Interim Order”). The Interim Order authorized the Debtor to use cash collateral through November 3, 2016, and provided adequate protection to Austin Bank and Community Bank in the form of replacement liens as set forth in the Interim Order. Prior to the final hearing on November 3, the parties entered into the following agreement authorizing the Debtor’s use of cash collateral:

1. Austin Bank and Debtor hereby stipulate that:

A. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **2441**) dated February 5, 2016, in the original principal amount of \$4,904,849.82, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor

("Note-1"). Note-1 was modified by a Note Modification Agreement dated August 10, 2016. As of the Petition Date, the unpaid balance of Note-1 was not less than \$4,948,115.19.

B. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **8233**) dated February 5, 2016, in the original principal amount of \$1,366,142.60, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, as Managers of the Debtor ("Note-2"). As of the Petition Date, the unpaid balance of Note-2 was not less than \$1,375,366.06.

C. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **7673**) dated December 21, 2015, in the original principal amount of \$1,303,700.73, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, as Managers of the Debtor ("Note-3"). Note-3 was modified by a Renewal, Extension and Modification Agreement (Promissory Note and Deed of Trust) dated August 10, 2016. As of the Petition Date, the unpaid balance of Note-3 was not less than \$1,301,691.09.

D. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **9177**) dated July 13, 2015, in the original principal amount of \$1,000,000, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, as Managers of the Debtor ("Note-4"). As of the Petition Date, the unpaid balance of Note-4 was not less than \$998,752.92.

E. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **4617**) dated March 20, 2014, in the original principal amount of \$138,100, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, as Managers of the Debtor ("Note-5"). As of the Petition Date, the unpaid balance of Note-5 was not less than \$61,969.18.

F. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **6953**) dated December 9, 2013, in the original principal amount of \$71,617.68, executed by

David Chad Powell, David Gene Powell, and Michael Clayton Powell, as Managers of the Debtor (“Note-6”). As of the Petition Date, the unpaid balance of Note-6 was not less than \$23,616.91.

G. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **2473**) dated February 29, 2012, in the original principal amount of \$276,250.00, executed by David Chad Powell, David Gene Powell, Michael Clayton Powell, and Jason West, as Managers of the Debtor (“Note-7”). On February 28, 2015, the unpaid balance of Note-7 in the amount of \$208,390.33 was renewed by a Renewal, Extension and Modification Agreement. As of the Petition Date, the unpaid balance of Note-7 was not less than \$168,308.44.

H. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **5729**) dated November 10, 2015 (renewed August 10, 2016), in the original principal amount of \$750,000.00, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-8”). Note-8 was modified by a Renewal, Extension and Modification Agreement (Revolving Promissory Note and Deed of Trust) dated August 10, 2016. As of the Petition Date, the unpaid balance of Note-8 was not less than \$501,614.58.

I. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **0665**) dated June 29, 2016 (renewed August 10, 2016), in the original principal amount of \$250,000, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-9”). As of the Petition Date, the unpaid balance of Note-9 was not less than \$251,614.53.

J. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **3777**) dated August 31, 2016, in the original principal amount of \$200,100.00, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor

(“Note-10”). As of the Petition Date, the unpaid balance of Note-10 was not less than \$200,571.73.

K. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending 4321) dated September 12, 2016, in the original principal amount of \$50,100.00, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-11”). As of the Petition Date, the unpaid balance of Note-11 was not less than \$50,183.54.

L. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending 4513) dated September 15, 2016, in the original principal amount of \$100,100.00 executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-12”). As of the Petition Date, the unpaid balance of Note-12 was not less than \$100,249.64.

M. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending 4665) dated September 19, 2016, in the original principal amount of \$50,100.00, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-13”). As of the Petition Date, the unpaid balance of Note-13 was not less than \$50,163.37.

N. Austin Bank is the owner and holder of a Promissory Note (Loan No. ending **4817**) dated September 21, 2016, in the original principal amount of \$100,100.00, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell as Managers of the Debtor (“Note-14”). As of the Petition Date, the unpaid balance of Note-14 was not less than \$100,215.11.

O. The debt evidenced by Note-1 through Note-14 is referred to herein collectively as the **Austin Bank Indebtedness**. As of the Petition Date, the Austin Bank Indebtedness was not less than \$10,132,432.30.

P. The Austin Bank Indebtedness is secured by the following property of the estate: (1) real and personal property more fully described in a Deed of Trust (Security Agreement, Assignment of Leases, Assignment of Rents and Financing Statement) dated February 29, 2012; (2) the property more fully described in a Commercial Security Agreement dated December 9, 2013; (3) the property more fully described in a Commercial Security Agreement dated June 20, 2014, including Exhibit A to the Commercial Security Agreement; (4) the property more fully described in a Commercial Security Agreement dated December 21, 2015, including Exhibit A to the Commercial Security Agreement; and (5) the property more fully described in a Commercial Security Agreement dated February 5, 2016, including Exhibit A to the Commercial Security Agreement. The real and personal property more fully described in the Deed of Trust and Commercial Security Agreements is referred to herein collectively as the **Austin Bank Collateral**.¹ The Austin Bank Collateral includes a security interest in all accounts, contract rights, chattel paper, instruments, general intangibles, rights to payment of every kind, arising out of the business of the Debtor; and all inventory, raw materials, works in progress, and materials used or consumed in Debtor's business, and the products thereof, all of which constitute Cash Collateral as defined in 11 U.S.C. §363 ("Cash Collateral"). A detailed list of the equipment included in the Austin Bank Collateral is set forth in **Exhibit B**, and includes all substitutes, replacements, additions, accessions, and attachments thereto, tools, parts and equipment added

to, incorporated into, affixed to or used in connection with the equipment, and all proceeds thereof. The list attached as Exhibit B is not intended to be exhaustive and shall not prejudice the rights of Austin Bank in any property not listed upon which Austin Bank holds a perfected security interest. The liens and security interests in the Austin Bank Collateral are valid, perfected, enforceable liens and security interests, and are not subject to defense or avoidance.

Q. NOTICE OF THE STIPULATIONS SET FORTH IN THE PRECEDING PARAGRAPH (the “NOTICE of STIPULATIONS”) SHALL BE SERVED ON ALL CREDITORS AND OTHER PARTIES-IN-INTEREST, INCLUDING THE UNSECURED CREDITORS COMMITTEE. THE STIPULATIONS BETWEEN AUSTIN BANK AND DEBTOR SHALL BE BINDING ON ALL CREDITORS AND OTHER PARTIES-IN-INTEREST UNLESS A CREDITOR OR OTHER PARTY-IN-INTEREST FILES A COMPLAINT ON OR BEFORE 90 DAYS FROM THE DATE THE NOTICE IS SERVED, CONTESTING THE LIEN OR SECURITY INTEREST OF AUSTIN BANK IN THE AUSTIN BANK COLLATERAL.

2. Community Bank and Debtor hereby stipulate that:

A. Community Bank is the owner and holder of a Promissory Note (Loan No. ending 1076) dated August 12, 2016, in the original principal amount of \$1,440,887.46, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, individually and as Managers of the Debtor (“Note-A”). As of the Petition Date, the unpaid balance of Note-A was not less than \$1,445,555.71.

B. Community Bank is the owner and holder of a Promissory Note (Loan No. ending 1265) dated August 12, 2016, in the original principal amount of \$574,889.38, executed by David Chad Powell, David Gene Powell, and Michael Clayton Powell, individually and as

Managers of the Debtor (“Note-B”). As of the Petition Date, the unpaid balance of Note-B was not less than \$576,685.91.

C. The debt evidenced by Note-A and Note-B is referred to herein collectively as the **Community Bank Indebtedness**. As of the Petition Date, the Community Bank Indebtedness was not less than \$ 2,022,241.60.

D. The Community Bank Indebtedness is secured by the following property of the bankruptcy estate: (1) the property more fully described in a Security Agreement dated August 12, 2016; and (2) the property more fully described in a Security Agreement dated August 12, 2016. The real and personal property more fully described in the Security Agreements is referred to herein collectively as the **Community Bank Collateral**.² The Community Bank Collateral includes: all accounts, contract rights, chattel paper, instruments, and other rights to payment, general intangibles of the business of the Debtor; and all inventory, raw materials, works in progress and materials used or consumed in Debtor's business, including the products and proceeds thereof, all of which constitute Cash Collateral as defined in 11 U.S.C. §363 (“Cash Collateral”). A detailed list of the equipment included in the Community Bank Collateral is set forth in **Exhibit C**, and includes all increases, parts, fittings, accessories, special tools, and accessions attached to or used in connection therewith, and replacements, products and proceeds of the foregoing. The list attached as Exhibit C is not intended to be exhaustive and shall not prejudice the rights of Community Bank in any property not listed upon which Community Bank holds a perfected security interest. The liens and security interests in the Community Bank

Collateral are valid, perfected, enforceable liens and security interests, and are not subject to defense or avoidance.

E. NOTICE OF THE STIPULATIONS SET FORTH IN THE PRECEDING PARAGRAPH (the “NOTICE of STIPULATIONS”) SHALL BE SERVED ON ALL CREDITORS AND OTHER PARTIES-IN-INTEREST INCLUDING THE UNSECURED CREDITORS COMMITTEE. THE STIPULATIONS BETWEEN COMMUNITY BANK AND DEBTOR SHALL BE BINDING ON ALL CREDITORS AND OTHER PARTIES-IN-INTEREST UNLESS A COMPLAINT IS FILED BY A CREDITOR OR OTHER PARTY-IN-INTEREST ON OR BEFORE 90 DAYS FROM THE DATE THE NOTICE IS SERVED, CONTESTING THE LIEN OR SECURITY INTEREST OF COMMUNITY BANK IN THE COMMUNITY BANK COLLATERAL.

3. Austin Bank, Community Bank and the Debtor hereby stipulate that:

A. On October 11, 2016, Debtor filed a voluntary petition under Chapter 11 of the United States Bankruptcy Code (the “Petition Date”). Debtor is continuing to operate its business as Debtor-in-Possession.

B. This Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 137(b)(2).

C. As of the Petition Date, the Debtor had on hand approximately \$25,011.48 in cash and owned \$4,263,266.65 in outstanding accounts receivable, of which \$444,218.44 was current and collectible. The cash and accounts receivable is the Cash Collateral of Austin Bank and Community Bank.

D. Debtor will not be able to pay its operating expenses and carry on its business without the use of the Cash Collateral. Use of the Cash Collateral is necessary to preserve and maintain the going concern value of the Debtor's estate.

4. Austin Bank, Community Bank and the Debtor hereby agree that:

A. Term of Authorization. The Debtor is authorized to use the Cash Collateral, subject to the terms and conditions of this Order, until 11:59 p.m. on December 31, 2016, or as otherwise extended by agreement of the parties filed with the Court or by Order of this Court. The authorization to use Cash Collateral shall automatically terminate if (1) relief from stay is obtained with respect to the Austin Bank Collateral or the Community Bank Collateral, (2) the case is dismissed, (3) the case is converted to Chapter 7, (iv) a Chapter 11 trustee is appointed; (v) a payment is made which is not authorized by this Order or consented to in writing by Austin Bank and Community Bank; or (vi) Debtor fails to cure a default under this Order within ten days after receiving notice of the default.

B. Scope of Authorization. Debtor is authorized to use the Cash Collateral: (i) in accordance with the Budget, attached hereto as **Exhibit A**, (ii) to pay the actual amount owed to any utility company or any insurance premium payments to protect property of the estate, (iii) for payment of U.S. Trustee fees, and (iv) for professional fees and expenses pursuant to orders entered by this Court after appropriate notice and hearing, pursuant to 11 U.S.C. §§327-328, and 330. Debtor may not use line item budgeted amounts on a cumulative basis and may not use the Cash Collateral for payment to any Insiders of Debtor, as defined at 11 U.S.C. § 101(31), except as set forth in the Budget. Debtor is also authorized to use Cash Collateral in the event of an emergency, to pay expenses which are not itemized on the Budget, in order to preserve property of the estate, provided the expense does not exceed \$2,500.00 and written notice is immediately

provided to Austin Bank and Community Bank. Debtor is also authorized to use Cash Collateral with the prior written consent of Austin Bank and Community Bank.

C. Adequate Protection.

(1) Replacement Liens. Pursuant to 11 U.S.C. §§ 361, 363, 507(b) and 552(b), as adequate protection for Austin Bank's interest in Cash Collateral, to the extent Debtor uses Cash Collateral, Austin Bank is granted a valid, attached, choate, enforceable, perfected, continuing, non-avoidable first priority security interest in, and lien upon all accounts, contract rights, chattel paper, instruments, general intangibles, and rights to payment of every kind arising out of the business of the Debtor, all inventory, raw material, works in progress and the proceeds thereof (the "Post-Petition Collateral"). Pursuant to 11 U.S.C. §§ 361, 363, 507(b) and 552(b), as adequate protection for Community Bank's interest in Cash Collateral, to the extent Debtor uses Cash Collateral, Community Bank is granted a valid, attached, choate, enforceable, perfected, continuing, non-avoidable security interest in, and lien upon all accounts, contract rights, chattel paper, instruments, general intangibles, and rights to payment of every kind arising out of the business of the Debtor, all inventory, raw material, works in progress and the proceeds thereof, subject only to the prior security interest of Austin Bank in the Post-Petition Collateral. No further action shall be required for Austin Bank and Community Bank to perfect their liens and security interests in the Post-Petition Collateral. With respect to the post-petition liens and security interests granted by this Order, Austin Bank and Community Bank may, but need not, take such steps as they deem desirable and applicable to comply with such Statutes, and all financing statements and other documents that are filed listing Debtor as borrower and Austin Bank and Community Bank as lender shall be deemed to have been filed and the post-petition liens and security interests granted herein shall be deemed to have been perfected on the Petition

Date. Debtor shall execute and deliver to Austin Bank and Community Bank all such agreements, financing statements, instruments, and other documents as Austin Bank and Community Bank may reasonably request to evidence, confirm, validate, or perfect the liens granted pursuant hereto. The liens on Post-Petition Collateral are granted as adequate protection against any diminution in the value of any liens and security interests of Austin Bank and Community Bank in any property of Debtor (including, without limitation, the pre-petition collateral) resulting from the imposition of the automatic stay or any use, sale, consumption or other disposition of such property (whether pursuant to this or any other order of this Court or the Bankruptcy Code) and shall have priority over all other creditors, against Debtor's cash on hand, accounts receivable, inventory, raw material, works in progress and the proceeds thereof originating post-petition. Austin Bank's interest in the Cash Collateral has priority over the interest of Community Bank. Austin Bank and Community Bank reserve the right to assert whatever rights they may have to any pre-petition preference payments and other avoidable transfers made by Debtor from funds that would otherwise be Cash Collateral. Austin Bank and Community Bank reserve the right to seek adequate protection payments in connection with the use of the Cash Collateral.

(2) Minimum Cash and Accounts Receivable Balances. Debtor shall at all times maintain cash on hand and accounts receivable which are current and collectible with an aggregate total of not less than **\$469,000.00**. An account is current and collectible if it is not more than 90 days old unless the Debtor knows the account is uncollectable.

D. Request for Adequate Protection by Other Creditors. In the event of a request by another secured creditor for adequate protection which would require the payment of cash to that creditor, the Debtor will not agree to such a request without first consulting with Austin Bank

and Community Bank. Nothing contained herein shall authorize the Debtor to use the Cash Collateral to make adequate protection payments to another creditor without the consent of Austin bank and Community Bank or authorization by order of the Court after notice and opportunity for hearing. Furthermore, nothing herein shall require the Debtor to oppose any creditor request for adequate protection nor shall anything herein prevent the Court from awarding adequate protection to any other secured creditor, after notice to all parties-in-interest including the Austin Bank and Community Bank and opportunity for hearing.

E. Access to Records. Debtor is directed to provide Austin Bank and Community Bank with reasonable access to Debtor's books and records to the extent deemed necessary by either Bank to ensure compliance with this Order.

F. Proof of Casualty Insurance. Debtor shall maintain and provide to Austin Bank certificates of casualty insurance coverage on the Austin Bank Collateral, to the extent provided under the pre-petition loan documents. Debtor shall provide Austin Bank with prompt notification of any change in such coverage which may hereafter occur. Debtor shall maintain and provide to Community Bank certificates of casualty insurance coverage on the Community Bank Collateral, to the extent provided under the pre-petition loan documents. Debtor shall provide Community Bank with prompt notification of any change in such coverage which may hereafter occur.

G. Reporting. Debtor shall provide a copy of its monthly operating report, and any other reports Austin Bank or Community Bank reasonably requests. Debtor shall provide to Austin Bank and Community Bank:

- (1) a cash flow report on the 1st day of each month beginning November 1, 2016, showing all receipts and expenditures for the period from the 16th day of the

prior month to the end of the prior month, identifying the source of each receipt and the budgeted line item for each expenditure (the first report shall be for the period October 11, 2016 to October 31, 2016);

(2) a cash and accounts receivable report on 1st day of each month beginning November 1, 2016, showing all cash and receivables as of last day of the prior month;

(3) an accounts payable report on the 1st day of each month beginning November 1, 2016, showing outstanding accounts payable as of the last day of the prior month;

(4) a jobs report on the 1st day of each month beginning December 1, 2016 showing in detail jobs priced and amounts, jobs booked and amounts, and jobs in progress and amounts as of the last day of the prior month;

(5) a cash flow report on the 16th day of each month beginning November 16, 2016, showing all receipts and expenditures for the prior 15 day period and identifying the source of each receipt and the budgeted line item for each expenditure;

(6) a cash and accounts receivable report on the 16th day of each month beginning November 16, 2016, showing Debtor's cash and accounts receivable balances as of the 15th day of the month;

(7) an accounts payable report on the 16th day of each month beginning November 16, 2016, showing outstanding accounts payable as of the 15th day of the month; and

(8) a jobs report on the 16th day of each month beginning November 16, 2016 showing in detail jobs priced and amounts, jobs booked and amounts, and jobs in progress and amounts as of the 15th day of the month.

If a report is due on a Saturday, Sunday or holiday then it shall be due on the next business day. All reports shall be consistently on a cash or accrual basis and shall be provided via electronic mail to Shannon Seay at sseay@austinbank.com, Kathy Tittle at ktittle@cbanktexas.com and Glen Patrick at glenpatrick@suddenlinkmail.com. A copy of the Debtor's general ledger for the corresponding period shall be provided with each report.

H. Revenue Accounting. Debtor shall deposit and account for all monies and revenue generated from the operation of its business. Subject to payment of the authorized expenses set forth at Paragraph 4(B) herein, all monies and revenue shall be deposited into Debtor's DIP operating account and shall not be used for any other purpose.

I. Contribution. A contribution to Debtor from an "insider", as that term is defined in the Bankruptcy Code, shall be treated as a capital contributions and not as a loan.

J. Location of Collateral. Debtor shall provide Austin Bank a list and current location of the Austin Bank Collateral on or before November 10, 2016. Thereafter, if Austin Bank Collateral is moved to a new location then Debtor shall give Austin Bank notice within three business days, identifying the item moved and the new location. Debtor shall provide Community Bank a list and current location of the Community Bank Collateral on or before November 10, 2016. If Community Bank Collateral is moved to a new location then Debtor shall give Community Bank notice within three business days, identifying the item moved and the new location.

K. Collateral Inspection. Austin Bank and Community Bank are entitled to review and inspect their collateral at any time upon reasonable notice to Debtor of the date, location and time of the planned inspection and Debtor is directed to cooperate.

L. Maintenance of Collateral. Debtor shall maintain the Austin Bank Collateral and the Community Bank Collateral and keep it in good repair and condition at all times. Debtor shall not permit any liens, including mechanic's or materialman's liens (or tax liens) to be placed against the Collateral. If Austin Bank Collateral needs maintenance or repair work then Debtor shall promptly, and in no event more than three business days after the Debtor identifies that maintenance or repair work is needed, give notice to Austin Bank. If Community Bank Collateral needs maintenance or repair work then Debtor shall promptly, and in no event more than three business days after the Debtor identifies that maintenance or repair work is needed, give notice to Community Bank. The notice shall identify the item, describe the repair or maintenance work to be performed, and state the name, address and telephone number of the repair shop. Debtor shall pay all maintenance and repair bills when due. Debtor shall take possession of the property as soon as the maintenance and repair work is completed.

M. Plan and Confirmation. Debtor shall file a Chapter 11 Plan within 150 days from the Petition Date. Debtor shall obtain confirmation of its Plan within 90 days after it is filed; provided, however, the Court may enlarge these times for cause shown by Debtor on a motion filed and heard before the expiration of the applicable time period.

N. Relief from the Automatic Stay. If Debtor violates any provision of this Agreed Order or fails to perform any obligation under this Agreed Order then Austin Bank may give the Debtor notice of the default. If the default is not cured within ten days from the date the notice is sent by Austin Bank then the automatic stay shall terminate against the Austin Bank Collateral.

If Debtor violates any provision in this Agreed Order or fails to perform any obligation under this Agreed Order then Community Bank may give the Debtor notice of the default. If the default is not cured within ten days from the date the notice is sent by Community Bank then the automatic stay shall terminate against the Community Bank Collateral.

O. This Order shall be deemed binding and in full force and effect in this bankruptcy case or any subsequent bankruptcy case until the later of 180 days after the stay terminates or Austin Bank and Community Bank exercise their rights and remedies under the loan documents and applicable law against their respective collateral.

P. This Order is without prejudice to the rights of Austin Bank and Community Bank, including but not limited to their right to dispute at any time Debtor's use of the Cash Collateral, seek relief from the stay or dismissal of this Case, and contest the nature, extent, validity or priority of any lien or security interest, and entry of this Order is not to be interpreted as a final finding as to adequate protection or an agreement by Austin Bank or Community Bank to support or accept the filing of Debtor's bankruptcy petition, any plan of reorganization or disposal of assets under Section 363 of the Bankruptcy Code, or any other proposed treatment of their claims.

Q. This Order is not intended and shall not be deemed to be consent by Austin Bank or Community Bank to any surcharges, excises, liens or charges of any nature or type pursuant to §§364, 506(c) and 510 of the Bankruptcy Code in this Chapter 11 proceeding or in any subsequent Chapter 7 proceeding, including, without limitation, expenses of administration or liquidation. Further, Austin Bank and Community Bank expressly do not consent to any surcharges, excises, liens or charges of any nature or type.

R. Notwithstanding anything to the contrary within Bankruptcy Rule 4001(b)(2) or any other rule of similar import, this Order shall be effective immediately upon its entry.

Based upon the pleadings and the agreement of the parties as set forth herein, the Court finds good cause to enter the following ORDER:

IT IS THEREFORE ORDERED that the relief requested in the Motion is GRANTED IN PART so as to authorize the use of Cash Collateral for the period from November 4, 2016 through 11:59 p.m. on December 31, 2016, or as otherwise extended by agreement of the parties filed with the Court or by Order of the Court, subject to the conditions and obligations set forth in this Agreed Order.

IT IS FURTHER ORDERED that the Debtor, Austin Bank and Community Bank are authorized to extend the cash collateral authorization granted herein by agreement for additional periods of time under the same terms and conditions set forth herein without the necessity of a court hearing by filing a “Notice of Extension of Cash Collateral Authorization Until _____” with the Court, with notice to all appropriate parties pursuant to the Federal and Local Rules of Bankruptcy Procedure. Any substantive change in the terms and conditions that potentially prejudices the interests of another party will require a further hearing, which will be granted by the Court upon the filing of a Request for Hearing with the Court.
