**CRAPP FARMS PARTNERSHIP'S MOTION:  
(1) FOR REJECTION OF UNEXPIRED LEASE; (2) FOR AUTHORIZATION TO SELL  
FARM EQUIPMENT, VEHICLES AND MACHINERY BY AUCTION; AND  
(3) FOR AUTHORIZATION TO COMPENSATE AUCTIONEER**

---

Crapp Farms Partnership, the debtor herein (the "Debtor"), by its attorneys, Krekeler Strother, S.C., files this motion (the "Motion") for entry of an order, (1) for rejection of an unexpired lease between the Debtor and BMO Harris Equipment Finance pursuant to Section 365 of the United States Bankruptcy Code, 11 U.S.C. §§ 101-1330, (the "Bankruptcy Code"); (2) pursuant to Section 363 of the United States Bankruptcy Code, for entry of an order permitting the Debtor to sell its farm real estate by a live auction sale to be conducted on April 3, 2018; and (3) for entry of an order authorizing compensation to the auctioneer. In support of this Motion, the Debtor respectfully represents as follows:

**JURISDICTION AND VENUE**

1. This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2). Venue of the Debtor's Chapter 11 case and this Application in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409. The relief requested herein is pursuant to Section 363 of the Bankruptcy Code.

**BACKGROUND**

2. On May 3, 2017 (the “Petition Date”), the Debtor commenced this case under Chapter 11 of Title 11 of the United States Code (the “Bankruptcy Code”).

3. The Debtor is continuing to operate its business as a debtor-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

4. The Committee of Unsecured Creditors in this case was appointed on June 5, 2017.

5. The Debtor wishes to conduct the sale of farm personal property consisting of equipment, machinery and vehicles formerly used in its farming operations using Steffes Group, Inc. (“Steffes”) as auctioneer, pursuant to the proposed Auction Sale Agreement (the “Equipment Auction Agreement”) between the Debtor and Steffes. A true and correct copy of the Equipment Auction Agreement is attached hereto and incorporated herein by reference as **Exhibit A**.

6. BMO Harris, N.A., (“BMO”), the Debtor’s pre-petition secured lender, obtained proposals from Steffes to conduct the Equipment Auction, and recommended that Debtor hire Steffes to conduct the proposed auction sale according to the terms and conditions set forth in the Equipment Auction Agreement.

7. The Debtor also intends to sell certain equipment at the Equipment Auction which is subject to an unexpired lease between the Debtor and BMO Equipment Finance. Therefore, the Debtor is also seeking entry of an order rejecting the lease so that the equipment may be included in the Equipment Auction.

8. Contemporaneous with the filing of this Motion, the Debtor filed the Amended Application of Crapp Farms Partnership to Employ Steffes Group as Auctioneer (the “Steffes Application”).

**RELIEF REQUESTED**

**Rejection of Unexpired Lease Between the Debtor and BMO Equipment Finance**

9. The Debtor and BMO Harris Equipment Finance are parties to a Master Lease of Personal Property dated June 18, 2013 (the “Master Lease”), and the Lease Schedule dated June 18, 2013 made a part of the Master Lease (the “Lease Schedule”).

10. The equipment leased by the Debtor are identified on Schedule A of the Lease Schedule and are more commonly known as three John Deere planters. A true and correct copy of the Lease Schedule is attached hereto and incorporated herein as **Exhibit B**.

11. The Master Lease is an executory contract which was in full force and effect on the Petition Date. Pursuant to Section 365(d)(1) of the Bankruptcy Code, the Debtor may reject an unexpired lease of personal property of the Debtor before the confirmation of a plan. As of the filing of this Motion, no order has been signed or entered by this Court confirming a plan in this Chapter 11 case.

12. The Debtor desires to reject the Master Lease immediately because the Debtor will not be continuing its farming operations, and so that the equipment subject to the Master Lease may be included in the Equipment Auction discussed in further detail below.

13. Rejection of the Master Lease is in the best interests of the Debtor, its creditors, and the estate.

**Sale of farm personal property via live auction**

14. By this Motion, the Debtor then seeks entry of an Order authorizing the Debtor to sell its farm personal property consisting of equipment, vehicles and machinery (collectively, the “Equipment”) by a live auction sale conducted by Steffes on April 3, 2018 (the “Equipment

Auction”), free and clear of liens, claims and encumbrances, with the same to attach to the proceeds of the sale.

15. A preliminary list of the Equipment to be sold at the Equipment Auction is attached hereto and incorporated herein as **Exhibit C** (the “Preliminary Equipment List”). The list is preliminary at this time as the Debtor is being allowed the opportunity to seek direct third party buyers for several equipment items which are itemized in the list attached hereto and incorporated herein as **Exhibit D** (the “Retained Equipment List”). The items of equipment listed in the Lease Schedule shall also be incorporated and made a part of the Preliminary Equipment List.

16. If the Debtor is unable to obtain buyers for any of the items identified in the Retained Equipment List by February 28, 2018, the Debtor agrees that any unsold item(s) shall be included and sold at the Equipment Auction.

17. In the event any unsold item(s) from the Retained Equipment List are included in the Equipment Auction, the Debtor shall file a supplemental affidavit to this Motion identifying any such unsold item(s).

18. The Debtor acknowledges that the direct sale of any equipment from the Debtor to a third party buyer must be approved by this Court after the filing of a properly noticed motion requesting entry of an order approving any such sale.

19. Because a majority of the Equipment is equipment used in cropping operations, the Debtor believes that conducting the Equipment Auction prior to the beginning of the 2018 planting season will yield great interest and competitive bidding as farmers look to upgrade or replace their farming equipment.

20. The Debtor anticipates that in conjunction with the filing of this Motion, the Debtor will also be filing an appropriate motion to have this Motion heard on an expedited basis. Additionally, the Debtor also requests that the 14-day stay pursuant to Rule 6004(h) be waived.

21. Upon information and belief, all the Equipment on the Preliminary Equipment List is subject to validly-perfected first-position security interests in favor of BMO, securing, among other obligations to BMO, notes with an outstanding principal balance of \$29,067,310.42 as of the Petition Date.

22. By virtue of BMO's properly perfected security interest in the Equipment, BMO shall be entitled to all net proceeds from the Equipment Auction, after compensation to Steffes, to be applied to reduce the current indebtedness owed by the Debtor to BMO.

**Compensation to Steffes**

23. The following is a brief summary of the services and efforts the Debtor anticipates that Steffes will undertake in connection with the Equipment Auction:

- a) Handle all aspects of marketing for the anticipated auction;
- b) Handle bidder registration, data entry and customer check out, and manage the on-line auction to answer all questions;
- c) Prepare the site for auction, including organizing, cleaning, and repairing the Equipment to be included in the sale; handle checkout of items; and assist in the removal of items won at the conclusion of the auction sale; and
- d) Any other related services deemed necessary by the parties for an efficient and successful on-line auction sale.

24. Steffes' requested compensation for services to be rendered to the Debtor are fully set forth in the Equipment Auction Agreement and specifically as follows:

- a) Steffes shall charge a total commission of 8%, itemized as follows: 5% for Auctioneer's & Clerk's Fee; 1% for Advertising; and 2% for Set-up Fees and Transport; and
- b) Steffes' commission shall be paid out of gross sale proceeds from the Equipment Auction.

25. The Debtor requests that this Court approve payment of the compensation to Steffes and authorize the Debtor to disburse Steffes' fee to Steffes upon conclusion of the Equipment Auction.

26. The Debtor believes that the Equipment Auction will yield the highest and best total value for the Equipment, and that the Equipment Auction is in the best interests of the Debtor, its creditors, and the estate.

**WHEREFORE**, Crapp Farms Partnership respectfully requests that the Court enter an Order (i) granting this Motion, (ii) authorizing the rejection of the Master Lease; (iii) authorizing Crapp Farms Partnership to sell the Equipment via a live auction described herein in the manner and under the terms and conditions set forth in the Equipment Auction Agreement, free and clear of all liens, claims, or encumbrances, with liens to attach to the proceeds of the sale; (iv) approving compensation to the Steffes Group as described herein and authorizing Crapp Farms Partnership to disburse the fee to the Steffes Group upon conclusion of the Equipment Auction; and (iv) granting such other and further relief as is just and proper.
