Mr. Cowan, the former mayor of Royal Oak for 14 years, served as lead attorney for Plunkett Cooney's team of attorneys that represented the state-appointed emergency manager for the City of Pontiac. As part of this assignment, he coordinated numerous restructuring projects, including the first request under Michigan's Public Act 4 for a change in the city's collective bargaining agreement with the police/fire dispatch union under Section 19(k).

While the state's emergency manager law provides an avenue for large and complex restructuring on behalf of troubled municipalities, a restructuring of this size has not been performed by any law firm in the nation's history.

However, Plunkett Cooney has extensive background representing clients in Chapter 11 filings, having participated in all aspects of its proceedings, and is one

of the few firms to actually advise emergency financial managers tasked with turning around the financial position of numerous municipalities.

Furthermore, while no municipality has filed Chapter 9 in the history of the state of Michigan, Mr. Bernstein is a recognized expert on the topic and has been quoted in national publications regarding the matter.

Plunkett Cooney represents numerous private-sector clients in all types and stages of bankruptcy cases, beginning with pre-bankruptcy workout efforts and continuing with the many services required during the bankruptcy process. The firm also has extensive experience with recovery and monitoring activities after bankruptcy cases have closed.

Plunkett Cooney has worked with communities in assisting in the evaluating and restructuring of debt obligations, including bonds and refundings. The firm has worked with existing bond counsel, or joined with special bond counsel, in developing strategies on specific projects. Our attorneys are prepared to work with the City of Detroit and its bond counsel in the best method to achieve the city’s financial objectives.

Plunkett Cooney has extensive experience working with local governmental entities seeking to address significant financial issues and has successfully implemented strategies for shared services, privatization and other restructuring plans to achieve cost savings. The various concepts and strategies for shared services and restructuring include:

- Consolidation of Services
- Outsourcing/Privatization

- Creation of Municipal Authorities

In the past, Plunkett Cooney has served as a consultant to the City of Detroit on alternative methods for providing police and fire services, including the possible consolidation of these services with other communities and/or the creation of an authority.

As previously mentioned, the firm most significant recent restructuring assignments focused on the City of Pontiac. This representation was extensive and involved numerous city departments and operations.

For example, the firm assisted with an asset transfer to the city's library, including the creation of a separate operations and functions structure for the library.

The firm also assisted the City of Pontiac with the sale of its multi-million dollar public water works and waste sewerage system to a private entity, providing the city with a much-needed cash infusion and restructuring personnel by providing them with employment opportunities with the system's new private-sector owner.

Additionally, Plunkett Cooney assisted Pontiac's emergency manager with the sizeable task of partnership with the Oakland County Sheriff's Department to consolidate community policing services (saving the city \$2.8 million annually), including dispatch services (with an annual cost savings of \$100,000).

Further efforts to improve efficiency and cost-effectiveness involved outsourcing the City of Pontiac's Information and Technology Department. Our attorneys also leveraged their experience in dealing with state and federal agencies such as MSHDA and HUD to realize further savings in these important areas of city housing services.

Plunkett Cooney's efforts to save the city money also extended into the area of zoning, planning, permitting and code enforcement with a successful effort to outsource these services to the design firm Wade Trim, Inc.

Beyond the experience gained in working with the City of Pontiac, attorneys from Plunkett Cooney's Governmental Law Group have worked alongside municipal officials for decades to address operational issues. Whether negotiating water rates on behalf of municipalities or crafting shared services agreements between communities, Plunkett Cooney has been at the forefront of proactive efforts to create more financially sustainable communities.

Other recent municipal restructuring efforts involved the following:

- The City of Algonac and the outsourcing of its police services to the St. Clair County Sheriff's Office. Similarly, on behalf of Pontiac, inter-governmental agreements were struck with Waterford Township to provide fire and rescue services and with Oakland County to assume the City's animal control service.
- The City of Flint relied on the firm's expertise by asking our attorneys to review the consolidation of the clerk/treasury department and restructuring alternatives for its grant department, including outsourcing.
- Plunkett Cooney consulted on, and ultimately, oversaw the merger of the City of Northville's fire services with the City of Plymouth.
- The City of Marine City requested Plunkett Cooney to consult with municipal officials on the privatization of its water and waste water treatment plant operations.

Recognizing that significant costs are involved when consolidating government operations, Plunkett Cooney attorneys have worked with municipal officials and representatives from the Michigan Department of Treasury to off-set the costs associated with the mergers. By coordinating the submission of multiple Competitive Grant Assistance Program (CGAP) applications (formerly EVIP Grant), our attorneys have helped these communities receive grant funding to accomplish the restructuring of public services.

- Through the efforts of Plunkett Cooney attorneys, the cities of Inkster, Lincoln Park, Hazel Park and Eastpointe were granted funding through the CGAP to assist in the restructuring of their public safety departments. These efforts will collectively save the cities over \$5.6 million annually.
- The City of Hamtramck received CGAP funding to consolidate its police and fire dispatch services, which saves Hamtramck \$700,000 annually.

- When the City of Highland Park needed to consolidate its police and fire dispatch services, our attorneys submitted the CGAP application that will ultimately save the city \$700,000 annually.
- Grant funding via the CGAP also applies to school districts and the courts. In conjunction with the City of Ecorse and Ecorse Public Schools, Plunkett Cooney attorneys assisted in the city receiving money to consolidate services between the city and the school district to create a single recreation program. This merger will save the entities \$130,000.
- After assisting with the merger of the 25th and 26th District Courts in Lincoln Park and Ecorse, respectively, Plunkett Cooney coordinated the CGAP submission to allow the courts to combine particular technical products and services to increase efficiencies. As a result, the courts save \$710,000 annually.

As one of the Midwest's leading law firms serving the public sector, Plunkett Cooney has extensive experience representing municipalities directly or through their insurance carriers in the areas of labor and employment relations, including union contract negotiations. This work also includes assisting emergency managers with the difficult task of setting municipalities on more sustainable financial courses.

For example, inherent in many of the City of Pontiac's necessary structural changes were behind-the-scenes negotiations with the city's unions. During the course of Plunkett Cooney's involvement with the city, our attorneys engaged in labor contract negotiations with eight separate bargaining units.

These types of efforts include a myriad of legal issues, including terms and conditions of employment, concessions, modifications to healthcare coverage, retirement plans, the dissolution of bargaining units, subcontracting and privatization, civil service counsel and advice, layoffs and new collective bargaining agreements.

Plunkett Cooney's labor and employment attorneys negotiated public sector contracts with public safety officers, command staff, department of public works employees, food services workers, library staff members and many other employee groups to arrive at reasonable agreements. Many of these contracts are multi-year agreements that successfully obtained near-term concessions and future employee considerations that protect the employer's long-term fiscal viability.

The firm's legal services extended beyond collective bargaining to include union representational campaigns and elections, unfair labor practice disputes, grievance proceedings, strikes, arbitrations, and wage and hour matters.

Plunkett Cooney also provides its clients with comprehensive employment law services, including litigation and human resources consulting. Our attorneys have had the privilege of assisting numerous municipalities, including the City of Detroit, with human resources matters and have successfully defended employment actions brought against them in state and federal court.

Our attorneys understand the intricacies of state and federal employment law, including compliance with the Americans with Disabilities Act (ADA), Family and Medical Leave Act (FMLA) and workplace health and safety regulations. They assist clients with maintaining appropriate workforce staffing levels and have extensive experience with issues related to the Employee Retirement Income Security Act (ERISA), Consolidated Omnibus Budget Reconciliation Act (COBRA), Fair Credit Reporting Act (FCRA) and Health Insurance Portability and Accountability (HIPAA), among many others.

As with any municipality, there remain day-to-day issues that need to be addressed. Our municipal attorneys are routinely called upon to issue legal opinions regarding the Open Meetings Act, and they frequently serve as Freedom of Information Act officers for their client communities. When Open Meetings Act and FOIA issues progress to litigation, our attorneys appear in court on behalf of their clients to advocate their positions and to protect their interests.

Through its efforts on behalf of the City of Pontiac and numerous other non-distressed municipal clients, Plunkett Cooney provides depth of expertise and personnel in these areas of practice that allows the firm to quickly and cost-effectively assist Michigan communities.

With respect to healthcare benefits, Plunkett Cooney attorneys negotiated an advantageous healthcare benefits contract for active employees and retirees at the direction of the emergency manager. Through this process, our attorneys helped save the City of Pontiac approximately \$1 million by developing third-party employee and retiree healthcare insurance audit protocols. Additional contract negotiations involving the healthcare benefits of active employees and retirees resulted in significant cost savings and structural changes in coverage.

Pursuant to then Public Act 4, and at the direction of the city's emergency manager, our attorneys also worked to restructure the salary and benefits of Pontiac's elected officials.

In addition to these key areas of expertise, the firm provides emergency managers with expertise in the areas of environmental law, public entity asset sales and the various other state laws governing home rule, transfers of power and inter-governmental agreements as outlined in the solicitation.

Plunkett Cooney's municipal practice also includes environmental regulatory and litigation services. Our attorneys work with municipalities to resolve water way, hazardous materials, ground contamination and clean air issues. A key aspect of the firm's environmental practice involves Brownfield redevelopment.

When environmental regulatory issues and litigation arise, our attorneys represent their clients before state and federal boards and in court. These often complex, protracted and expensive disputes require technical expertise, access to qualified experts who can provide supporting testimony and familiarity with sometimes intertwining aspects of state and federal law to mitigate exposure.

Plunkett Cooney's attorneys also have experience dealing with inter-local public agency agreements, and in particular, the Urban Cooperative Act of 1967 (PA 7) and Act 425 agreements.

Regarding PA 7, Plunkett Cooney has advised clients on the standards for filing these types of agreements and on allocating certain taxes or payments in lieu of taxes received from Tax Increment Financing (TIF) districts to be re-invested in designated properties/developments.

Our attorneys have been involved in development agreements between municipalities for a variety of purposes, including Act 425 agreements for water and sewer services. In one particular case, Plunkett Cooney helped resolve a nearly 18-year dispute between a township and a city by drafting a mutually beneficial Act 425 agreement.

Stevenson Keppelman Associates has advised many Michigan municipalities and other government employers on the establishment, maintenance and ongoing legal compliance of retirement plans. The firm has extensive experience with the complex tax and Michigan state law requirements that apply to Michigan municipalities. In fact, their attorneys are frequently requested to write and present on the subject.

Stevenson Keppelman Associates have worked on public retirement cases since the 1970s. Regarding the operation of Michigan retirement systems, the firm has handled almost every aspect of Michigan public pensions and employee benefits, including:

6. Demonstration of no conflicts and/or discussion of required releases

The City of Detroit is a current client of Plunkett Cooney, and as such, we are not aware of any conflicts which would prevent us from providing restructuring legal counsel.

Stevenson Keppelman Associates has no known conflicts to undertake this representation. Their firm does represent Blue Cross Blue Shield of Michigan with respect to its own retirement plans (and not with respect to the provision of services by BCBSM to its clients). They have obtained conflict waivers to negotiate administrative services agreements on behalf of other clients with BCBSM.

7. Proposed fee structure

We understand that controlling legal costs is a major challenge and goal for many of our clients. It is our goal at Plunkett Cooney to be your partner, not only by providing outstanding legal counsel, but by working with you to control legal costs.

The firm utilizes ABA Uniform Task Based Billing codes for all time entry, and our attorneys provide their clients with detailed descriptions of billable activities each month. The firm's standard billing unit is based upon 0.1 hour increments, and the standard billing cycle is 30 days.

We are comfortable providing time estimates and budgets for specific assignments, when possible. Our attorneys are happy to discuss with city officials the scope of services necessary to address specific legal issues.
