

SCHEDULE 10.2(a)

Pre-Petition Executory Contracts and Unexpired Leases to be Assumed Pursuant to the Plan

This Schedule 10.2(a) lists certain executory contracts and unexpired leases entered into prior to the Petition Date¹ that are not scheduled to expire or terminate prior to the Confirmation Date and that the Debtors presently intend to assume pursuant to the Plan as of the relevant Assumption Effective Date.

Notes:

1. Assumption Parties with respect to agreements listed individually on this Schedule 10.2(a) will receive notice of such proposed treatment, along with a Proposed Cure amount for pre-petition debt (which may be zero dollars). Debtors intend to pay post-petition amounts in the ordinary course of business, and acceptance of the Proposed Cure amount for pre-petition debt will not affect the Assumption Party's rights with respect to post-petition debt.
2. Except as otherwise indicated hereon, the Assumption Effective Date shall be the Effective Date.
3. The listing of any contract or lease on this Schedule is not an admission that such contract or lease is an executory contract or unexpired lease.
4. The Debtors reserve the right to amend this Schedule (and the amount of any Proposed Cure) as permitted by the Plan.
5. Each executory contract and unexpired lease assumed pursuant to the Plan includes all modifications, amendments, addenda, exhibits and supplements that affect such contract or lease; *provided, however*, that master terms and conditions agreements are treated as separate contracts from the annexes, statements of work, schedules and other ordering documents that identify particular goods or services to be supplied and the prices for such goods or services, and the listing of a master terms and conditions agreement on Schedule 10.2(a) does not mean that all related annexes, statements of work, schedules and other ordering documents are also being assumed.
6. If a contract or lease is listed on Schedule 10.2(b) (as rejected), then that designation of the contract or lease shall control over any listing of the contract on Schedule 10.2(a) or the inclusion of such contract in one of the categories below, and the contract shall be considered rejected.
7. Certain Indemnification Obligations are addressed in Section 10.3(b) of the Plan and thus are not included on this Schedule.
8. Collective Bargaining Agreements are addressed in Section 10.3(c) of the Plan and thus are not included on this Schedule.

¹ All capitalized terms used herein and not otherwise defined shall have the meanings set forth in the Debtors' Joint Plan of Reorganization, dated as of July 22, 2009 (the "**Plan**"), as the same may be modified, supplemented or amended.

Executory Contracts and Unexpired Leases to be Assumed

Inclusion of any agreement hereon is not an admission by the Debtors that such agreement is an executory contract or unexpired lease. Subject to the terms of Article 10 of the Plan, the Debtors reserve all rights, claims and defenses under all relevant agreements and applicable law on all issues including, but not limited to, whether or not such agreements are executory contracts or unexpired leases.

The Assumption Effective Date for each agreement listed hereon shall be the Plan Effective Date unless otherwise noted hereon.

The Debtors reserve the right, subject to the terms of the Plan, to supplement and amend this Schedule, including in order to add, remove and/or change the treatment of agreements.
