**ORDER AUTHORIZING SALE OF CERTAIN INVENTORY (J. C. PENNEY)  
FREE AND CLEAR OF ALL LIENS, CLAIMS, INTERESTS, AND  
ENCUMBRANCES AND GRANTING RELATED RELIEF**

The Trustee Richard Levin has filed a motion (the “**Motion**”) for an order authorizing him to sell the interest of Firestar Diamond, Inc. (“**Firestar**”) in certain consignment inventory, described in Bill of Sale attached as Exhibit A to the Motion, free and clear of all liens, claims, interests, and encumbrances under section 363 of the Bankruptcy Code; and the Court finding that: (i) the purchaser J. C. Penney Company, Inc. (the “**Purchaser**”) is a purchaser in good faith within the meaning of 11 U.S.C. § 363(m); (ii) the Trustee has given appropriate notice of the Motion and the sale under the circumstances and no other or further notice is necessary; and (iii) in light of the absence of any objections or other responses to the Motion and the notice given by the Trustee, any party with a lien, claim, encumbrance, or other interest in or against the Penney Memo Inventory has consented to the sale free and clear within the meaning of 11 U.S.C. § 363(f)(2),

IT IS ORDERED:

1. The Trustee is authorized under 11 U.S.C. § 363(b) and (f) and Fed. R. Bankr. P. 6004 to sell Firestar’s interest in the inventory listed on the Schedule attached to the Bill of Sale

attached as Exhibit A to this Order to the Purchaser for \$1,000,000, subject to adjustment as provided in the Bill of Sale, in cash (the "Purchase Price") under the Bill of Sale.

2. The sale of the inventory to the Purchaser shall be free and clear of all liens, claims, encumbrances, or other interests, with any such interests to attach to the proceeds of the sale.

3. The Purchaser is deemed to have purchased the inventory in good faith, as that term is used in section 363(m) of the Bankruptcy Code, and no reversal or modification of this Order on appeal will affect the validity of the Bill of Sale or the transactions contemplated thereby.

4. The Bill of Sale and the transactions contemplated thereby may not be avoided under section 363(n) of the Bankruptcy Code.

5. Under Fed. R. Bankr. P. 6004(h), this Order shall not be stayed for fourteen days after entry, but shall be effective and enforceable immediately.

6. This Court shall retain exclusive jurisdiction to enforce the provisions of this Order. To the extent any provisions of this Order are inconsistent with the Motion, the terms of this Order shall control.

**EXHIBIT A**  
**(Bill of Sale)**

## BILL OF SALE

**THIS BILL OF SALE** is executed and delivered as of \_\_\_\_\_, 2018, by **RICHARD LEVIN, NOT INDIVIDUALLY BUT SOLELY IN HIS CAPACITY AS CHAPTER 11 TRUSTEE (“Seller”) OF FIRESTAR DIAMOND, INC.**, a Delaware corporation (“**Debtor**”) and **J.C. PENNEY COMPANY, INC.**, (“**Buyer**”) (each a “**Party**”). Seller and Buyer agree:

1. Transfer of Transferred Assets. Effective as of the date hereof, for the consideration set forth in Section 3 of this Bill of Sale, Seller sells, assigns, transfers, and delivers to Buyer all of Seller’s right, title and interest in, to, and under the inventory listed on the attached Schedule (the “**Transferred Assets**”), in each case free and clear of all liens, claims, and encumbrances.

2. Title to Assets. Whenever and as often as reasonably requested to do so by Buyer, Seller agrees to acknowledge, execute, and deliver such other instruments of transfer and take such other action as may be required more effectively to transfer to, and vest in, Buyer all of Seller’s right, title, and interest in, to, and under the Transferred Assets.

3. Purchase Price. In consideration of the transaction contemplated hereby (the “**Transaction**”), Buyer shall, subject to the terms and conditions of this Bill of Sale, pay Seller an aggregate amount of \$1,000,000.00, as adjusted below (the “**Purchase Price**”).

All of the Transferred Assets have been on consignment from Seller to Buyer. If and to the extent that Buyer sells any of the Transferred Assets from July 12, 2018 until the closing of this sale and has paid Seller the regular consignment purchase price for the sold items before the closing of this sale, the Purchase Price shall be decreased by the amount actually paid.

4. “AS IS” Transaction. Buyer acknowledges and agrees that Seller makes no representations or warranties whatsoever, statutory, express, or implied, with respect to any matter relating to Debtor’s diamond and jewelry businesses (the “**Business**”) or with respect to the Transferred Assets, including income to be derived or expenses to be incurred in connection with the Business or the Transferred Assets, the physical condition of any personal property comprising any part of the Transferred Assets, the value or transferability of the Transferred Assets (or any portion thereof), or the merchantability or fitness for any particular purpose as to any portion of the Transferred Assets. Buyer acknowledges that Buyer has had an opportunity to conduct an independent inspection and investigation of the physical condition of the Transferred Assets. Accordingly, Buyer accepts the Transferred Assets at the closing date “AS IS,” “WHERE IS,” and “WITH ALL FAULTS,” subject to the provisions of this Bill of Sale providing that the sale of the Transferred Assets is free and clear of all liens, claims, and encumbrances.

5. Binding Effect. This Bill of Sale shall be binding upon, and inure to the benefit of, Seller’s and Buyer’s respective successors and assigns.

6. Counterparts. This Bill of Sale may be executed in several counterparts (including by fax or PDF via email), each of which when so executed will be deemed to be an original and all of which will together constitute one and the same agreement.

7. Governing Law; Venue. This Bill of Sale is and shall be deemed to be a contract entered into and made under the laws of the State of New York and shall in all respects be governed,


construed, applied and enforced in accordance with the laws of said State, without reference to its conflict of laws principles. Any action, claim, suit, or proceeding arising out of, based upon or relating to this Bill of Sale or the Transaction (an “**Action**”) shall be brought solely in the United States Bankruptcy Court for the Southern District of New York (the “**Bankruptcy Court**”). Each Party agrees that it will not bring any Action in any other court; but if the Bankruptcy Court does not have jurisdiction, any Action shall be heard and determined solely in the appropriate courts located in the County of New York. **Each Party irrevocably waives to the fullest extent permitted by applicable law any and all right such Party may have to trial by jury in any Action.**

8. Seller Capacity as Trustee of the Debtor; Limitation on Liability. Buyer acknowledges that Seller is the Chapter 11 trustee of the Debtor and that Seller enters into this Bill of Sale solely in his capacity as Chapter 11 trustee of the Debtor and not in his personal capacity, and no liability or obligations accrue to him personally as a result of this Bill of Sale. Buyer acknowledges and understands that (i) case no. 18-10509-SHL was filed as a voluntary case and that the Seller has very limited information regarding the Debtor and its assets, and the sale of the Transferred Assets is “as is” “where is” as set forth in Section 4 of this Bill of Sale and (ii) any claim that it may assert under this Bill of Sale or under the Transaction will be made solely against the Debtor’s bankruptcy estate.
