**THIRD INTERIM ORDER ON FUNKYTOWNMALL.COM, INC.'S EMERGENCY
MOTION FOR ORDER AUTHORIZING USE OF CASH COLLATERAL**

THIS MATTER came before the Court on January 31, 2018, at 1:30 p.m., pursuant to Bankruptcy Rule 4001 and 11 U.S.C. § 363, and the Second Interim Order [ECF 32] granting the *Emergency Motion for Order Authorizing Use of Cash Collateral* [ECF 8] (the “Motion”), filed by debtor-in-possession, Funkytownmall.com, Inc. (the “Debtor”), seeking entry of an interim order authorizing use of cash collateral as defined in Section 363(a), granting adequate protection and related relief. The Court, having reviewed the Motion and heard argument of counsel, after notice and hearing, noting that no objections have been filed, finding good and sufficient cause

having been shown, and otherwise being fully advised in the premises, it is accordingly:

ORDERED that:

1. The hearing on the relief requested in the Motion (the "Hearing") shall be and is hereby continued until **April 4, 2018 at 1:30 PM** (prevailing Eastern Time), at the Flagler Waterview Building, 1515 N. Flagler Dr., Room 801, Courtroom B, West Palm Beach, FL 33401.
2. The Debtor is authorized to use Cash Collateral¹ for the line items detailed in the Budget attached to this Order as Exhibit "A" up through and including the date of the Hearing. The Debtor shall not exceed the budgeted line item amounts by more than five percent (5%).
3. Pursuant to this Court's Guidelines for Motions Seeking Authority to Use Cash Collateral and Motion Seeking Approval of Postpetition Financing, any adequate protection provided to creditors are subject and subordinate to fees due to the clerk of the court or the United States Trustee pursuant to 28 U.S.C. §1930.
4. To adequately protect Chase and/or any other potentially secured creditors in connection with the use by the Debtor of any Cash Collateral and other property upon which security interests and liens may have been previously granted by the Debtor to Chase and/or any other putative secured creditors, the Court hereby confirms the grant, assignment and pledge by the Debtor to any such secured creditors a post-petition security interest and lien (only to the same validity, extent, and priority of such pre-petition security interests, if any exist) in the secured creditor's Pre-Petition Collateral, any of its goods, property, assets and interests in property in which the secured creditors may have held a lien or security interest prior to the Petition Date, and the proceeds from the disposition of any of such Prepetition Collateral.
5. Nothing in this Order shall be construed as an improvement of the security or

security interests of Chase and/or any other putative secured creditors as of the Petition Date. The replacement lien shall not apply to any funds recovered by the estate pursuant to avoidance actions arising under Sections 542 through 550 of the Bankruptcy Code.

6. If no objections are timely filed and served, the Court may enter a Final Order granting the Motion without further notice or hearing.
