### GLOBAL NOTES PERTAINING TO DEBTOR'S SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENT OF FINANCIAL AFFAIRS

The Groves in Lincoln, Inc. (the "Debtor" or "Groves"), the debtor-in-possession in the above-captioned case, respectfully represents as follows.

With the assistance of its professionals and advisors, the Debtor's management prepared these Schedules of Assets and Liabilities and Statement of Financial Affairs pursuant to 11 U.S.C. § 521 and Fed. R. Bankr. P. 1007 (collectively, the "Schedules and SOFA"). The Schedules and SOFA are unaudited. While the Debtor has made every effort to ensure that the Schedules and SOFA are accurate and complete based on information available at the time of preparation, the subsequent receipt or discovery of information may result in material changes in financial data contained in the Schedules and Statements.

These global notes comprise an integral part of the Schedules and SOFA and should be referenced in connection with any review of the Schedules and SOFA. Nothing contained in the Schedules and SOFA shall constitute, or be deemed, a waiver of any rights, claims or defenses of the Debtor against any third party or with respect to this Chapter 11 case or any related litigation or arbitration. Nothing contained in the Schedules or SOFA is intended or should be construed as an admission or stipulation of the validity of any claim against the Debtor or a waiver of the Debtor's rights to dispute any claim or assert any cause of action or defense against any party. The Debtor reserves all rights to dispute or challenge the characterization of the structure of any transaction or any document or instrument related to a creditor's claim.

The Apartments at The Groves. As described in the Debtors' Motion for Authority to Continue to Honor Certain Obligations to Residents in the Ordinary Course [Doc. No. 11], and authorized by an Order entered March 13, 2013 [Doc. No. 43], in the ordinary course of business, prior to the petition date, the Debtor and its affiliate, The Apartments at The Groves, Inc. ("Apartments"), the debtor in Chapter 11 Case No. 13-11330-HJB, which is being jointly administered with this case, utilized a centralized cash management system, whereby all financial activity of Apartments has been and continues to be accounted for in Groves's books and records. Accordingly, all financial activity of Apartments has been listed in the Schedules and SOFA of Groves.

Schedule E. As of the Petition Date, certain employees were owed (i) prepetition wages, salaries, and other compensation, and (ii) accrued and unused paid time off earned prior to the petition date. Pursuant to the Court's Order Authorizing Payment of Certain Prepetition Wages, Taxes and Benefits By Debtors-in-Possession [Doc. No. 44], entered March 13, 2012, the Debtor paid certain prepetition wages, salaries, and other compensation, and filed a list of the employees and the amounts paid under seal on March 20, 2013.

The Debtor has deemed it necessary and appropriate to redact from the public record the names and addresses of each employee on Schedule E, due to privacy concerns. The Debtor has listed the aggregate total amount of claims for priority wages and prepetition paid time off and will file a separate list with each employee's name, address and claim amount with the Court under seal pursuant to MLBR 9018-1.

Schedule G—Executory Contracts. The Debtor has attempted to provide a complete list of all agreements in Schedule G that might be considered executory contracts. The inclusion on Schedule G of any particular agreement or contract does not constitute an admission that (i) such agreement or contract is an executory contract under the Bankruptcy Code; (ii) such agreement or contract is valid and enforceable; (iii) such agreement or contract was in effect on the petition date or (iv) such agreement or contract is severable or unified.

The Debtor reserves all rights with respect to such agreements or contracts, including, without limitation, the right to seek or contest any characterization of any such agreements or contracts on any available basis. The Debtor will supplement Schedule G if it identifies additional agreements that may constitute executory contracts. Omission of an agreement or contract from Schedule G does not constitute an admission that such omitted agreement or contract is not an executory contract. The Debtor's rights under the Bankruptcy Code with respect to any omitted agreements or contracts are not impaired by the omission. Schedule G is not an admission or recognition that any contractual relationship constitutes an "Executory Contract."

- <u>SOFA 3c</u>. The payments listed on the attached schedule with respect to Question 3(c) were made to reimburse certain of the Debtor's affiliates for the payment of operating expenses related to the Debtor's business made by those affiliates on the Debtor's behalf.
- <u>SOFA 14</u>. Pursuant to M.G.L. ch. 186, § 15B(3)(a), and in accordance with the cash management system described above, Groves maintains a separate interest-bearing bank account for the benefit of the tenants of Apartments.

The Debtor specifically reserves the right to amend, modify, supplement, change, or alter any part of its Schedules and SOFA as and to the extent necessary and as it deems appropriate.
