Bidding Procedures

BIDDING PROCEDURES

A. Bid Deadline

1. Goody's, LLC and certain of its affiliates (collectively, the "Debtors"), seek to solicit bids for the sale of the Debtors' intellectual property and intangible assets identified in Exhibit A (the "Intellectual Property").

2. If the Debtors receive more than one offer for Intellectual Property, an auction (the "Auction") shall be conducted as set forth below. In order to bid at the Auction, a bidder (the "Bidder" and collectively, the "Bidders") must submit a written bid in the form of the Required Bid Documents (as defined below) for any of the Intellectual Property no later than May 27, 2009 at 3:00 PM (ET) (the "Bid Deadline"). The original Required Bid Documents must be submitted to: (i) counsel for the Debtor, Young Conaway Stargatt & Taylor, LLP, 1000 West Street, 17th Floor, Wilmington, Delaware 19801, Attn: M. Peek; (iii) counsel to the Official Committee of Unsecured Creditors, Cooley Godward Kronish, LLP, 1114 Avenue of the Americas, New York, New York 10036, Attn: Cathy Hershcopf, Esq. and Jeffrey L. Cohen, Esq. and Benesch, Friedlander, Coplan & Aronoff LLP, 222 Delaware Avenue, Suite 801, Wilmington, Delaware 19801, Attn: Bradford J. Sandler, Esq.; (iv) counsel to the Prepetition Tranche C Agents, Schulte Roth & Zabel LLP, 919 Third Avenue, New York, NY 10022, Attn: Lawrence V. Gelber, Esq., and Landis Rath & Cobb LLP, 919 Market Street, Suite 1800, Wilmington, Delaware 19801, Attn: Adam G. Landis, Esq.; (v) Office of the United States Trustee; 844 N. King Street, Room 2311, Lock Box 35, Wilmington, Delaware 19801, Attn.: Joseph J. McMahon, Esq.; and (vi) Streambank LLC, 400 Hillside Avenue, Suite 19, Needham Heights, MA 02494, Attn: Gabriel Fried.

3. Each Bidder shall be deemed to acknowledge: (a) that it had an opportunity to review all other pertinent documents with respect to the Intellectual Property prior to making its

offer and that each such Bidder relied solely on that review and upon its own investigation of the Intellectual Property in making its offer and (b) that Bidder is not relying upon any written or oral statements, representations, or warranties of the Debtors, their agents, or their representatives.

B. Reservation of Rights

4. The Debtors may, after consultation with the Committee and the Prentice Entities, withdraw from sale any of the Intellectual Property prior to or during the Auction. The Debtors reserve the right, after consultation with the Committee and the Prentice Entities, to reject any and all bids for Intellectual Property.

C. Required Bid Documents

5. All bids must include the following documents (the "Required Bid Documents"):

a. a written offer, on Bidder's corporate letterhead, or, if on behalf of Bidder by Bidder's legal counsel, then on Bidder's legal counsel's letterhead, for the purchase of Intellectual Property. Such written offer for Intellectual Property must expressly state that the Bidder's offer is irrevocable until the earlier to occur of (i) the Closing (as defined herein) or (ii) forty-five days following the Auction (unless such bid is sooner expressly rejected in writing by the Debtors);

b. a certified check for the Deposit (as defined herein).

6. All bids shall remain open and irrevocable until the earlier to occur of: (i) the Closing (as defined herein) or (ii) forty-five days following the completion of the Auction.

D. Qualified Bids

7. Unless such requirement is waived by the Debtors, in consultation with the Committee and the Prentice Entities, only Bidders that have submitted qualified bids ("Qualified Bids") shall be eligible to participate in the Auction. In order to be a Qualified Bid, a bid shall:

- a. include each of the Required Bid Documents;
- b. be an offer to purchase Intellectual Property for cash only;
- c. not be contingent on obtaining financing; and
- d. be received by the Bid Deadline.

E. Deposit Requirement

8. Each Bidder shall tender a deposit in the amount of twenty percent (20%) of such Bidder's initial purchase price (the "Deposit"). The Deposit shall be by cashier's check payable to "Goody's, LLC Debtor-in-Possession." The Debtors shall hold in escrow (without interest) the Deposit of the first highest and best Bidder and the Deposit of the second highest and best Bidder until the earlier to occur of (i) the Closing, and (ii) forty-five days after the Auction. The Debtors shall return the Deposits of all other Bidders within ten business days of the Auction.

9. In the event the Debtors do not consummate a sale of their interest in the Intellectual Property for any reason (other than the Bidder's failure to consummate the sale), the Debtors' sole obligation and liability shall be to refund the Deposit to the Bidder with respect to such Intellectual Property.

10. No Intellectual Property shall be deemed sold pursuant to the procedures described herein unless (a) the Bankruptcy Court has approved such sale at a hearing (the "Sale Hearing") to consider the approval of the sale of the Intellectual Property and (b) such proposed transaction is in fact consummated.

F. The Auction

11. The Auction shall occur on June 2, 2009 at 11:30 AM (ET), at the offices of Debtors' counsel, Young Conaway Stargatt & Taylor, LLP, 1000 West Street, 17th Floor, Wilmington, Delaware 19801, on the terms and conditions set forth in these Bidding Procedures. Only Qualified Bids will be considered at the Auction. ALL SALES WHETHER AT THE AUCTION OR A PRIVATE SALE, SHALL BE SUBJECT TO APPROVAL OF THE BANKRUPTCY COURT.

12. The terms and procedures governing the Auction are as follows:

- a. In the event the Debtors receive only a single Qualified Bid for Intellectual Property, such Intellectual Property will not be subject to bidding at the Auction, and the Debtors may seek to sell such Intellectual Property at the Sale Hearing, if such Qualified Bid is otherwise acceptable to the Debtors, after consultation with the Committee and the Prentice Entities. In the event the Debtors receive multiple

Qualified Bids for Intellectual Property, such Intellectual Property, unless previously sold, otherwise disposed of, or withdrawn, will be offered for sale at the Auction, either in bulk or separately.

b. A minimum Qualified Bid amount for Intellectual Property may be announced and/or posted prior to the Auction. Such minimum Qualified Bid amounts may be established based upon a variety of factors, including: the highest bids received prior to the Auction. All bidding shall be in increments determined by the Debtors, after consultation with the Committee and the Prentice Entities.

c. The Debtors intend to sell their interest to the Bidder making the highest or otherwise best Qualified Bid at the Auction for the Intellectual Property. Formal acceptance of a bid will not occur unless and until the Court enters an order approving and authorizing the Debtors to consummate the sale of Intellectual Property to such Bidder or its designated assignee.

d. At the conclusion of the Auction, the Debtors, after consultation with the Committee and the Prentice Entities, will announce for which bid is the highest or otherwise best bid (the "Successful Bidder") and which bid is the second highest and/or best bid. The Successful Bidder shall supplement its Deposit within one business day so that, to the extent necessary, such Deposit equals fifteen percent (15%) of the highest and best bid.

e. The Debtors reserve the right, following consultation with the Committee and the Prentice Entities, to (i) determine which Bid, if any, for any or all of the Intellectual Property is the highest or otherwise best Bid and (ii) reject at any time prior to entry of an order of the Bankruptcy Court approving a Bid, any offer which the Debtors, at their sole discretion, deems to be (i) inadequate or insufficient, (ii) not in conformity with the requirements of the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, the Bankruptcy Local Rules, or the terms and conditions of sale set forth herein, or (iii) contrary to the best interests of the Debtors, their estates, and their creditors. The Debtors will have no obligation to accept or submit for Court approval any offer presented at the Auction except such written offers as may have been accepted by the Debtors.

G. The Closing

13. Except as otherwise provided in a written offer that has been accepted by the Debtors, the closing of the sale of Intellectual Property shall take place at the offices of Debtors' counsel within one business day following the entry of an order by the Bankruptcy Court approving the sale (the "Closing"). The Sale Hearing before the Bankruptcy Court to approve the sale of Intellectual Property is scheduled for June 4, 2009 at 11:30 AM (ET). With respect to the

Closing, time of performance by the Successful Bidder is of the essence. Upon failure to consummate a sale of some or all of the Intellectual Property because of a breach or failure on the part of the Successful Bidder(s) with respect to such Intellectual Property, the Debtors shall retain the Deposit as liquidated damages, and the next highest or otherwise best Qualified Bidder, as disclosed at the Sale Hearing with respect to some or all of such Intellectual Property, shall be deemed the Successful Bidder and shall consummate the sale of the Intellectual Property.

14. The balance of the purchase price shall be paid by the Successful Bidder by wire transfer or an endorsed bank or certified check at the Closing.

H. Miscellaneous Terms of Sale

15. Any sale, assignment, or other disposition of Intellectual Property shall be without representations or warranties of any kind, nature, or description by the Debtors, their agents, or representatives. The Intellectual Property shall be transferred "as is."

16. All of the Debtors' rights, title, and interest in and to the Intellectual Property shall be assigned and sold free and clear of all liens, claims, encumbrances, and security interests, which shall attach to the net proceeds received by the Debtors as a result of the sale with the same force and effect that they now have, subject to further order of the Bankruptcy Court.





17. All sales, transfer, and recording taxes, stamp taxes or similar taxes, if any, relating to the sale of Intellectual Property shall be the sole responsibility of the Successful Bidder and shall be paid to the Debtors at the Closing of each transaction.




18. The Debtors, after consultation with the Committee and the Prentice Entities, at or before the Auction, may impose or modify the terms and conditions herein as they determine to be in the best interests of the Debtors, their estates, creditors, and other parties in interest.
