**MOTION OF DEBTORS AND DEBTORS IN  
POSSESSION FOR AN ORDER, PURSUANT TO SECTION 365(d)(4)  
OF THE BANKRUPTCY CODE, EXTENDING THEIR TIME TO ASSUME  
OR REJECT UNEXPIRED LEASES OF NONRESIDENTIAL REAL PROPERTY**

TO THE HONORABLE ROBERT D. DRAIN,  
UNITED STATES BANKRUPTCY JUDGE:

Hostess Brands, Inc. and its five domestic direct and indirect subsidiaries, as debtors and debtors in possession (collectively, "Hostess" or the "Debtors"), respectfully represent as follows:

**Background**

1. On January 11, 2012 (the "Petition Date"), the Debtors commenced their reorganization cases by filing voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"). The Debtors' chapter 11 cases have been consolidated and are being administered jointly for procedural purposes only.

2. The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

3. On January 18, 2012, the United States Trustee for the Southern District of New York (the "U.S. Trustee") appointed an official committee of unsecured creditors, pursuant to section 1102 of the Bankruptcy Code (the "Creditors Committee"). On January 30, 2012, the U.S. Trustee amended the membership of the Creditors Committee.

4. Founded in 1930, Hostess is one of the largest wholesale bakers and distributors of bread and snack cakes in the United States. Today, Hostess sells an array of popular products under new and iconic brands such as Butternut®, Ding Dongs®, Dolly Madison®, Drake's®, Home Pride®, Ho Hos®, Hostess®, Merita®, Nature's Pride®, Twinkies® and Wonder®. The Debtors operate 36 bakeries, 565 distribution centers, approximately 5,500 delivery routes and 570 bakery outlet stores throughout the United States.

### **Jurisdiction**

5. This Court has jurisdiction to consider this matter pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

### **Relief Requested**

6. By this Motion, the Debtors seek an order, pursuant to section 365(d)(4) of the Bankruptcy Code, granting them a 90-day extension of the time to assume or reject the Unexpired Leases (as such term is defined below), through and including August 8, 2012 (or the date on which the Debtors confirm a plan of reorganization if such date is prior to August 8, 2012) without prejudice to the right of the Debtors to seek further extensions upon the consent of the affected lessors.

### **The Unexpired Leases**

7. In connection with the conduct of their businesses, certain of the Debtors are lessees or sublessees under approximately 638 unexpired leases and subleases of nonresidential real property (collectively, the "Unexpired Leases").<sup>2</sup>

8. As of the date of this Motion, the Unexpired Leases remain in effect and have not expired or terminated according to their respective terms.<sup>3</sup> Thus, each of the Unexpired

<sup>2</sup> A nonexclusive schedule of the Unexpired Leases is attached hereto as Exhibit A and incorporated herein by reference. This schedule identifies, for each Unexpired Lease: (a) the location of the underlying property and (b) the name and address of the lessor or sublessor, as applicable, for the property (collectively, the "Lessors"). Listing an agreement on the attached Exhibit A is not an acknowledgment by the Debtors that such agreement is, in fact, an Unexpired Lease subject to section 365(d)(4) of the Bankruptcy Code, and the Debtors reserve all of their rights with respect to such issue, including the right to argue that certain of these agreements constitute financing transactions rather than leases.

Leases may constitute an "unexpired lease" subject to assumption or rejection under section 365 of the Bankruptcy Code.<sup>4</sup>

**Request for an Extension of the Debtors'  
Deadline to Assume or Reject the Unexpired Leases**

**The Existing Deadline**

9. Section 365(d)(4) of the Bankruptcy Code provides as follows:

(A) Subject to subparagraph (B), an unexpired lease of nonresidential property under which the debtor is the lessee shall be deemed rejected and the trustee shall immediately surrender that nonresidential real property to the lessor, if the trustee does not assume or reject the unexpired lease by the earlier of —

(i) the date that is 120 days after the date of the order for relief; or

(ii) the date of the entry of an order confirming a plan.

(B)(i) The court may extend the period determined under subparagraph (A), prior to the expiration of the 120-day period, for 90 days on the motion of the trustee or lessor for cause.

(ii) If the court grants an extension under clause (i), the court may grant a subsequent extension only upon prior written consent of the lessor in each instance.

11 U.S.C. § 365(d)(4). As such, under section 365(d)(4), the Debtors have 120 days from the Petition Date to assume or reject the Unexpired Leases, unless this deadline is extended for up to an additional 90 days by order of the Court, or longer by consent of the applicable Lessors.

10. In these chapter 11 cases, the 120-day period established by section 365(d)(4)(A) expires on May 10, 2012 (the "NRRP Deadline"). Consequently, unless the NRRP

leases listed in the attached Exhibit A. Accordingly, with respect to those leases, the Debtors seek an extension of time only if the foregoing motion is not granted and the leases remain in effect.

<sup>4</sup> As described above, the Debtors have expressly reserved and retain the right to argue that certain of the agreements identified on the attached Exhibit A are not Unexpired Leases.

Deadline is extended, the Debtors will be required to make decisions concerning the Unexpired Leases by the first business day of next month. The Debtors' failure to take any action to assume or reject the Unexpired Leases or obtain an extension of the NRRP Deadline would result in the Unexpired Leases being deemed rejected.

**Justifications for Extending the Deadline**

11. In light of the circumstances of these cases, the Debtors require additional time to evaluate the Unexpired Leases before they decide whether to assume or reject these leases.

12. Given the size and scope of the Debtors' businesses and the complexity of their financial affairs, the Debtors have devoted the majority of their efforts to date to completing the transition to operations in chapter 11 and resolving other pressing matters incident to the commencement of these cases, including securing approval of their postpetition financing facility, commencing a third party investor process and negotiating with their unions and preparing for trial under sections 1113 and 1114 of the Bankruptcy Code. Although the Debtors have begun the evaluation of the Unexpired Leases (and have already rejected certain leases not necessary to their businesses), the Debtors require additional time to evaluate these matters in the context of implementing their long-term business and turnaround plan. To minimize the chances that the Debtors make an improvident decision to assume or reject the Unexpired Leases, the Debtors request a 90-day extension of the NRRP Deadline.

13. Under section 365(d)(4) of the Bankruptcy Code, this Court may extend the NRRP Deadline for an additional 90 days for "cause." See 11 U.S.C. § 365(d)(4)(B)(i). Courts in this Circuit have developed a non-exclusive list of factors to consider in determining what constitutes sufficient "cause" to extend the time period within which a debtor may assume or reject unexpired leases of nonresidential real property. See South Street Seaport Ltd. P'ship v.



Burger Boys, Inc. (In re Burger Boys, Inc.), 94 F.3d 755, 761 (2d Cir. 1996); In re Wedtech Corp., 72 B.R. 464, 471-72 (Bankr. S.D.N.Y. 1987). These factors include:

- (a) whether the leases are important assets of the estate;
- (b) whether the decision to assume or reject these leases would be central to any plan of reorganization;
- (c) the complexity of the case;
- (d) the number of leases at issue; and
- (e) the debtor's need for additional time to complete an intelligent appraisal of each lease's value to a plan of reorganization.

Wedtech, 72 B.R. at 471-72; see also Burger Boys, 94 F.3d at 761; (citing Theatre Holding Corp. v. Mauro, 681 F.2d 102, 105-106 (2d Cir. 1982), and noting that the list of factors "is by no means exhaustive," and a bankruptcy court may consider others, such as the complexity of the debtor's case and the number of leases the debtor must evaluate); In re Enron Corp., 330 B.R. 387, 393 n.10 (Bankr. S.D.N.Y. 2005) (finding that courts in the Second Circuit consider the factors provided in Burger Boys, among others, when setting the time for a debtor to assume or reject a contract).

14. The foregoing factors support a finding of cause to extend the NRRP Deadline in these cases. As an initial matter, the Unexpired Leases are important assets of the Debtors' estates. These leases provide the Debtors with, among other things, retail outlets and depot and storage facilities central to their current operations. Given the potential importance of the Unexpired Leases to the Debtors' overall business and future operations, the Debtors believe that the decision to assume or reject these leases must be made to the fullest extent possible consistent with the strategies and initiatives being implemented as part of the Debtors' turnaround plan. As described above, the Debtors' efforts to date have been focused primarily on completing a transition to operations in chapter 11 and negotiating with their unions—substantial

tasks in light of the size and complexity of the Debtors' businesses. Moreover, the number of Unexpired Leases, as described above, is significant. The Debtors, therefore, require additional time to determine how they will treat each of the Unexpired Leases.

15. Due to the number of Unexpired Leases, and the other matters occurring in these cases that have occupied the Debtors' time, the Debtors cannot make an adequately informed and intelligent appraisal of all of the Unexpired Leases within the current timeframe. If the Debtors nevertheless were forced to make a decision to assume or reject all of the Unexpired Leases prior to the current NRRP Deadline, the Debtors run the distinct risk of prematurely and improvidently assuming certain Unexpired Leases that they later determine to be burdensome — thus creating potential administrative claims — or prematurely and improvidently rejecting certain Unexpired Lease that the Debtors later discover are critical to their reorganization efforts. Additional time would mitigate the risk of such an improvident decision. Moreover, given the number of Unexpired Leases and their complexity, additional time is required to complete a full evaluation of these agreements.

16. Additionally, although the Debtors' reorganization efforts are continuing, should those efforts fail, the terms of the Debtors' debtor in possession financing contemplate a transition into a sale and/or liquidation mode. Whether such a transformation is necessary will hinge in large part on the Debtors' efforts to negotiate with their unions and the outcome of the hearing on the Debtors' motion pursuant to sections 1113 and 1114 of the Bankruptcy Code, which is now scheduled to be heard by this Court on April 17 and 18, 2012. In the event the outcome of that hearing requires the Debtors to shift the focus of these cases, the Debtors' decisions regarding the Unexpired Leases will similarly be affected, and the Debtors will require

additional time in order to make a fully-informed decision to either assume or reject the Unexpired Leases.

17. For all of these reasons, the Debtors submit that it would be imprudent to make final assumption or rejection decisions with respect to all of the Unexpired Leases prior to the current NRRP Deadline, and there is cause to extend the NRRP Deadline by an additional 90 days, through and including August 8, 2012 (or the date of the entry of an order confirming a plan of reorganization, if such date is prior to August 8, 2012). Courts in this District have granted similar requests for relief by Debtors. See, e.g., In re Great Atl. & Pac. Co., Case No. 10-24549 (Bankr. S.D.N.Y. Mar. 24, 2011) (granting 90-day extension, pursuant to section 365(d)(4) of the Bankruptcy Code); In re Uno Rest. Holdings Corp., Case No. 10-10209 (Bankr. S.D.N.Y. May 11, 2010) (same); In re Finlay Enters., Inc., Case No. 09-14873 (Bankr. S.D.N.Y. Dec. 17, 2009) (same); In re Stone Barn Manhattan LLC, Case No. 08-12579 (Bankr. S.D.N.Y. Oct. 17, 2008) (same); In re Extended Stay Inc., Case No. 09-13764 (Bankr. S.D.N.Y. Oct. 8, 2009) (granting 90-day extension of the 120-day period to assume or reject unexpired leases); In re Ion Media Networks, Inc., Case No. 09-13125 (Bankr. S.D.N.Y. Oct. 6, 2009) (same); In re Dana Corp., Case No. 06-10354 (Bankr. S.D.N.Y. June 28, 2006) (same).<sup>5</sup>

18. In addition, pending the Debtors' election to assume or reject each of the Unexpired Leases, the Debtors will continue to perform all of their obligations arising under the Unexpired Leases from and after the Petition Date in a timely fashion, including by paying all postpetition rent due, as required by section 365(d)(3) of the Bankruptcy Code. Thus, the extension of time requested in this Motion will not prejudice the Lessors under the Unexpired

Leases. In addition, the Debtors request that any order granting the relief requested in this Motion be entered without prejudice to the right of any Lessor to seek an order requiring the Debtors to elect to assume or reject a particular Unexpired Lease prior to the NRRP Deadline, as extended in connection with this Motion.

**Notice**

19. Pursuant to the Administrative Order, Pursuant to Rule 1015(c) of the Federal Rules of Bankruptcy Procedure, Establishing Case Management and Scheduling Procedures (Docket No. 371) (the "Case Management Order"), entered on February 21, 2012, notice of this Motion has been given to (a) the parties identified on the Special Service List and the General Service List (as such terms are defined in the Case Management Order) and (b) the Lessors. The Debtors submit that no other or further notice need be provided.

**No Prior Request**

18. No prior request for the relief sought in this Motion has been made to this or any other court in connection with these chapter 11 cases.

WHEREFORE, the Debtors respectfully request that the Court (i) enter an order substantially in the form attached hereto as Exhibit B, granting the relief requested herein; and (ii) grant such other and further relief to the Debtors as the Court may deem proper.

**ORDER, PURSUANT TO SECTION 365(d)(4) OF  
THE BANKRUPTCY CODE, EXTENDING TIME FOR  
THE DEBTORS AND DEBTORS IN POSSESSION TO ASSUME OR  
REJECT UNEXPIRED LEASES OF NONRESIDENTIAL REAL PROPERTY**

This matter coming before the Court on the Motion of Debtors and Debtors in Possession for an Order, Pursuant to Section 365(d)(4) of the Bankruptcy Code, Extending Their Time to Assume or Reject Unexpired Leases of Nonresidential Real Property (the "Motion"),<sup>2</sup> filed by the debtors and debtors in possession in the above-captioned cases (collectively, the "Debtors"); the Court having reviewed the Motion and having considered the statements of counsel at a hearing before the Court (the "Hearing"); and the Court having found that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b), (c) notice of the Motion and the Hearing was sufficient under the circumstances and (d) cause has been established under section 365(d)(4)(B)(i) of the Bankruptcy Code to extend the NRRP Deadline as set forth herein; and the

Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein;

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED.
2. Pursuant to section 365(d)(4) of the Bankruptcy Code, the time period within which the Debtors must assume or reject each of the Unexpired Leases is extended by 90 days, through and including August 8, 2012 (or the date of the entry of an order confirming a plan of reorganization, if such date is prior to August 8, 2012), without prejudice to the Debtors' rights to seek further extensions upon consent of the affected Lessors.
3. This Order is without prejudice to (a) the right of any Lessor to seek an order requiring a Debtor to elect to assume or reject a particular Unexpired Lease prior to August 8, 2012 (or the date on which the Debtors confirm a plan of reorganization, if such date is prior to August 8, 2012) or (b) the Debtors' right to oppose any such relief.
4. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order.
5. The Court retains jurisdiction with respect to all matters arising from or related to the interpretation, implementation and/or enforcement of this Order.
