**AMENDMENT TO SCHEDULE B**

(1) Add the following property and value:

- 40. Demineralization filtration equipment value: \$335,000.00
- tin to build 80`x140` storage sheds value: \$100,000.00

After this Amendment, the total value of property on Schedule B is \$9,072,018.55.

\*This Amendment does not affect any creditor except Northwest bank, because the bank holds a blanket security interest in these non-title assets. When the bankruptcy schedules were prepared, the 2014 year end depreciation schedule was used and that schedule did not include these assets because they were not and still are not in service. The value used for the filtration equipment is 10% of original cost and the Debtor estimates the liquidation value to be only \$100,000.00 because the equipment has a very specific purpose for Debtor’s manufacturing process. The cost for the tin was \$237,500.00, and the value listed is estimated if reasonable effort were made to find a buyer. If the tin were liquidated at auction value would likely be closer to \$50,000.00.
