INCLUSION IN THE FOLLOWING LIST SHALL NOT CONSTITUTE AN ADMISSION BY THE DEBTORS, THE LIQUIDATION TRUST, OR THE POST-CONSUMMATION TRUST THAT THE LISTED DOCUMENTS ARE EXECUTORY CONTRACTS OR UNEXPIRED LEASES, OR WITH REGARD TO THE NATURE OR VALIDITY OF SUCH DOCUMENTS.

EXECUTORY CONTRACTS AND UNEXPIRED LEASES SHALL BE TREATED IN THE MANNER SET FORTH IN ARTICLE V OF THE PLAN AND IN THE CONFIRMATION ORDER.

THE DEBTORS SHALL PAY THE CURE AMOUNTS SET FORTH HEREIN (THE "CURE AMOUNT CLAIM"), IF ANY: (A) IN CASH ON OR AS SOON AS REASONABLY PRACTICAL AFTER THE EFFECTIVE DATE OR (B) ON SUCH OTHER TERMS AS ARE AGREED TO BY THE PARTIES TO THE APPLICABLE EXECUTORY CONTRACT OR UNEXPIRED LEASE. PAYMENT OF THE CURE AMOUNT CLAIM SHALL SATISFY, IN FULL, THE DEBTORS' OBLIGATIONS PURSUANT TO SECTION 365(b)(1) OF THE BANKRUPTCY CODE.

A COUNTERPARTY MAY FILE AN OBJECTION TO A CURE AMOUNT CLAIM BY FILING A PROOF OF CLAIM WITH THE CLAIMS AND SOLICITATION AGENT NO LATER THAN THIRTY (30) DAYS AFTER THE EFFECTIVE DATE AND SERVING SUCH OBJECTION UPON THE POST-CONSUMMATION TRUST AND THE LIQUIDATION TRUST. IF NO OBJECTION TO THE CURE AMOUNT CLAIM IS TIMELY FILED, THE COUNTERPARTY TO THE EXECUTORY CONTRACT OR UNEXPIRED LEASE SHALL BE BOUND BY THE CURE AMOUNT CLAIM AND SHALL BE FOREVER BARRED FROM ASSERTING ANY ADDITIONAL CURE CLAIM AGAINST THE DEBTORS, THE LIQUIDATION TRUST, THE POST-CONSUMMATION TRUST, THEIR RESPECTIVE SUCCESSORS, OR THEIR RESPECTIVE PROPERTIES UNLESS OTHERWISE ORDERED BY THE BANKRUPTCY COURT. IN THE EVENT THERE IS A



DISPUTE REGARDING THE ASSUMPTION OF AN EXECUTORY CONTRACT OR UNEXPIRED LEASE, INCLUDING ANY DISPUTE REGARDING THE PROPER CURE AMOUNT CLAIM, THAT CANNOT BE RESOLVED CONSENSUALLY BY THE COUNTERPARTY TO THE EXECUTORY CONTRACT OR UNEXPIRED LEASE AND THE DEBTORS, THE LIQUIDATION TRUST, OR THE POST-CONSUMMATION TRUST, AS APPLICABLE, SUCH CONTRACT OR LEASE SHALL NOT BE ASSUMED UNLESS AND UNTIL SUCH ASSUMPTION IS APPROVED BY A FINAL ORDER OF THE BANKRUPTCY COURT. THE DEBTORS, THE LIQUIDATION TRUST, AND THE POST-CONSUMMATION TRUST, AS APPLICABLE, RESERVE THE RIGHT TO REJECT ANY EXECUTORY CONTRACT OR UNEXPIRED LEASE IN THE EVENT ANY DISPUTE REGARDING ASSUMPTION IS NOT RESOLVED TO THE SATISFACTION OF THE DEBTORS, THE LIQUIDATION TRUST, AS APPLICABLE.
