Another company owned by J. Peter Jungbacker, Alexander & Bishop Real Estate Capital Markets LLC ("ABRE"), has periodically advanced funds to the Debtor for over a decade for various tenant improvements and operating costs. ABRE functions as the intermediary or "clearing house" for all intercompany loans among numerous entities owned or controlled by Jungbacker (not including ORC). When Company X has excess cash in its checking account, ABRE will borrow some of the available funds and lend them to Company Y, which is short of cash needed to pay its immediate obligations. When Company Y's cash position improves, ABRE will require a repayment, and may re-lend those funds to Company Z for the costs of tenant improvements. Using ABRE as either the borrower or the lender for all intercompany loans eliminates the complication of having more than 100 separate intercompany relationships.
