E	Joanna Rothchild	900007018	N/A <sup>1</sup>	Claimant submitted a check issued by Lehman Brothers Special Financing out of a Chase Manhattan Bank Account. EX. E 007. G	Phyllis Dua	900007075	1126	Claimant states that the claim is for an LBHI security and attaches a Ferris Baker Watts trade confirmation demonstrating the purchase of the claimed security. EX G 003 - 004.	The claimant submits an explanation of her claim which indicates that her claim is based on the loss in value of LBHI securities. EX. G 006 - 007.
H	Schoellerbank Aktiengesells chaft	800000789	1188	Claimant submitted a statement from Clearstream Banking listing securities issued by Lehman Bros. Treas. Co. B.V. with an ISIN of XS0252173066, and states "we have no account with LBI." EX. H 005 - 006.
