21 A continued hearing was held at the above time and place on the “Debtor’s Emergency
22 Motion for Entry of Order (1) Authorizing Use of Cash Collateral on an Interim Basis and
23 (2) Setting a Final Hearing on Use of Cash Collateral” (the “Motion,” Docket No. 8), filed by
24 debtor Orange Courier, Inc. (the “Debtor”). Appearances were noted on the record.

25 The court having considered Motion, the remarks of chapter 11 trustee David K. Gottlieb
26 (the “Trustee”), the remarks of counsel for the Trustee, and the record in this case, and for the
27 reasons set forth by the court on the record at the hearing,

1 IT IS HEREBY ORDERED that:

2 A. The Trustee is authorized to use “cash collateral,” as such term is defined in
3 11 U.S.C. § 363(a), through and including April 15, 2026, to pay expenses of the Debtor’s
4 business incurred in the ordinary course of the Debtor’s business as determined by the Trustee.

5 B. Starting April 1, 2026, the bankruptcy estate must make monthly adequate
6 protection payments to the U.S. Small Business Administration (the “SBA”) in the amount of
7 \$731.00.

8 C. On account of the bankruptcy estate’s use of “cash collateral” as defined in
9 11 U.S.C. § 363(a), the SBA and any party asserting an interest in such “cash collateral” are
10 granted replacement liens on, and security interests in, the assets of the bankruptcy estate
11 including all post-petition proceeds obtained by the Debtor from such pre-petition collateral but
12 not against any avoidance action claims under Chapter 5 of the Bankruptcy Code or any
13 recoveries thereon (“Avoidance Actions”), with the same extent, validity, and priority as their
14 respective pre-petition liens on pre-petition collateral.

15 D. A further hearing for the court to consider further use of cash collateral beyond
16 April 15, 2026 will be held on April 14, 2026 at 1:00 p.m.

17 E. All of the Debtor’s customers and account debtors that owe money to the Debtor
18 are hereby instructed and directed to deliver payment solely in the following manner:

- 19 (1) By check, made payable to Orange Courier, Inc. and delivered to
20 16222 Phoebe Ave., La Mirada, CA 90638, Attention: David K. Gottlieb or to
21 such other address as directed in writing by David K. Gottlieb; or
22 (2) By ACH, pursuant to the instructions attached hereto, or any new or modified
23 instructions as made or directed by David K. Gottlieb during this case.

24 F. The Trustee is authorized to communicate the contents of this order, and/or
25 deliver a copy of this order, to all of the Debtor’s customers and account debtors, and any other
26 party in interest. Any creditor or party that takes any action in contravention, breach, or
27

violation of the provisions of Paragraph E above will be subject to sanctions, damages, and any
other appropriate ruling of the court.
