GLOBAL NOTES AND STATEMENT OF LIMITATIONS, METHODOLOGY AND DISCLAIMER REGARDING DEBTOR'S SCHEDULES AND STATEMENTS

The Schedules of Assets and Liabilities and Statements of Financial Affairs (the "Schedules" and "Statements," respectively) filed by the above-referenced debtor and debtor in possession (the "Debtor"), in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court"), were prepared by the Debtor's management, with the assistance of the Debtor's personnel and bankruptcy professionals, pursuant to 11 U.S.C. § 521² and Federal Rule of Bankruptcy Procedure 1007 and are unaudited. The Schedules and Statements remain subject to further review and verification by the Debtor. Subsequent information may result in material changes in financial and other data contained in the Schedules and Statements. The Debtor reserves its right to amend the Schedules and Statements from time to time as may be necessary or appropriate without notice. These Global Notes and Statement of Limitations, Methodology and Disclaimer Regarding Debtor's Schedules and Statements (the "Global Notes") are incorporated by reference in, and comprise an integral part of, each of the Schedules and Statements, and should be referred to and reviewed in connection with any review of the Schedules and Statements.

- 1. <u>Case</u>. On February 20, 2009 (the "<u>Petition Date</u>"), the Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the Bankruptcy Court. Unless otherwise indicated, the information provided is as of the close of business on the Petition Date.
- 2. <u>Joint Administration</u>. Pursuant to an order entered February 23, 2009 [Docket No. 31], the Debtor's Chapter 11 case is jointly administered with the case of Qimonda North America Corp. ("QNA") (case number 09-10590) under case number 09-10589. Notwithstanding the joint administration of the Debtor's case, each debtor has filed its own Schedules and Statements.
- 3. <u>Amendments</u>. The Debtor reserves the right to amend the Schedules and Statements in all respects at any time as may be necessary or appropriate, including without

limitation, (a) to assert offsets or defenses to any claim, (b) to amend the amount, liability, or classification of any claim, or (c) to otherwise designate any claim as contingent, unliquidated or disputed.

- 4. <u>Estimates and Assumptions</u>. The preparation of the Schedules and Statements required the Debtor to make estimates and assumptions with respect to the reported amounts of assets and liabilities, the value of contingent assets and liabilities on the date of the Schedules and Statements and the reported amounts of revenues and expenses during the applicable reporting periods. Actual results could differ from those estimates.
- 5. <u>Prepetition v. Postpetition</u>. The Debtor has allocated liabilities between the prepetition and postpetition periods based upon information from research conducted in connection with the preparation of the Schedules and Statements. As additional information becomes available and further research is conducted, the identification of liabilities as prepetition or postpetition may change.
- 6. <u>GAAP</u>. Given the difference between the financial information requested in the Schedules and Statements and used under generally accepted accounting principles in the United States ("<u>GAAP</u>"), the aggregate asset values and claim amounts set forth in the Schedules and Statements may not reflect the amounts that would be set forth in a balance sheet prepared in accordance with GAAP.
- 7. <u>Causes of Action</u>. The Debtor reserves all of its causes of action. Furthermore, nothing contained in the Schedules and Statements shall constitute a waiver of any claim or cause of action that may be asserted, including, but not limited to, equitable subordination, causes of action arising under Chapter 5 of the Bankruptcy Code and any other causes of action arising in this Chapter 11 case or under applicable non-bankruptcy law.
- 8. <u>Insiders</u>. Where the Schedules or Statements require information concerning officers, directors or insiders, included therein are the Debtor's (a) directors (or persons in similar positions) and (b) employees that are, or were during the relevant period, officers (or persons in control). Employees may have been included in this disclosure for informational purposes only and are not necessarily "insiders" as defined in § 101(31) or as otherwise defined by applicable law, including, without limitation, any state or federal securities law. The listing of a party as an insider is not intended to be nor should it be construed as a legal characterization of such party as an insider, nor should it be construed as an admission that such party is an insider, all such rights, claims and defenses being expressly reserved.
- 9. <u>Qimonda North America Corp. Address</u>. As of the Petition Date, the address for QNA and its employees was 3000 CentreGreen Way, Cary, NC 27513. In the near term, QNA will be moving its offices to 4721 Emperor Blvd., Durham, NC 27703. The Debtor has listed this latter address in its Schedules and Statements for QNA.
- 10. <u>Prepetition Claims Paid Postpetition.</u> As part of the "first day" orders, the Debtor was authorized to pay certain outstanding, prepetition claims, including, but not limited to, wages and benefits, workers' compensation claims and taxes. Any such prepetition claims that have been paid postpetition pursuant to the authority granted by the Bankruptcy Court have been

excluded from the Schedules and Statements. The inadvertent inclusion of any such amounts shall not be deemed to obligate the Debtor to pay such amounts again. Further, the Debtor may continue to pay prepetition claims in accordance with the authority granted by the Bankruptcy Court. The balances listed in the Schedules and Statements are as of April 30, 2009, and any such subsequent payments shall reduce (or eliminate) the amounts owed to such claimants.

- 11. <u>Categories or Labels Use in Schedules and Statements</u>. Information requested by the Schedules and Statements requires the Debtor to make judgments regarding the appropriate category in which information should be presented or how certain parties, claims or other data should be labeled. The Debtor's decisions regarding the category or label to use is based on the best information available as of the filing of these Schedules and Statements and within the time constraints imposed. The Debtor reserves the right to modify, change or delete any information in the Schedules and Statements by amendment, including to the extent some information currently presented should be moved to a different category or labeled in a different way.
- 12. <u>Summary of Significant Reporting Policies and Practices</u>. The following conventions were adopted by the Debtor in preparing the Schedules and Statements:
 - a. <u>Personal Information</u>. The Debtor has not included home addresses of current and former employees and directors in the Schedules and Statements. Such information will be provided upon reasonable request to parties having an interest in such information.
 - b. Fair Market Value; Book Value. For the preparation of these Schedules and Statements, it would be prohibitively expensive, unduly burdensome and time-consuming to obtain current market valuations of all of the Debtor's property interests. Accordingly, unless otherwise noted, each asset and liability of the Debtor is shown on the basis of the net book value of the asset or liability in accordance with the Debtor's accounting or tax books and records as of the Petition Date. As applicable, assets that have been fully depreciated or were expensed for accounting purposes have no net book value. Unless otherwise noted, the Schedules reflect the net book value of the liabilities as listed in the Debtor's books and records, and are not based upon any estimate of their current market values, which may not correspond to book value. For this reason, amounts ultimately realized may vary from net book value and such variances may be material. Unless otherwise indicated, all amounts are listed as of the Petition Date.
 - c. <u>Leased Real and Personal Property</u>. In the ordinary course of its business, the Debtor leases real and personal property, including furniture, fixtures and equipment, from certain third-party lessors. Nothing in the Schedules or Statements is or shall be construed as an admission or determination as to legal status of any lease (*e.g.*, as a true lease or financing arrangement), and the Debtor reserves all rights with respect to such issues.
 - d. <u>Claims</u>. The Schedules and Statements generally identify parties holding claims existing as of the Petition Date. The Bankruptcy Court, however, has authorized

the Debtor to continue certain prepetition practices and make payments in respect of certain prepetition claims. Accordingly, certain of the claims identified in the Schedules and Statements may already have been paid or may be paid in the future. The inclusion of such amounts on the Schedules and Statements shall not be deemed to create any additional obligation for the Debtor.

- e. <u>Disputed, Contingent and Unliquidated Claims</u>. The Debtor may designate certain claims on Schedules D, E and F as disputed, contingent and/or unliquidated, as applicable. Any failure to designate a claim on the Schedules and Statements as disputed, contingent and/or unliquidated does not constitute an admission that such claim is not disputed, contingent and/or unliquidated, as applicable. The Debtor reserves the right to dispute, or assert offsets or defenses to, any claim reflected on the Schedules and Statements as to amount, liability or status.
- 13. <u>Summary of Significant "Schedules" Conventions</u>. The following conventions were adopted by the Debtor in preparation of the Schedules:
 - Schedule D. Except as otherwise agreed pursuant to a stipulation or order entered by the Bankruptcy Court, the Debtor reserves its rights to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D. Moreover, except as otherwise agreed pursuant to a stipulation or order entered by the Bankruptcy Court, the Debtor reserves all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument (including, without limitation, any intercompany agreement) related to such creditor's claim. In certain instances, the Debtor may be a co-obligor or guarantor with respect to scheduled claims of the other debtor, and no claim set forth on Schedule D of the Debtor is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other entities. The descriptions provided in Schedule D are intended only to be a summary, and reference should be made to the applicable loan agreements and related documents for a complete description of any collateral and corresponding liens or security interests. Nothing in the Global Notes or the Schedules and Statements shall be deemed a modification or interpretation of the terms of such agreements.

The Debtor has not included on Schedule D any creditor who may assert an interest in property of the estate by way of setoff rights, deposits posted by or on behalf of the Debtor or inchoate statutory lien rights. Any such creditors may, however, be listed on Schedule F.

On September 30, 2008, the Debtor accelerated the depreciation of the assets of the 200mm plant. All of the 200mm assets have been fully depreciated as of the Petition Date.

b. <u>Schedule E</u>. As noted above, as part of the "first day" orders, the Debtor was authorized to pay certain outstanding, prepetition amounts owing with respect to

employee wages and benefits and taxes. Therefore, any such prepetition claims that have been paid postpetition in accordance with the Bankruptcy Court's orders have not been listed in these Schedules and Statements. The inadvertent inclusion of any such amounts shall not be deemed to obligate the Debtor to pay such amounts again. Further, the Debtor may continue to pay prepetition claims in accordance with the authority granted by the Bankruptcy Court. The balances listed in the Schedules and Statements are as of April 30, 2009, and any such subsequent payments shall reduce (or eliminate) the amounts owed to such claimants.

The listing of any claim on Schedule E does not constitute an admission by the Debtor that such claim is entitled to priority treatment under 11 U.S.C. § 507. Such claims remain subject to further review and verification.

The Debtor does not have any employees. All employees are formally employed, and paid, by QNA. However, certain QNA employees perform services, and work, for the Debtor. Those employees are paid their salaries or wages by QNA, and QNA is subsequently reimbursed by the Debtor for the value of such services in the form of an intercompany transaction. This reimbursement claim represents the majority of the payments made by the Debtor to QNA in the one year prior to the Petition Date.

- <u>Schedule G.</u> While reasonable efforts have been made to ensure the accuracy of Schedule G, inadvertent errors, omissions or over-inclusions may have occurred. Listing a contract or lease on Schedule G does not constitute an admission that such contract or lease is an executory contract or unexpired lease or that such contract or lease was in effect on the Petition Date or is valid or enforceable. Any and all of the Debtor's rights, claims and causes of action with respect to the contracts and agreements listed on Schedule G are hereby reserved. In addition, the Debtor may have entered into various other types of agreements in the ordinary course of business, such as supplemental agreements, amendments/letter agreements and confidentiality agreements. Such documents may not be set forth in Schedule G. The Debtor reserves all of its rights to dispute or challenge the characterization of the structure of any transaction or any document or instrument related to a creditor's claim (including, but not limited to, whether the transaction, document or instrument is a true lease or financing arrangement). Omission of a contract or lease from Schedule G does not constitute an admission that such omitted contract or lease is not an executory contract or unexpired lease. The Debtor's rights under the Bankruptcy Code with respect to any such omitted contracts or leases are not impaired by the omission.
- 14. <u>Summary of Significant "Statement" Conventions</u>. The following conventions were adopted by the Debtor in preparation of the Statements:
 - a. <u>Statement 3b</u>. In the list of payments under question 3b, the Debtor has not included ordinary course payments for wages, compensation or expenses made to employees. To the extent an employee is a creditor notwithstanding the first-day

- motion, that employee's claim may be entitled to (in whole or in part) priority treatment in accordance with section 507 of the Bankruptcy Code.
- b. <u>Statement 3c</u>. As part of Qimonda AG global cash management policies, cash was pooled daily both to and from QNA and the Debtor bank accounts to bank accounts of Qimonda AG. Daily transfers of cash to Qimonda AG from QNA and the Debtor as part of the cash management are not captured in Statement 3c. Cash pooling was terminated on January 23, 2009.
- 15. General Disclaimer. While those members of management responsible for the preparation of the Schedules and Statements have made a reasonable effort to ensure that the Schedules and Statements are accurate and complete based on information known to them at the time of preparation after reasonable inquiries, inadvertent errors may exist or the subsequent receipt of information may result in material changes in financial and other data contained in the Schedules and Statements that may warrant amendment of the same. Moreover, because the Schedules and Statements contain unaudited information that is subject to further review and potential adjustment, there can be no assurance that the Schedules and Statements are complete or accurate.
