# AGREED ORDER APPROVING AUCTION AGREEMENT AND SALE OF ESTATE PROPERTY FREE AND CLEAR OF LIENS, CLAIMS AND ENCUMBRANCES [relates to Doc. No. 27]

THE R. HASSELL HOLDING COMPANIES INC. ("RHHC"), Debtor and Debtor-in-Possession, has filed an Emergency Application (A) to Approve Retention of Auctioneer; (B) to Approve Auction Contract, and (C) for Approval of a Sale Free And Clear of Liens, Claims and Encumbrances ("Application"). The Court finds that it has jurisdiction over the matters covered in the Application, and has requisite constitutional authority to enter a final order approving the Application. After notice and hearing, this Court finds that the proposed Multi-Channel Sale Agreement by and between the Debtor and Ritchie Bros. Auctioneers (America), Inc. ("Auctioneer") attached as Exhibit "1" to the Application (the "Auction Agreement") is reasonable, necessary and in the best interests of the Debtor, Debtor's estate and creditors and parties-in-interest. The Court also finds that the proposed Auction Agreement and the proposed sale free and clear of liens and encumbrances contemplated in the Application is within the sound business judgment of the Debtor, that the Debtor and its management have exercised such business judgment in good faith after considering all of the applicable factors. Therefore, it is

ORDERED that the Auction Agreement is hereby approved; and it is further

**ORDERED** that the sale of the Debtor's Equipment contemplated in the Application by the Auctioneer is hereby approved; and it is further

**ORDERED** that the Debtor's Equipment sold at auction by the Auctioneer pursuant to the Auction Agreement is hereby sold to the purchasers free and clear of liens, claims and encumbrances; and it is further

**ORDERED** that the liens or interests of Texas Capital Bank, NA ("TCB") are transferred to the proceeds of sale of the Debtor's Equipment in the same priority as such liens or interests existed on Debtor's Equipment as of the date this Chapter 11 was filed on June 30, 2018; and it is further

**ORDERED** that from the proceeds of sale of the Equipment the reimbursable costs and commissions payable to the Auctioneer pursuant to the Auction Agreement shall be paid to the Auctioneer, and the amount remaining after such payments ("Net Sales Proceeds") shall remain with the Auctioneer subject to further order of this Court; and it is further

**ORDERED** that the Debtor shall obtain insurance for the Equipment in the amounts set forth on **Exhibit A** and that TCB shall be named the loss payee for such insurance; and it is further

**ORDERED** that TCB does not waive any of its rights or remedies through the granting of the relief sought in the Debtor's Application.
