# EXPEDITED NOTICE OF HEARING AND MOTION FOR APPROVAL TO AUCTION PROPERTY OF THE ESTATE

- TO: The United States Bankruptcy Court, the United States Trustee, the Debtor, all creditors and all parties who requested notice under Bankruptcy Rule 2002.
- 1. David G. Velde, Trustee of the bankruptcy estate of the above-named debtor, moves the court for the relief requested below and gives notice of hearing.
- 2. The Trustee seeks approval of an expedited basis. The Court will hold a hearing on this motion at 9:00 a.m. on Wednesday, June 6, 2018, in US Bankruptcy Court, Courtroom 2, 2<sup>nd</sup> Floor, 118 South Mill Street, Fergus Falls, Minnesota.
- Any response to this motion must be filed and served not later than Wednesday, June 6, 2018, at 9:00 a.m., at the hearing.
- 4. This Chapter 11 case was filed on August 11, 2017. The court has jurisdiction over this motion pursuant to 28 U.S.C. §§157 and 1334. This is a core proceeding. The case is now pending in this Court.
- This motion arises under 11 U.S.C. § 363(f), and Federal Rule of Bankruptcy 6004©) and Local Rule 6004-1. This motion is filed under Bankruptcy Rule 9014 and Local Rule 9013-1.
- 6. Movant seeks an order of the Court approving the auction of the Debtor's farm equipment, subject to creditor's secured liens. The Debtor had previously made arrangements with Steffes Group, Inc. ("Steffes") to auction the equipment. Steffes has completed the advertising and marketing of the equipment and the auction is set for Tuesday, June 19, 2018, at 11:00 a.m., at 23451 County Road 26, Badger, Minnesota. A delay in the auction will result in additional expenses to the estate. See Exhibit A attached hereto.
- 7. The sale of each item is subject to the secured lien of each creditor. The Trustee will work with the lenders holding perfected security interests to satisfy their liens from the proceeds.

- 8. The Debtor has not claimed any of the equipment to be sold exempt.
- 9. The Trustee is obtaining information in order for the estate's accountant to determine the tax consequences to the estate. Given the recent appointment as Trustee and the prior scheduled auction by the Debtor, it is necessary to obtain court approval in advance of the auction date of June 19, 2018. Should it be determined that the auction will not be of benefit to the bankruptcy estate, the Trustee may seek abandonment of the estate's interest and allow the auction to proceed by the Debtor individually. In that event, the estate will not be responsible for any of the fees, expenses or taxes owing from the auction.
- 10. Steffes Group, Inc., will be allowed to retain its fees and expenses from the auction proceeds, as described on Exhibit A attached hereto, and remit the net proceeds to the bankruptcy estate.
- 11. The Trustee will file a report of sale after completion of the auction.

WHEREFORE, Movant herein seeks an expedited hearing and order approving the auction of the farm equipment, and for such other and further relief as the Court deems just and equitable.


