**GENERAL NOTES REGARDING  
THE SCHEDULES OF ASSETS AND LIABILITIES**

3. Claims Description - The Debtor reserves the right to dispute, or to assert offsets or defenses to, any claim reflected on the SOAL as to amount, liability or classification. Schedules D, E, and F permit the Debtor to designate a claim as disputed, contingent and/or unliquidated. A failure to designate a claim on the SOAL as disputed, contingent, and/or unliquidated does not constitute an admission that such claim is not subject to objection.
4. Accuracy - While every effort has been made to file a complete and accurate SOAL, inadvertent errors and/or omissions may exist. The Debtor reserves all rights to amend its SOAL as necessary and appropriate.
5. Causes of Action - The Debtor reserves all of its rights with respect to any causes of action (whether known or inchoate) that it may have and neither these notes nor the SOAL shall be deemed a waiver of any such causes of action.
6. Date - The Debtor commenced the above-referenced Chapter 11 case on March 03, 2009 (the "Commencement Date"). Immediately preceding the Commencement Date, in order to establish a clear cut-off between pre- and post-petition payables for the purposes of the automatic stay and to facilitate proper compliance with GAAP reporting requests, the Debtor instituted a month-end closing of its books. Except as otherwise noted, the values are representative of the financial values as of the Commencement Date.
7. The Debtor's assets are presented, in detail, as they appear on the Debtor's accounting sub-ledgers. As such, the detail includes error corrections and value adjustments (shown as negative values) as well as some assets that may be misclassified between asset classifications. The Debtor did not undertake to correct their financial records as part of producing these schedules.
