**AGREED ORDER ON BECKMAN COULTER INC'S MOTION FOR

AND NOW, this 29th day of May, 2012, upon consideration of Beckman Coulter Inc.'s Motion for Reconsideration of Court Order Dated May 4, 2012 Approving Contract and Authorizing Sale of Equipment Free and Clear of Liens and Permitting Replacement Liens for Use of Cash Collateral (the "Motion for Reconsideration"), filed on behalf of Beckman Coulter, Inc. ("Beckman), in which Beckman and SBMC Healthcare, LLC (Debtor") request the entry of this Agreed Order. As evidenced by the signature of their respective counsel below, Beckman and the Debtor consent to the content and entry of this Agreed Order.

THE PARTIES HEREBY STIPULATE AND AGREE AS FOLLOWS:


- A. The Debtor does not have title to the Equipment, as it belongs to Beckman;

- B. That the Debtor rejects lease numbers 27757US and 22850US;
- C. That Beckman Coulter, Inc. is granted immediate relief from the automatic stay to retrieve its Equipment;
- D. That the Equipment has been retrieved by Beckman; and
- E. That Beckman Coulter, Inc. shall have 60 days from the entry of this order to file a claim for rejection damages.
