On April 15, 2013 (the "Commencement Date"), each of the above-captioned debtors and debtors in possession (collectively, the "Debtors") commenced a voluntary case under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"). The Debtors continue to operate their businesses and manage their properties as debtors and debtors in possession, pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. The Debtors' cases have been consolidated for procedural purposes only and are being jointly administered under case number 13-10904 (PJW).

The Schedules of Assets and Liabilities and Statements of Financial Affairs (the "Schedules and SOFAs") filed by the Debtors in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") were prepared pursuant to section 521 of the Bankruptcy Code and Rule 1007 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") by management of the Debtors with unaudited information available as near as possible to the Commencement Date. The Schedules and SOFAs do not purport to represent financial statements prepared in accordance with generally accepted accounting principles in the United States ("GAAP") and they are not intended to be fully reconciled to the Debtors' financial statements.

The Schedules and SOFAs have been signed by an authorized representative of each of the Debtors. In reviewing and signing the Schedules and SOFAs, this representative relied upon the efforts, statements and representations of the Debtors' other personnel and professionals. The representative has not (and could not have) personally verified the accuracy of each such statement and representation, including, for example, statements and representations concerning amounts owed to creditors and their addresses.

These Global Notes and Statement of Limitations, Methodology and Disclaimer Regarding the Debtors' Schedules of Assets and Statements of Financial Affairs (the "Global Notes") are incorporated by reference in, and comprise an integral part of, each of the Debtors' Schedules and SOFAs, and should be referred to and reviewed in connection with any review of the Schedules and SOFAs.

1. Reservation of Rights. The Debtors' chapter 11 cases are large and complex. Although the Debtors' management has made every reasonable effort to ensure that the Schedules and SOFAs are as accurate and complete as possible, based on the information that was available to it at the time of preparation, subsequent information or discovery may result in changes to the Schedules and SOFAs (some of which may be material), and inadvertent errors or omissions may have occurred. Because the Schedules and SOFAs contain unaudited information, which is subject to further review, verification, and potential adjustment, there can be no assurance that these Schedules and SOFAs are complete. Nothing contained in the Schedules and SOFAs or these Global Notes shall constitute an admission or a waiver of any of the Debtors' rights to assert any claims or defenses. The Debtors reserve the right to amend and/or supplement the Schedules as necessary and/or appropriate.

- 2. <u>Reporting Date</u>. Unless otherwise noted, the data contained in the Schedules and SOFAs is effective as of March 31, 2013 ("Reporting Date") as reflected on the Debtors' books and records.
- 3. <u>Currency</u>. All amounts are reflected in U.S. dollars.
- 4. <u>Estimates and Assumptions</u>. The preparation of the Schedules and SOFAs required the Debtors to make estimates and assumptions that affected the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported amounts of revenue and expense. Actual results could differ materially from these estimates.
- 5. Asset Presentation and Valuation. The Debtors do not have current market valuations for all of their assets. It would be prohibitively expensive, unduly burdensome and an inefficient use of estate assets for the Debtors to obtain current market valuations for all of their assets, to the extent such valuations even exist. Unless otherwise indicated, asset valuations are presented as the net book value as of the Reporting Date. When necessary, the Debtors have indicated that the value of certain assets is "Unknown" or "Undetermined." Amounts ultimately realized may vary from net book value (or whatever value was ascribed) and such variance may be material. Accordingly, the Debtors reserve all of their rights to amend, supplement, or adjust the value of each asset set forth in the Schedules and SOFAs. As applicable, fixed assets and leasehold improvement assets that have been fully depreciated, fully amortized or were expensed for GAAP accounting purposes have no net book value and are therefore not included in the Schedules and SOFAs.
- 6. <u>Insiders</u>. For purposes of the Schedules and SOFAs, the Debtors define "insiders" pursuant to section 101(31) of the Bankruptcy Code as: (a) directors; (b) officers; (c) persons in control of the Debtors; and (d) relatives of the Debtors' directors, officers or persons in control of the Debtors. Persons listed as "insiders" have been included for informational purposes only. Moreover, the Debtors do not take any position with respect to: (a) any insider's influence over the control of the Debtors; (b) the management responsibilities or functions of any such insider; (c) the decision-making or corporate authority of any such insider; or (d) whether the Debtors or any such insider could successfully argue that he or she is not an "insider" under applicable law or with respect to any theories of liability or for any other purpose.
- 7. <u>Liabilities</u>. Some of the scheduled liabilities are unknown and unliquidated at this time. In such cases, the amounts are listed as "Unknown" or "Undetermined." Accordingly, the Schedules and the SOFAs do not accurately reflect the aggregate amount of the Debtors' total liabilities.
- 8. <u>Consolidated Accounts Payable and Disbursements System</u>. The Debtors utilize an integrated, centralized cash management system, in the ordinary course of business, to collect and transfer the funds generated by their operations and to disburse funds to satisfy their financial obligations. Substantially all accounts payable processing and

disbursements were made from The SCOOTER Store, Ltd. for all other Debtor entities, and intercompany allocations were performed accordingly. A more complete description of the centralized cash management system can be found in *The Debtors' Motion for Entry of an Order (A) Authorizing the Debtors to (I) Continue Use of Cash Management System, Bank Account and Business Forms and (II) Authorizing the Debtors to Open New Debtor-In-Possession Accounts and (B) Extending the Debtors' Time to Comply with Section 345(b) of the Bankruptcy Code filed on the Commencement Date [Docket No. 5].*

- 9. <u>Intercompany Transactions</u>. Prior to the Commencement Date (and subsequent to the Commencement Date pursuant to Bankruptcy Court approval), the Debtors routinely engaged (and continue to engage) in intercompany transactions with both Debtors and nondebtor subsidiaries and affiliates. The respective intercompany accounts payable are off-set against receivable as of the Reporting Date, if any, and net amounts are reflected in the respective Debtor entity's Schedule and SOFA. Each Debtor reserves all rights with respect to claims against and debts owed to other Debtors.
- 10. Executory Contracts and Unexpired Leases. Counterparties to executory contracts and unexpired leases with the Debtors may have claims that arise upon the rejection of such contract or lease, but such claims are contingent, unliquidated, and disputed at this point. The Debtors have not included potential rejection damage claims on Schedule F.
- 11. Recharacterization. The Debtors have made reasonable efforts to correctly characterize, classify, categorize or designate the claims, assets, executory contracts, unexpired leases and other items reported in the Schedules and SOFAs. Due to the complexity and size of the Debtors' business, however, the Debtors may have improperly characterized, classified, categorized or designated certain items. In addition, certain items reported in the Schedules and SOFAs could be included in more than one category. In those instances, one category has been chosen to avoid duplication. Further, the designation of a category is not meant to be wholly inclusive or descriptive of the rights or obligations represented by such item. For the avoidance of doubt, listing a claim on Schedule D as "secured," on Schedule E as "priority," on Schedule F as "unsecured nonpriority," or listing a contract or lease on Schedule G as "executory" or "unexpired" does not constitute an admission by the Debtors of the legal rights of the claimant, or a waiver of the Debtors' right to seek to recharacterize or reclassify such claim or contract.
- 12. <u>Claim Description</u>. Any failure to designate a claim on the Debtors' Schedules and SOFAs as "contingent," "unliquidated" or "disputed" does not constitute an admission by the Debtors that such claim is not "contingent," "unliquidated" or "disputed." The Debtors reserve all of their rights to dispute, or to assert offsets or defenses to, any claim reflected on the Schedules and SOFAs as to amount, liability, priority, secured or unsecured status, classification or any other grounds or to otherwise subsequently designate any claim as "contingent," "unliquidated" or "disputed." The Debtors reserve all of their rights to amend their Schedules and

SOFAs as necessary and appropriate, including, but not limited to, with respect to claim description and designation.

- 13. <u>Undetermined or Unknown Amounts</u>. The description of an amount as "Undetermined" or "Unknown" is not intended to reflect upon the materiality of such amount. Assets or claims that are in an "Undetermined" or "Unknown" amount are calculated as zero dollars (\$0.00) when preparing totals or summaries notwithstanding the fact that such assets and claims may have a value greater than zero dollars (\$0.00).
- 14. Bankruptcy Court First-Day Orders. The Bankruptcy Court has authorized the Debtors to pay various outstanding prepetition claims, including, but not limited to, payments relating to employee compensation, employee benefits, reimbursable business expenses, certain taxes and to honor certain prepetition customer programs. Where the Schedules list creditors and set forth the Debtors' scheduled amount attributable to such claims, such scheduled amount reflects amounts owed as of the Commencement Date adjusted for any payments made on account of such claims subsequent to the Commencement Date pursuant to the authority granted to the Debtors by the Bankruptcy Court. To the extent payments are made on account of such claims subsequent to the filing of the Schedules, the Debtors reserve all of their rights to deduct such amounts paid from future payments to creditors. The estimate of claims set forth in the Schedules, however, may not reflect assertions by the Debtors' creditors of a right to have such claims paid or reclassified under the Bankruptcy Code or orders of the Bankruptcy Court. In general, only tax claims for items not authorized to be paid by the Bankruptcy Court have been included in the Schedules and SOFAs.
- 15. Contingent Assets and Causes of Action. Despite their reasonable efforts to identify all known assets, the Debtors may not have listed all of their causes of action or potential causes of action against third parties as assets in their Schedules and SOFAs, including, but not limited to, avoidance actions arising under chapter 5 of the Bankruptcy Code and actions under other relevant non-bankruptcy laws to recover assets. The Debtors reserve all of their rights with respect to any claims, causes of action, or avoidance actions they may have, and neither these Global Notes nor the Schedules and SOFAs shall be deemed a waiver of any such claims, causes of actions, or avoidance actions or in any way prejudice or impair the assertion of such claims. The Debtors may also possess contingent and unliquidated claims against affiliated entities (both debtor and nondebtor) for various financial accommodations and similar benefits they have extended from time to time, including, but not limited to, contingent and unliquidated claims for contribution, reimbursement, and/or indemnification arising from various (i) letters of credit, (ii) surety bonds, (iii) guarantees, (iv) indemnities, and (v) tax sharing agreements. Additionally, prior to the Commencement Date, each Debtor, as plaintiff, may have commenced various lawsuits in the ordinary course of its business against third parties seeking monetary damages for business-related losses.

16. Assumptions Used to Prepare Specific Schedules or Answer SOFAs Questions.

- SOFA Questions #1 and #2. All amounts are presented as of the Reporting Date. Other Income, reported on SOFA #2, consists of interest income, gains on sale of assets and income derived by The SCOOTER Store, Inc. from its partnership holdings of two variable interest entities. The SCOOTER Store Holdings Inc.'s Other Income for the financial year 2011 consists of issues of warrants to Sun Capital.
- SOFA Question #3c. Each Debtor has included all payroll distributions and aggregate travel and entertainment expense reimbursement made over the twelve months preceding the Commencement Date to any individual that may be deemed an "Insider" (as defined in the Bankruptcy Code) when the Debtor has either made or been charged for such payments. To the extent that former officers do not qualify as Insiders at the time of the transfer, such benefits and payments are not included in the Schedules and SOFAs. To the extent that such benefits and payments are provided pursuant to a written agreement, such agreement is included in Schedule G. To the extent that a current or former employee is an Insider, such employee received payment pursuant to the terms of his or her employment agreement and/or severance agreement with the Debtor and such payments are listed in the aggregate for current and former employees in response to SOFA 3c. The listing of a party as an Insider in the Schedules and SOFAs, however, is not intended to be, nor shall be, construed as a legal characterization or determination of such party as an actual insider and does not act as an admission of any fact, claim, right or defense, and all such rights, claims, and defenses are hereby expressly reserved.
- SOFA Question #9. Certain payments received by Morgan, Lewis & Bockius LLP may not be for services rendered in the preparation of the bankruptcy filing or for debt counseling.
- SOFA Question #13. Despite not including setoffs in the SOFAs, the Debtors' creditors may have setoffs against a debt or deposit of the applicable Debtor. In such instances, such ordinary course setoffs are excluded from the Debtors' responses to Question 13 of the SOFAs. The Debtors reserve all rights to enforce or challenge, as the case may be, any setoffs that have been or may be asserted.
- SOFA Question #18. The Debtors have listed all businesses in which the Debtors were a partner or owned 5 percent or more of the voting or equity securities. A more complete organizational chart is attached as an exhibit to the *Declaration of Charles Lowrey of The SCOOTER Store Holdings, Inc. in Support of Debtors' Chapter 11 Petition and First Day Motions* (the "First Day Declaration") filed on the Commencement Date [Docket No. 2].
- SOFA Question #19b. The Debtors' auditors, PricewaterhouseCoopers, completed the 2011 audit on February 8, 2013. The Debtors have not engaged an auditor for the financial year 2012.

- SOFA Question #19d. While the Debtors have made every effort to provide a complete list, financial statements may have been provided upon request in the ordinary course of business to various parties including regulatory agencies, financial institutions, shareholders, investment bankers, vendors and attorneys and all such parties are not included in response to SOFA Question #19d.
- Schedule B. Except as otherwise noted, dollar amounts listed on Schedule B are presented as net book value as of the Reporting Date.
- Schedule B2. Cash accounts are presented at bank balance as of the Commencement Date.
- Schedules B13 and B14. The Debtors have listed all businesses in which the Debtors were a partner or hold an equity interest. A more complete organizational chart is attached as an exhibit to the First Day Declaration.
- Schedule B16. Accounts receivable includes Intercompany Receivables, which are accounting allocations performed as part of the Debtors' centralized cash management system and Intercompany Notes Receivable, which are actual promissory notes between the affected Debtor entity.
- Schedules B18 and B21. The Debtors have attempted to list all known liquidated debts and all known contingent and/or unliquidated debts. The Debtors' failure to list any liquidated debt or contingent and/or unliquidated debt (whether known or unknown) on Schedule B shall not be deemed a waiver of the Debtors' rights to collect such amounts, including offsets or defenses to any claim reflected in the Schedules as to amount, liability, priority, secured or unsecured status or classification, or to otherwise designate any claim as "disputed," "contingent" or "unliquidated." The failure to identify any setoff shall not be deemed a waiver of any claims, counterclaims or defenses. Nothing set forth herein shall be deemed an admission of liability with respect to any agreement or validity thereof.
- Schedule B22. The Debtors own the rights to certain intellectual property. The Debtors have undertaken reasonable efforts to identify significant and/or material trademarks and copyrights, which are listed on Schedule B22. The failure to list a trademark, copyright or any other intellectual property on Schedule B22 does not constitute an admission by the Debtors that they do not own such trademark, copyright or other intellectual property.
- Schedule B23. Certain of the Debtors own the rights to certain medical provider numbers and supplier billing numbers obtained through active accreditation. Section 302 of the Medicare Modernization Act requires the Secretary of the Department of Health and Human Services to establish and implement quality standards for suppliers of Durable Medical Equipment, Prosthetics, Orthotics, and Supplies. All suppliers that furnish Durable Medical Equipment, prosthetic device, prosthetic, or

orthotic items or services must comply with the quality standards in order to receive Medicare Part B payments and to retain a supplier billing number. To demonstrate their adherence to these quality standards, DME suppliers (such as the Debtors) must maintain active accreditation with at least one of the 10 agencies deemed by the Center for Medicare and Medicaid Services as accreditation organizations. The SCOOTER Store, Ltd. has maintained its active accreditation through the Accreditation Commission for Health Care, Inc., (ACHC), since 2006.

- Schedule B30. Inventories represent finished goods consisting primarily of power wheelchairs, scooters and related accessories, which are stated at the lower of cost (average cost method) or market and are either held for sale or rental.
- Schedule D. Except as otherwise agreed pursuant to a stipulation or agreed order or general order entered by the Bankruptcy Court, the Debtors reserve their rights to dispute or challenge validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D of any Debtor. Moreover, although the Debtors may have scheduled claims of various creditors as secured claims, the Debtors reserve all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument related to such creditor's claim. The descriptions provided in Schedule D are intended only as a summary. Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in these Global Notes or the Schedules and SOFAs shall be deemed a modification or interpretation of the terms of such agreements.

Finally, certain parties have filed UCC-1 financing statements against the Debtors and have been listed on Schedule D. The Debtors reserve the right to assert, among other things, that they have no obligations to such parties and that the collateral that is the subject of such UCC-1 financing statements is or is not property of one of more of the Debtors and their estates.

• Schedule E. Certain claims listed on the Debtors' Schedule E are claims owing to various taxing authorities to which the Debtors may potentially be liable. The Debtors are unable to determine with certainty the amount of many, if not all, of the claims listed on Schedule E. Therefore, the Debtors have listed all such claim amounts as "Unknown" in amount, pending final tax returns or other outstanding issues. The Debtors reserve the right to dispute any claim asserted by a taxing authority.

By orders of the Court, the Debtors were permitted to pay wages and commissions to employees and honor customer programs. Therefore, to not burden the Court, the Debtors have not included deposits, wage and commission claims that would have existed as of the Commencement Date, but were subsequently paid by the Debtors.

Schedule F. The Debtors have used their best efforts to report all general unsecured claims against each Debtor on Schedule F based upon the Debtors' existing books and records as of the Commencement Date. Schedule F does not include certain deferred charges, deferred liabilities, accruals or general reserves. Such amounts are, however, reflected on the Debtors' books and records as required in accordance with GAAP. Such accruals are general estimates of liabilities and do not represent specific claims as of the Commencement Date and, as such, have not been included on Schedule F.

Schedule F includes Intercompany Payables, which are accounting allocations performed as part of the Debtors' centralized cash management system and Intercompany Notes Payable, which are actual promissory notes between the affected Debtor entity.

The Debtors are performing their obligations as required by law and in accordance with applicable court orders and, as such, workers' compensation claims have not been included on Schedule F.

The scheduled liability with Center for Medicare and Medicaid ("CMS") represents an extended refund agreement based on self-identified overpayments. The current liability listed as \$18,400,000 consists of an agreed upon refund of \$19,500,000 for Year 3 and Year 4 claims pursuant to the Extended Repayment Agreement, decreased by a \$5,000,000 initial repayment on June 6, 2012, as well as \$1,000,000 worth of monthly payments from July 2012 to date. An estimated Year 5 claim amount of \$4,900,000 has been added to the liability although this amount has yet to be agreed on by the Debtors and CMS. The Debtors reserve the right to dispute any claim asserted by CMS.

Schedule G. The Debtors' businesses are complex. While the Debtors' existing records and information systems have been relied upon to identify and schedule each Debtor's executory contracts and every effort has been made to ensure the accuracy of Schedule G, inadvertent errors or omissions may have occurred. The Debtors hereby reserve all of their rights to dispute the validity, status, or enforceability of any contracts, agreements or leases set forth in Schedule G and to amend or supplement such Schedule as necessary. The contracts, agreements and leases listed on Schedule G may have expired or may have been modified, amended, or supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letters, memoranda and other documents, instruments and agreements which may not be listed therein.
