**ORDER AUTHORIZING THE DEBTORS
TO REJECT CERTAIN EXECUTORY CONTRACTS,
NUNC PRO TUNC, EFFECTIVE AS OF APRIL 30, 2014**


Upon consideration of the motion (the "Motion")² of the Debtors for entry of an order authorizing the Debtors to reject executory contracts listed on Schedule 1 attached hereto (collectively, the "Executory Contracts"), *nunc pro tunc*, effective as of April 30, 2014; and it appearing that the relief requested is in the best interests of the Debtors' estates, their creditors, and other parties in interest; and it appearing that this Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that this Motion is a core proceeding pursuant to 28 U.S.C. § 157; and adequate notice of the Motion and opportunity for objection having been given, with no objections or requests for hearing having been filed, or all objections having been overruled, as the case may be; and it appearing that no other notice need be given; and after due deliberation and sufficient cause therefor, it is hereby ORDERED, ADJUDGED, AND DECREED that:

1. The Motion is granted as provided herein.
2. The Executory Contracts identified on Schedule 1 hereto are hereby rejected, *nunc pro tunc*, effective as of April 30, 2014.
3. The Non-Exclusive License and Servicing Agreement (the "Service Agreement") between Simplicity, LLC and Qualution Systems, Inc. ("Qualution") is hereby rejected, *nunc pro tunc*, effective as of April 30, 2014; provided, however, that nothing herein shall affect Qualution's right to assert an administrative claim or claims for amounts under the Service Agreement arising after the Petition Date, including after the effective date of rejection, or the Debtors' defenses or rights to object to such claims.
4. The counterparties to the Executory Contracts shall have until the date fixed by this Court pursuant to Bankruptcy Rule 3003(c)(3) to file any and all claims for damages arising from the rejection of the Executory Contracts.
5. Nothing herein shall prejudice any party's rights to assert that any of the Executory Contracts are not, in fact, executory within the meaning of 11 U.S.C. § 365.
6. The Debtors do not waive any claims they may have against the counterparties to the Executory Contracts, whether or not such claims arise under, are related to the rejection of, or are independent of the Executory Contracts.
7. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.
8. The Debtors are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Motion.
9. This Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
