CERTIFICATION OF MICHAEL J. PAQUE WITH RESPECT TO THE TABULATION OF VOTES ON THE DEBTORS' FIRST AMENDED JOINT PLAN OF LIQUIDATION PURSUANT TO CHAPTER 11 OF THE BANKRUPTCY CODE

I, Michael J. Paque, depose and say under penalty of perjury:

- 1. I am a Director, employed by Kurtzman Carson Consultants LLC ("KCC"), the administrative agent retained by Signal International, Inc. et al. (collectively, the "Debtors") to assist with the solicitation and voting process in the above-captioned Chapter 11 cases, pursuant to the Order Authorizing and Approving the Employment and Retention of Kurtzman Carson Consultants LLC as Administrative Advisor for the Debtors, Effective as of the Petition Date [Docket No. 209]. My business address is 1290 Avenue of the Americas, 9th Fl, New York, NY 10104. I am over the age of 18 and not a party to this action.
- 2. On October 8, 2015, the Court entered the Order (A) Approving the Disclosure Statement; (B) Approving Form and Manner of Notice of Confirmation Hearing; (C) Approving Procedures for the Solicitation and Tabulation of Votes to Accept or Reject the Plan; (D) Estimating Each Litigation Claim at \$1.00 for Voting Purposes; (E) Approving Notice and Objection Procedures in Respect Thereof; and (F) Granting Related Relief [Docket No. 384] (the "Solicitation Procedures Order") establishing, among other things, certain solicitation and voting tabulation procedures.

The Debtors in these chapter 11 cases, along with the last four digits of each Debtor's federal tax identification number, are: Signal International, Inc. (4248); Signal Ship Repair, LLC (2642); Signal International, LLC (5074); Signal International Texas GP, LLC (3050); and Signal International Texas, L.P. (5066). The Debtors' principal offices are located at RSA Battle House Tower, 11 North Water Street, Mobile, Alabama 36602.



- 3. KCC worked with the Debtors and their counsel to solicit votes to accept or reject the **Debtors' First Amended Joint Plan of Liquidation Pursuant to Chapter 11 of the Bankruptcy Code** [Docket No. 386] (the "Plan") and to tabulate the ballots of creditors voting to accept or reject the Plan. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge. I am authorized to submit this Certification on behalf of KCC.
- 4. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans.

A. Service and Transmittal of Solicitation Packages and Related Information

- 5. On October 14, 2015, KCC caused to be served Solicitation Packages (as defined in the Solicitation Procedures Order²) on all known members of Class IV Litigation Claims and Class V General Unsecured Claims in accordance with the Solicitation Procedures Order. An affidavit evidencing the service of the foregoing was filed with the Court on October 30, 2015 [Docket No. 437].
- 6. In addition, in compliance with the Solicitation Procedures Order, copies of the Solicitation Procedures Order, the Disclosure Statement for Debtors' First Amended Joint Plan of Liquidation [Docket No. 287, 380] (the "Disclosure Statement") and the Plan have been available on the case website, free of charge, at www.kccllc.net/signal.

B. The Tabulation Process

7. The Solicitation Procedures Order established October 8, 2015 as the record date for determining which creditors were entitled to receive Solicitation Packages and, where applicable, vote on the Plan. Pursuant to the Solicitation Procedures Order, holders of claims in

Class IV Litigation Claims and Class V General Unsecured Claims were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.

- 8. Pursuant to the Solicitation Procedures Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the claims information pertaining to the Debtors' Chapter 11 Cases as reflected in KCC's systems in order to identify the holders of claims entitled to vote to accept or reject the Plan.
- 9. Using the information outlined above, and with specific guidance and approval from Debtors' counsel, KCC created a voting database reflecting the names of holders in the Voting Classes, addresses of such holders, voting amounts and classification of Claims in the Voting Classes.
- 10. Using its KCC CaseView voting database ("KCC CaseView"), KCC generated ballots for holders of Claims entitled to vote to accept or reject the Plan. The Solicitation Procedures Order established November 12, 2015 at 4:00 p.m. (prevailing Eastern Time) as the deadline for receiving ballots to accept or reject the Plan (the "Voting Deadline").
- 11. Pursuant to the Solicitation Procedures Order, KCC received and tabulated ballots as follows: (a) each returned ballot was opened and inspected at KCC's offices; (b) ballots were date-stamped and scanned into KCC CaseView; and (c) all ballots received on or before the Voting Deadline were then entered into KCC CaseView and tabulated in accordance with the tabulation rules outlined in the Solicitation Procedures Order. Furthermore, under direction from counsel, KCC has tabulated the votes on a not substantively consolidated basis pursuant to Section 4.C of the Disclosure Statement and Plan.
- 12. The final Ballot Report containing the consolidated and unconsolidated summary Ballot Reports of the Voting Classes is annexed hereto as Exhibit A-1³. The detailed Ballot

C. The Unacceptable Ballots

13. Attached as <u>Exhibit D</u> to this Certification is a detailed report of any ballots that were not included in the tabulation above because they did not satisfy the requirements for a valid ballot as set forth in the Solicitation Procedures Order.

Conclusion

14. To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission and tabulation of ballots in connection with the Plan is true. The ballots received by KCC are stored at KCC's office and are available for inspection by or submission to this Court.
