**ORDER GRANTING MOTION PURSUANT TO SECTION 363 FOR AUTHORITY TO  
SELL REAL PROPERTY FREE AND CLEAR OF LIENS**  
(Collateral of InterBank)

There comes on for consideration the Debtor's Motion Pursuant to Section 363 for Authority to Sell Real Property Free and Clear of Liens (Collateral of InterBank) (the "Motion") [Doc #183] filed on November 16, 2012. Based on representations of Counsel for the Debtor, the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157(b)(2)(A) and (O) and 1334, that adequate, due and proper notice of the Motion was served on all parties in interest pursuant to Fed. R. Bankr. P. 6004, and the last date for filing objections was December 10, 2012, which has passed with no objections thereto being served and filed, and that the Motion pursuant to 11 U.S.C. § 363 to sell the property, according to the terms sets forth in the Motion, should be granted. Based on the representation and approval of Counsel reflected by the approvals below, the Debtor and the secured

creditor, InterBank have approved this order.
