Management has made every reasonable effort to ensure that the Monthly Operating Reports are accurate and complete based on the information that was available to them at the time of their preparation, subsequent information may result in material changes to this information, and inadvertent errors or omissions may exist. Monthly Operating Reports do not purport to represent financial statements prepared in accordance with GAAP and do not necessarily reflect the amounts that would be set forth in financial statements prepared in accordance with GAAP.
4. Due to the voluminous nature of the Debtors' Bank Statements for this period, copies of the Debtors' Bank Statements have not been filed with this MOR, however, hard copies of such statements have been provided by the Debtors to the Office of the United States Trustee and the Official Committee of Unsecured Creditors.
