General Notes

The Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "Statements" and, collectively with the Schedules, the "Bankruptcy Materials") of Schutt Sports, Inc. ("Schutt Sports") and its affiliated debtors in the abovecaptioned, jointly administered chapter 11 cases (collectively, the "Debtors") prepared pursuant to 11 U.S.C. § 521 and Rule 1007 of the Federal Rules of Bankruptcy Procedure by management of the Debtors and are unaudited. While the Debtors' management has made reasonable efforts to ensure that the Bankruptcy Materials are accurate and complete, based upon information that was available to them at the time of preparation, subsequent information may result in material changes to the Bankruptcy Materials. Moreover, because the Bankruptcy Materials contain unaudited information which is subject to further review and potential adjustment, there can be no assurance that these Bankruptcy Materials are complete. The Debtors reserve all rights to amend the Bankruptcy Materials from time to time, in all respects, as may be necessary or appropriate, including, but not limited to, the right to dispute or otherwise assert offsets or defenses to any claim reflected on the Bankruptcy Materials as to amount, liability or classification, or to otherwise subsequently designate any claim as "disputed," "contingent" or "unliquidated." Furthermore, nothing contained in the Bankruptcy Materials shall constitute a waiver of rights with respect to these Chapter 11 cases and specifically with respect to any issues involving substantive consolidation, equitable subordination or causes of action arising under the provisions of Chapter 5 of the Bankruptcy Code and other relevant non-bankruptcy laws to recover assets or avoid transfers. These Global Notes Regarding Debtors' Bankruptcy Materials ("Global Notes") comprise an integral part of the Bankruptcy Materials and should be referred to and considered in connection with any review of the Bankruptcy Materials.

Amendment. While reasonable efforts have been made to file complete and accurate Bankruptcy Materials, inadvertent errors or omissions may exist. The Debtor reserves all rights to amend and/or supplement its Bankruptcy Materials as is necessary and appropriate.

Joint Administration. Mountain View Investment Company of Illinois (3563), Schutt Sports, Inc. (0521), Schutt Holdings, Inc. (0276), Circle System Group, Inc. (7711), Melas, Inc. (9761), R.D.H. Enterprises, Inc. (2752), and Triangle Sports, Inc. (6936) filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code. Pursuant to order of the Court, the Debtors' chapter 11 cases are being jointly administered pursuant to Bankruptcy Rule 1015(b).

<u>Basis of Presentation.</u> For financial reporting purposes, Schutt Holdings, Inc. and its subsidiaries prepare audited consolidated financial statements annually. Unlike the consolidated financial statements, the Bankruptcy Materials (except as indicated herein) reflect the separate assets and liabilities of each individual Debtor. The Bankruptcy Materials do not purport to represent financial statements prepared in accordance with U.S. Generally Accepted Accounting Principles ("GAAP").

<u>Causes of Action.</u> The Debtors, despite their efforts, may not have listed all of their causes of action against third parties as assets in the Bankruptcy Materials. The Debtors reserve all of their rights with respect to any causes of action they may have and neither these Global Notes nor the Bankruptcy Materials shall be deemed a waiver of any such causes of action.

Claims Description. Any failure to designate a claim on the Debtors' Bankruptcy Materials as "disputed," "contingent," or "unliquidated" does not constitute an admission by the Debtors that such amount is not "disputed," "contingent," or "unliquidated." The Debtors reserve the right to dispute any claim reflected on their Bankruptcy Materials on any grounds, including but not limited to, amount, liability or classification, or to otherwise subsequently amend the Bankruptcy Materials or to designate such claims as "disputed," "contingent," or "unliquidated."

<u>Claims Paid Pursuant to Court Orders</u>. Certain of the Bankruptcy Materials may list creditors and set forth the Debtors' estimate of the claims of creditors as of the Petition Date. The Bankruptcy Court authorized the Debtors to pay various pre-petition claims, including claims of customers, employees, critical vendors and critical service providers. Consequently, certain pre-petition fixed, liquidated and undisputed unsecured claims have been paid as of the date of the filing of the Bankruptcy Materials. Accordingly, the actual unpaid claims of creditors that may be allowed in these cases may differ from the amounts set forth in the Bankruptcy Materials.

<u>Confidentiality.</u> In a limited number of instances within the Bankruptcy Materials, amounts have been left blank or listed as "Redacted." Due to the confidential nature of certain agreements between the Debtors and third parties, the Debtors have deemed it appropriate and necessary to avoid listing such amounts.

<u>Dates.</u> Unless otherwise indicated, all asset and liability information is listed as of September 6, 2010 (the "Petition Date"), except for Schutt Holdings, Inc. whose petition date is September 15, 2010 (the "Holdings Petition Date").

Employee Claims. The Bankruptcy Court entered "first day" orders granting authority to the Debtors to pay prepetition employee wages, salaries, benefits and other obligations in the ordinary course of business. Accordingly, only employee claims against the Debtors for prepetition amounts that have not been paid as of the time that the Bankruptcy Materials were prepared (such as employee litigation claims pending against the Debtors as of the Petition Date) have been included in the Bankruptcy Materials.

<u>Estimates.</u> To close the books and records of the Debtors as of the Petition Date, management was required to make estimates and assumptions that affect the reported amounts of assets and liabilities.

<u>Excluded Assets and Liabilities.</u> The Debtors have excluded certain categories of assets and liabilities from the Bankruptcy Materials including goodwill, pension assets, deferred compensation, accrued salaries, and employee benefit accruals. In addition, immaterial assets and liabilities may also have been excluded.

Inventory is presented without consideration for any potential warehousemen's or mechanics liens.

<u>Foreign Currency.</u> Unless otherwise indicated, all amounts are reflected in U.S. dollars Transactions denominated in foreign currency have been converted to U.S. dollars as of the applicable date of the transaction.

<u>Leases.</u> The Debtors have not included in the Bankruptcy Materials the future obligations of any capital or operating leases. However, assets under a capital lease have been included in the Bankruptcy Materials.

<u>Litigation</u>. Certain litigation reflected as claims against Schutt may relate to any of the other Debtors. The Debtors have made reasonable efforts to accurately record these actions in the Bankruptcy Materials of the Debtor that is the party to the action. In addition, the Debtors have excluded details relating to labor arbitration and grievance claims, and government civil penalty actions. Discrimination charges have been excluded to protect the privacy interests of the charging parties and because the majority of such claims generally will not result in actual litigation. Labor arbitration and grievance claims are omitted to protect the privacy interests of the grieving party. Government civil penalty actions were excluded due to confidentiality and privacy concerns.

<u>Totals.</u> All totals that are included in the Bankruptcy Materials represent totals of all the known amounts included in the tables.

Trade Accounts Receivable and Accounts Payable. Trade Accounts Receivable are presented without consideration for doubtful accounts, any liabilities related to mutual counterparty accounts payable, open or terminated contract liabilities, liquidated damages, setoff rights or collateral held by the Debtors, unless otherwise stated. Likewise, Accounts Payable are shown without open or terminated contracts, liquidated damages, setoff rights or collateral that has been posed on behalf of the counterparty.

<u>Valuation.</u> It would be prohibitively expensive, unduly burdensome and an inefficient use of estate assets for the Debtors to obtain current market valuations of all of their assets. Accordingly, unless otherwise indicated, net book values as of the Petition Date are reflected on the Bankruptcy Materials. For this reason, amounts ultimately realized will vary from net book value, and such variance may be material. In addition, the amounts shown for total liabilities exclude items identified as "unknown" or "undetermined" and, thus, ultimate liabilities may differ materially from those stated in the Bankruptcy Materials.

<u>Workers Compensation.</u> Workers Compensation claims have also been excluded from the Bankruptcy Materials and Statements due to their voluminous nature and by virtue of the fact the Debtors are performing their obligations as required by law and in accordance with the "first day" orders granting authority to the Debtors to pay these obligations in the ordinary course.

<u>Utilities.</u> In the ordinary course of business, the Debtors have entered into numerous agreements, both written and oral, regarding the provision of certain services on month-to-month basis, including electricity, natural gas, water, telephone, and garbage collection. The Debtors do not believe that such contracts constitute executory contracts and thus, said agreements are not listed individually on Schedule G. Nevertheless, the Debtors reserve the right to assert that such agreements constitute executory contracts.

Schedules of Assets and Liabilities - NOTES

Schedule D: Creditors Holding Secured Claims. Except as otherwise agreed pursuant to a stipulation, agreed order or general order entered by the Bankruptcy Court, the Debtors reserve the right to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D of any Debtor. Moreover, although the Debtors may have scheduled claims of various creditors as secured claims, the Debtors reserve all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument (including, without limitation, any intercompany agreement) related to such creditor's claim. In certain instances, a Debtor may be a co-obligor, co-mortgagor or guarantor with respect to scheduled claims of other Debtors, and no claim set forth on Schedule D of any Debtor is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other entities. The descriptions provided in Schedule D are intended only to be a summary. Reference to the applicable loan agreements and related

documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in the Global Notes or the Bankruptcy Materials shall be deemed a modification or interpretation of the terms of such agreements. Except as specifically stated herein, real property lessors, utility companies and other parties which may hold security deposits have not been listed on Schedule D. Certain of the Debtors' agreements listed on Schedule G may be in the nature of conditional sales agreements or secured financing agreements. No attempt has been made to identify such agreements for purposes of Schedule D.

On May 19, 2010, the Debtors established an Irrevocable Standby Letter of Credit (Number 68050240) with Bank of America, NA (issuing bank) for an amount not to exceed \$25,000. The beneficiary is the Hanover Insurance Company and/or Massachusetts Bay Insurance Company, and the agreement expires November 18, 2010.

Schedule E: Creditors Holding Unsecured Priority Claims. While commercially reasonable efforts have been made, determining the date upon which each claim in Schedule E was incurred or arose would be unduly burdensome and cost prohibitive and, therefore, the Debtors do not list a date for each claim listed on Schedule E.

The Debtors reserve the right to assert that any claim listed on Schedule E does not constitute an unsecured priority claim under 11 U.S.C. § 507.

<u>Schedule F: Creditors Holding Unsecured Non-Priority Claims.</u> Schedule F does not include certain deferred charges, deferred liabilities or general reserves. Such amounts are general estimates of liabilities and do not represent specific claims as of the Petition Date; however, they are reflected on the Debtors' books and records as required in accordance with GAAP.

The Bankruptcy Court entered a "first day" order granting authority to honor certain prepetition customer programs. Accordingly, certain debts arising out of customer programs have not been included in the Debtors' Bankruptcy Materials.

The claims listed in Schedule F arose or were incurred on various dates. In certain instances, the date on which a claim arose is an open issue of fact. While commercially reasonable efforts have been made, determining the date upon which each claim in Schedule F was incurred or arose would be unduly burdensome and cost prohibitive and, therefore, the Debtors do not list a date for each claim listed on Schedule F.

Schedule F contains information regarding potential, pending and closed litigation involving the Debtors. In certain instances, the Debtor that is the subject of the litigation is unclear or undetermined. However, to the extent that litigation involving a particular Debtor has been identified, such information is contained in the Schedule for that Debtor.

<u>Schedule G: Executory Contracts.</u> While commercially reasonable efforts have been made to ensure the accuracy of Schedule G regarding executory contracts and unexpired leases, inadvertent errors, omissions or over-inclusions may have occurred. The Debtors

reserve all of their rights to dispute the validity, status or enforceability of any contracts, agreements or leases set forth in Schedule G and to amend or supplement such Schedule as necessary. The contracts, agreements and leases listed on Schedule G may have expired or may have been modified, amended and supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letter and other documents, instruments and agreements which may not be listed therein.

In some cases, the same supplier or provider may have multiple agreements listed in Schedule G. These agreements represent distinct agreements between the applicable Debtor and such supplier or provider.

Certain of the leases and contracts listed on Schedule G may contain certain renewal options, guarantees of payment, options to purchase, rights of first refusal, and other miscellaneous rights. Such rights, powers, duties and obligations are not set forth on Schedule G. In addition, the applicable Debtor may have entered into various other types of agreements in the ordinary course of their business, such as easements, right of way, subordination, nondisturbance and attornment agreements, supplemental agreements, amendments/letter agreements, title agreements and confidentiality agreements. Such documents are also not set forth on Schedule G.

In addition, certain of the agreements listed on Schedule G may be in the nature of conditional sales agreements or secured financings. The Debtors reserve all of their rights to dispute or challenge the characterization of the structure of any transaction, or any document or instrument (including, without limitation, any intercompany agreement) related to a creditor's claims. Finally certain of the executory agreements may not have been memorialized and could be subject to dispute.

Listing a contract or agreement on this schedule does not constitute an admission that such contract or agreement is an executory contract or unexpired lease. Any and all of the Debtors' rights, claims, and causes of action with respect to the contracts and agreements listed on this schedule are hereby reserved and preserved. Similarly, the listing of a contract or lease on this schedule does not constitute admission that such document is not a secured financing.

While every effort has been made to ensure the accuracy of Schedule G, inadvertent errors or omissions may have occurred. The Debtors do not make, and specifically disclaims, and representation or warranty as to the completeness or accuracy of the information set forth herein, or the validity or enforceability of any contracts, agreements or leases listed herein.

The contracts, agreements and leases listed on Schedule G may have expired or been modified, amended or supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letters or other documents, instruments or agreements which may be listed herein. Certain of the real property leases listed on this Schedule G may contain rights of first refusal, rights to lease additional space or other miscellaneous rights. Such rights, powers, duties and obligations are not set forth on this

Schedule G. Certain of the executory agreements may not have been memorialized and could be subject to dispute. Additionally, the Debtors may be party to various other agreements concerning real property, such as easements, rights of way, subordination, non-disturbance and attornment agreements, supplemental agreements, amendments/letter agreements, title documents, consents, site plans, maps or other miscellaneous agreements. Such agreements are not set forth on this Schedule G.

Statements of Financial Affairs - NOTES

<u>SOFA 3b: Payments to Creditors.</u> Payments made are listed by the entity making such payment notwithstanding that certain payments may have been made on behalf of another entity.

SOFA 9: Payments Related to Debt Counseling or Bankruptcy. All payments relating to bankruptcy professionals have been made by Schutt Sports (Case No. 10-12795). In the ordinary course of business, Schutt Sports makes payments on behalf of other Debtors through a disbursement account. See response for question 9 of the Statements of Financial Affairs for Schutt Sports for more information regarding payments to bankruptcy professionals on behalf of all filing Debtor entities.

SOFA 23: Distributions by a Corporation. Many of the items required to be disclosed in SOFA 23 are duplicative with SOFA 3c, therefore only to the extent there are items that are not listed in SOFA 3c will they be included on SOFA 23.

Debtor Specific Notes: Schedules of Assets and Liabilities - NOTES

Schedule B.23: Licenses, Franchises, and Other General Intangibles. The items listed by Schutt Sports in Schedule B.23 are not carried as assets in the Debtor's books and records, and therefore the Debtor has not estimated their value. The Debtor hereby reserves all of its rights to dispute the validity, status or enforceability of any contract or other agreement set forth on Schedules B.23.

Schedule B.24: Customer Lists. Schutt Sports and Circle System Group, Inc. have compiled certain customer lists and related customer information. This information is confidential and has not been included on Schedule B, the omission of such information should not be deemed a conclusion that such information has no value.

Schedule E: Creditors Holding Unsecured Priority Claims. With respect to Schutt Sports, Circle System Group, Inc. and Melas, Inc., some of the claims listed on the Debtors' Schedule E are claims owing to various taxing authorities to which the Debtors may potentially be liable. However, certain of such claims may be subject to on-going audits and the Debtors are otherwise unable to determine with certainty the amount of many, if not all, of the claims listed on Schedule E. Therefore, the Debtors have listed all such claims as unknown in amount, pending final resolution of on-going audits or other outstanding issues. The Debtors reserve their right to dispute or challenge whether such claims are entitled to priority.

Schutt Sports has agreements with individuals who work with Schutt as independent sales representatives ("Independent Sales Representatives"). The Independent Sales Representatives receive commissions based on their sales. Schutt withholds 10% of the Independent Sales Representatives' commissions during the calendar year until January of the following calendar year when Schutt will make a true up of their accounts. Pursuant to the first day orders, the Debtors were granted authority to pay such amounts in the ordinary course of business, consistent with their business practices. These amounts will become owing in January following the true up. Since the sales earned by the Independent Sales Representatives comprise more than 75% of the Schutt's sales, the commissions withheld are treated as unsecured priority claims under 11 U.S.C. § 507.

Employees of Schutt Sports and Circle System Group, Inc. received paid personal time off ("PTO Days") based on their length of service. The Bankruptcy Court entered "first day" orders granting authority to the Debtors to continue to honor their PTO days policies in the ordinary course of business to honor all prepetition obligations related thereto. Accrued, unused paid time off is paid out only upon separation from the Debtors. The claims listed in Schedule E represent the accrued PTO Days as at the date of filing and have not been adjusted for any PTO Days used since filing. To the extent any employees have separated from the Debtors and been paid their accrued PTO Days as at the time that the Bankruptcy Materials were prepared, the claim has been adjusted.

Statements of Financial Affairs - NOTES

<u>SOFA 1a: Income from Operation of Business.</u> The income reported by Schutt Sports, and Circle System Group, Inc. represents gross revenue including intercompany sales.

<u>SOFA 3b: Payments to Creditors.</u> The Schutt Sports and Circle System Group, Inc. use a third party payroll administrator, Jocor Enterprise, to process payroll and related withholding payments. Where applicable, SOFA 3b includes payments to Jocor Enterprise, not the individual employees or taxing authorities.

<u>SOFA 7: Gifts.</u> On occasion, Schutt Sports and Circle System Group, Inc. will donate helmets and other sports equipment to teams and individuals. The Debtors do not keep track of these non-cash donations and therefore they are not included on SOFA 7.

SOFA 13: Setoffs. The Schutt Sports and Circle System Group, Inc. routinely incur certain setoffs and other similar rights from customers or suppliers in the ordinary course of business. Setoffs in the ordinary course can result from various items, including, but not limited to pricing discrepancies, returns, warranties, and other disputes between the Debtors and their customers and/or suppliers. Although such setoffs and other similar rights may have been accounted for when scheduling certain amounts, setoffs are not independently accounted for, and as such, are excluded from the Bankruptcy Materials.

SOFA 14: Property held for Another Person. On occasion Schutt Sports and Circle System Group, Inc. will hold equipment on behalf of third parties; this equipment does not represent an asset of the Debtors and therefore is not included in Bankruptcy Materials.
