

Spansion LLC

On June 30, 2003, AMD and Fujitsu Limited (“Fujitsu”) organized their Flash memory business as a Delaware limited liability company named FASL LLC, later renamed Spansion LLC, which was 60% owned by AMD and 40% owned by Fujitsu. Since 2003, Spansion LLC has been the principal operating company of the Debtors. It is the parent company of Spansion International, Inc. and all other foreign Spansion entities. Spansion LLC has employees, and conducts businesses that generate revenue. It files its own payroll tax returns. It is included in Spansion Inc’s federal consolidated and California worldwide unitary tax returns.

For the purposes of the Monthly Operating Report filed with the bankruptcy court, Spansion LLC recognizes the operating results of its wholly-owned subsidiaries worldwide based on the equity method of accounting, effective with the April MOR. Prior period balances in the April MOR were adjusted to reflect this treatment.

Spansion Japan Limited (“SPJ”), a wholly-owned subsidiary of Spansion LLC, filed a proceeding under the Corporate Reorganization Law (Kaisha Kosei Ho) of Japan on February 10, 2009, to obtain protection from SPJ’s creditors, and proceedings were formally commenced on March 3, 2009. SPJ is now managed by a trustee appointed by the Japanese court and is subject to the general supervision of the Japanese Court and a court-appointed supervisory attorney (chosa i’in). As a result, effective fiscal March 2009, Spansion LLC no longer “controls” SPJ and, under GAAP, SPJ’s results are no longer consolidated in Spansion Inc.’s consolidated financial results, and have never been reflected in Spansion LLC’s Monthly Operating Reports. Additional adjustments to Spansion LLC’s March results, as a result of further refinements in the deconsolidating entries for SPJ, were also reflected in the prior period balances as reported in Spansion LLC’s April Monthly Operating Report.

Since shortly after filing its chapter 11 petition, Spansion LLC has engaged in on-going discussions with SPJ concerning their existing and future commercial relationship. In particular, Spansion LLC has sought to ensure that the pricing it pays for wafers produced at SPJ’s Aizu wafer fabrication facilities (JV3 and SP1) and for sort services is on market terms. Spansion LLC believes that it reached an understanding with SPJ (the “Understanding”) as to the proposed prices and volumes for wafers produced at JV3 and SP1 and for sort services in 2Q2009 and 3Q2009, which prices and volumes would result in compensation to SPJ approximately equal to its anticipated costs, less depreciation, plus a mark-up. Management of Spansion LLC believes that the pricing agreed to in the Understanding is roughly equal to the market prices for the wafers and services. As part of the Understanding, Spansion LLC believes the parties agreed that the pricing would be retroactive to March 3, 2009. Since reaching the Understanding, actual cash settlements between the two companies for March and April activities (paid in May and June) were consistent with the prices and volumes of the Understanding. However, to date SPJ has not executed the documentation formalizing the Understanding nor obtained approval from the Japanese court for such an agreement.

The attached report and financial statements are based on the pricing that Spansion LLC believe was agreed to in the Understanding. Spansion LLC believes further that such pricing represents the reasonable value of the wafers and services that Spansion LLC is receiving.

SPJ disputes that the Understanding reflects a binding agreement. It further asserts that the pricing for wafers and sort services under the prepetition foundry agreement between Spansion LLC and SPJ continues to apply. In addition, GE Financial Service Corporation has asserted in pleadings that it has filed with the Bankruptcy Court that, among other things, the pricing for wafers and sort services under the prepetition foundry agreement has continued to apply during the pendency of the Debtors' chapter 11 cases. If the pricing under the prepetition foundry agreement were applicable during the term of the attached report, the accounts payable to SPJ and wafer purchases that recorded in cost of goods sold for the period from the petition date to fiscal September 2009 would have been approximately \$180 million higher as compared to that in the attached report, with the amount having been adjusted compared to \$120 million as previously disclosed in September monthly operating reports. Spansion LLC has retroactively revised its financial statements in this Report to reflect the correct ownership of inventory associated with wafer purchases from SPJ based on shipment of sorted wafers instead of recognizing the ownership after fabrication process of those wafers as reported in the previously monthly operating reports. Due to this change of recognizing the ownership of inventory, Spansion LLC also adjusted its inventory balance on the book. As of fiscal September 2009, the net inventory balance would have been \$24 million lower (decrease of \$60 million in gross inventory offset by \$36 million reduction in inventory reserve associated with those wafers), thus \$24 million higher in cost of goods sold as compared to that reported in the September monthly operating reports.

Spansion LLC reserves all of its rights, claims, remedies, defenses and arguments with respect to the pricing of wafers and sort services, including, without limitation, in connection with the Motion of GE Financial Services Corporation (F/K/A GE Capital Leasing Corporation) for Allowance and Payment of Administrative Expense Claim [D.I. 1213] or in the event that SPJ or any other person or entity formally challenges the validity or enforceability of the Understanding or files any motion or takes any other action seeking to enforce pricing for the wafers and services on terms other than those of the Understanding, including the terms of the prepetition foundry agreement or any other prepetition agreement between Spansion LLC and SPJ. Nothing contained herein shall constitute a waiver or release of any such rights, claims, remedies, defenses and arguments. Moreover, in the event that the Understanding is deemed to be unenforceable or invalid for any reason, Spansion LLC reserves the right to assert under 11 U.S.C. § 503(a)(1)(A), or otherwise, that it is obligated to pay only the market price for wafers and services provided by SPJ after the commencement of Spansion LLC's chapter 11 case rather than the price set forth in the prepetition foundry agreement or any other prepetition agreement or understanding (regardless of whether any such agreement or understanding has or has not been rejected as of the date thereof).
