# **EMERGENCY MOTION TO APPROVE SALE OF CONDOMINUM UNIT**

COMES NOW Magnify Industries, LLC ("Magnify"), a party in interest which is the owner of certain condominiums in Emerald Beach Resort and requests the Court enter an Order approving the sale of Unit 632 and in support says as follows:

1. At the hearing on May 22, 2017 the Court directed that all prospective sales of condominium units owned by Magnify should be presented to the Court for consideration and approval.

2. On May 20, 2017 Magnify received from its listing agent, Mark Cowart of Counts Real Estate Group the attached offer (Exhibit "A") to purchase Unit 632

3. The offer is a proposed contract for the one bedroom, one bath unit which is 792 square feet for \$168,000.00.

4. The offer has only a financing contingency and is to be closed by June 21, 2017.

5. The purchaser has no connection to or relationship with the Debtor or Magnify.

6. Mr. Cowart is an experienced realtor in the Panama City, Florida real estate market who is familiar with unit 632.

7. As set out in the affidavit attached as Exhibit "B", he believes that the proposed purchase price for the unit represents its fair market value.

8. The proposed price represents \$212 per square foot, which is within the

parameters of testimony previously offered to the Court as a reasonable price for condominiums in the Emerald Beach Resort.

9. The net cash after paying the amounts required for closing will be placed in the escrow account at Engel, Hairston & Johanson P.C.

The agent has advised that the offer was tendered for acceptance on Monday, May
 22, 2017. He has obtained an extension but if not accepted by tomorrow, Magnify will likely
 lose the sale.

Marketable title shall 371 be determined according to applicable Title Standards adopted by authority of The Florida Bar and in accordance 372 with law. 373

If Buyer timely delivers such notice and Survey to Seller, such matters identified in the notice and Survey shall constitute a title defect, subject to cure obligations of STANDARD A above. If Seller has delivered a 396 prior survey, Seller shall, at Buyer's request, execute an affidavit of "no change" to the Real Property since the 397 398 preparation of such prior survey, to the extent the affirmations therein are true and correct.

399 C. INGRESS AND EGRESS: Seller represents that there is ingress and egress to the Real Property and title to the Real Property is insurable in accordance with STANDARD A without exception for lack of legal right of access. 400 D. LEASE INFORMATION: Seller shall, at least 10 days prior to Closing, furnish to Buyer estoppel letters from 401 tenant(s)/occupant(s) specifying nature and duration of occupancy, rental rates, advanced rent and security 402 403 deposits paid by tenant(s) or occupant(s)("Estoppel Letter(s)"). If Seller is unable to obtain such Estoppel Letter(s) the same information shall be furnished by Seller to Buyer within that time period in the form of a Seller's affidavit 404 and Buyer may thereafter contact tenant(s) or occupant(s) to confirm such information. If Estoppel Letter(s) or 405 Seller's affidavit, if any, differ materially from Seller's representations and lease(s) provided pursuant to Paragraph 406 407 6, or if tenant(s)/occupant(s) fail or refuse to confirm Seller's affidavit, Buyer may deliver written notice to Seller within 5 days after receipt of such information, but no later than 5 days prior to Closing Date, terminating this 408 Contract and receive a refund of the Deposit, thereby releasing Buyer and Seller from all further obligations under 409 this Contract. Seller shall, at Closing, deliver and assign all leases to Buyer who shall assume Seller's obligations 410 thereunder. 411

E. LIENS: Seller shall furnish to Buyer at Closing an affidavit attesting (i) to the absence of any financing 412 statement, claims of lien or potential lienors known to Seller and (ii) that there have been no improvements or 413 repairs to the Real Property for 90 days immediately preceding Closing Date.
