ORDER GRANTING TRUSTEE'S FIRST AMENDED EXPEDITED MOTION PURSUANT TO SECTIONS 105, 363 AND 365 OF THE BANKRUPTCY CODE AND BANKRUPTCY RULES 2004, 6004 AND 6006, FOR AN ORDER (A) APPROVING SALE AND AUCTION PROCEDURES IN CONNECTION WITH SALE OF CERTAIN ASSETS; (B) SCHEDULING A HEARING ON THE AUCTION PROCEDURES; (C) AUTHORIZING THE SALE OF CERTAIN ASSETS FREE AND CLEAR OF LIENS, CLAIMS, ENCUMBRANCES AND OTHER INTERESTS;

AND (D) GRANTING RELATED RELIEF

Upon consideration of the Chapter 11 Trustee (the "Trustee's") First Amended Expedited Motion Pursuant to Sections 105, 363 and 365 of the Bankruptcy Code and Bankruptcy Rules 2002, 6004 and 6006, for an Order (A) Approving Sale and Auction Procedures in Connection with Sale of Certain Assets; (B) Scheduling a Hearing on the Auction Procedures; (C) Authorizing the Sale of Certain Assets Free and Clear of Liens, Claims, Encumbrances and Other Interests; and (D) Granting Related Relief ("the Amended Auction Motion") [Doc.#418 and #451, collectively]¹; and the Auction Motion having been served by regular mail upon Debtor's Counsel, all listed creditors of the Debtor, including the United States Bankruptcy Administrator, and the Court having considered all objections to the Auction Motion; and this Court having considered the relief sought in the Auction Motion and having found that the legal and factual basis set for establish good cause to grant the relief requested, it is hereby

ORDERED, ADJUDGED and DECREED THAT:

1. The Amended Auction Motion be, and hereby is, granted on the terms and

conditions set forth therein;

2. The Trustee is authorized and directed to conduct an auction, for the Old Car

Heaven Vehicle Collection (as set forth on **Exhibit "A"** which is attached and incorporated by

reference for all purposes), through the assistance and direction of Tom Mack Auctions on

December 2, 2017 at the Old Car Heaven facility in Birmingham, Alabama (the "Auction"). The

Auctioneer's compensation shall be limited to twelve percent (12%) of the actual bid price which

does not include the ten percent (10%) buyer's premium the Auctioneer is entitled to charge

buyers, but not the Trustee or bankruptcy Estate;

3. On the day of the Auction, each unit in the Old Car Heaven Vehicle Collection shall

be sold and transferred free and clear of all liens, pledges, claims, security interests, encumbrances

and interests of any kind with all such liens, pledges, claims, security interests, encumbrances and

interests attaching to the proceeds of sale to the same extent and in the same order of priority as

each such interest now attaches to or affects the respective vehicle, subject to this Court's power

to determine the validity, extent and priority of any such liens, pledges, claims, security interests,

encumbrances or other interests;

4. The objections to the Amended Auction Motion asserted by Magnify, LLC

("Magnify"), Torch Holdings, LLC ("Torch"), and Ahrian Dudley ("Ahrian") are all overruled.

The Trustee and counsel for Magnify, Torch Holdings, Ahrian, C. Ray Dudley ("Ray Dudley"),

the children of Mr. and Mrs. Dudley (the "Children"), and all related entities and affiliates shall

cooperate in the process and procedure of transferring each unit of the Old Car Heaven Vehicle

Collection to the Estate for the purpose of effectuating the sale in accordance with 11 U.S.C. §

363. Magnify, Torch, Ahrian, Ray Dudley and the Children reserve all of their rights regarding

all net proceeds resulting from the Auction, and it is made without waiver as to any and all existing

rights, legal arguments and defenses each may have, including those related to Adversary

Proceeding 17-00052 pending with this Court and the ultimate distribution of the Auction

proceeds;

5. All net proceeds of the Auction shall be held by the attorney for the Trustee, in his

trust account, pending further order of this Court;

6. There are sound business reasons for the Trustee, pursuant to Section 363(b) of the

Bankruptcy Code, to effectuate the transactions described in the Amended Auction Motion and

the sale of the Old Car Heaven Vehicle Collection. Further, the Trustee is acting in accordance

with the provisions of Section 363(b) and (f) of the Bankruptcy Code. The Auction is a

commercially reasonable method to liquidate the Old Car Heaven Vehicle Collection given the

facts of this case, the pending Chapter 11 proceeding and its current posture, the evidence

presented; and the argument of counsel;

7. A Purchaser shall not be deemed to be a successor to or of the Debtor (or any of

Magnify, Torch, Ahrian, Ray Dudley, and/or the Children) as a result of the acquisition of a vehicle

pursuant to the terms of the Amended Auction Motion and this Order;

8. Each and every federal, state, and local governmental agency or department

(including without limitation, state departments of motor vehicles or departments of public safety)

shall be, and hereby is, directed to accept this Order and any and all documents and instruments

necessary and appropriate to consummate the transaction contemplated by the Amended Auction

Motion, including, without limitation, documents and instruments for recording in any governmental agency or department required to transfer to the Purchaser the names and any and all other licenses or permits necessary for the operation that is associated with any unit within the

Old Car Heaven Vehicle Collection;

9. The terms and provisions of the Amended Auction Motion and this Order shall be

binding in all respects upon, and shall inure to the benefit of the Purchaser, the Debtor, his family

and/or related entities or affiliates, the Debtor's estate, and their successors and assigns, including

any trustee that may be appointed in this case or any superseding case under Chapter 7 of the

Bankruptcy Code;

10. The Trustee, Debtor, Magnify, Torch, Ahrian, Ray Dudley, the Children, and the

Purchaser are authorized and directed to take the necessary actions to consummate the transactions

contemplated by the Amended Auction Motion and execute all documents and instruments of

assignment, transfer and sale that are necessary and appropriate to implement the Amended

Auction Motion and this Order:

11. Not later than 12:00 noon (local prevailing time), on December 8, 2017 the Trustee

shall file with the Court a pleading that shall include, without limitation, the following:

(i) A report of sale describing the outcome of the Auction, including the

purchase price for each vehicle;

(ii) A list of all bidders qualified by the Auctioneer;

(iii) A detailed description of the advertising and marketing actually performed

by the Auctioneer (or its designee) prior to the Auction and the amount of money spent on all

marketing and advertising;

(iv) A request that the sale was conducted in a commercially reasonable manner,

without collusion, and that the Trustee, Auctioneer and/or each purchaser acted in "good faith" as

contemplated by 11 U.S.C. § 363(m); and

(v) A request for all other necessary and appropriate relief.

12. The Sale Hearing to consider ratification of the Auction results is scheduled for

Monday, December 11, 2017 at 10:00 a.m. (local prevailing time);

13. This Court shall retain jurisdiction to determine any claims, disputes or causes of

action arising out of or relating to the Auction, the Old Car Heaven Vehicle Collection or any of

the transactions contemplated under the Amended Auction Motion and/or this Order;

14. Notice of the Amended Auction Motion and all hearings scheduled thereon

constituted good and sufficient notice of the sale proposed in the Amended Auction Motion to all

parties entitled to such notice.
