The Debtors are authorized to operate their businesses and manage their affairs as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. The Debtors' chapter 11 cases are being jointly administered for procedural purposes pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>") and Rule 1015-1 of the Local Rules of Bankruptcy Practice and Procedure for the United States Bankruptcy Court for the District of Delaware.

The Debtors' respective Schedules of Assets and Liabilities, Schedules of Current Income and Expenditure, and Schedules of Executory Contracts and Unexpired Leases (the "<u>Schedules</u>") and Statements of Financial Affairs (the "<u>Statements</u>" and together with the Schedules, the "<u>Schedules and Statements</u>") have been prepared by the Debtors' management with the assistance of their bankruptcy counsel and financial advisors pursuant to section 521 of the Bankruptcy Code and Bankruptcy Rule 1007.

1. Reservation of Rights. The Schedules and Statements are unaudited and subject to further review and potential adjustment. The Debtors have made reasonable efforts to ensure the accuracy and completeness of such financial information, however, subsequent information or discovery may result in change to the Schedules and Statements and inadvertent errors, omissions or inaccuracies may exist. The Debtors reserve all of their rights to amend or supplement their Schedules and Statements.

Nothing contained in the Schedules and Statements or these Global Notes shall constitute an admission or a waiver of any of the Debtors' rights to assert claims or defenses.

<u>2. "As of" Information Date.</u> Unless otherwise indicated, all amounts listed in the Schedules and Statements are as of the close of business on December 18, 2012, the date prior to the Petition Date.

Pursuant to certain orders of the Bankruptcy Court (the "<u>Court Orders</u>"), the Debtors were authorized to, and did, conduct sales of certain of their assets, assume and/or assign certain of their unexpired executory contracts or leases, and pay certain outstanding prepetition claims after the Petition Date. In addition, pursuant to certain Court Orders, certain outstanding prepetition claims against the Debtors may have been paid by non-Debtor third parties following the Petition Date. Therefore, certain claims may be net of payments made following the Petition Date. Nothing herein shall be deemed to alter the rights of any party in interest to contest a payment made pursuant to a Court Order that preserves such right to contest.

<u>3. Basis of Preparation</u>. For purposes of filing reports with the Securities and Exchange Commission, the Debtors have historically prepared consolidated financial statements and in accordance with generally accepted accounting principles ("<u>GAAP</u>").
