#### GLOBAL NOTES TO DEBTOR'S SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENTS OF FINANCIAL AFFAIRS

Katie Goodman, as Chapter 11 Trustee (the "Trustee") of the above-captioned debtor ("Trendset" or the "Debtor"), hereby submits the Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "SOFAs") of the Debtor pursuant to 11 U.S.C. § 521, Rule 1007 of the Federal Rules of Bankruptcy Procedure.

- 1. These global notes (the "Global Notes") regarding the Debtor's Schedules and SOFAs comprise an integral part of the Schedules and SOFAs filed on behalf of the Debtor, and should be referenced in connection with any review of the Schedules and SOFAs.
- The Schedules and SOFAs prepared by the Trustee for the Debtor are 2. unaudited, and were prepared with data available as near as possible to April 15, 2013, the date of commencement of the Debtor's chapter 11 case (the "Petition Date"). Although the Trustee made every reasonable effort to ensure that the Schedules and SOFAs are accurate and complete based on information that was available at the time of preparation, inadvertent errors or omissions may exist, and subsequent information or discovery may result in material changes to the Schedules and SOFAs, including, but not limited to, the discovery of prepetition invoices that were not available (or that the Debtor had not yet received) at the time the Schedules and SOFAs were prepared. Accordingly, the Schedules and SOFAs remain subject to further review and verification by the Trustee, and the Trustee reserves the right to amend the Schedules and SOFAs from timeto-time as may be necessary or appropriate. Nothing contained in the Schedules and SOFAs shall constitute, or be deemed, a waiver of any rights, claims or defenses of the Debtor or the Trustee against any third party, or with respect to any aspect of this chapter 11 case or any related litigation or arbitration. Except as otherwise agreed pursuant to a stipulation, agreed order, or general order entered by the Bankruptcy Court, nothing contained in the Schedules and SOFAs is intended or should be construed as an admission or stipulation of the validity of any claim against the Debtor, or as a waiver of the Trustee's or the Debtor's rights to dispute any claim or assert any cause of action or

defense against any party, and the Trustee reserves all rights to dispute or challenge the characterization of the structure of any transaction or any document or instrument related to a creditor's claim.

- 3. The Schedules and SOFAs do not purport to represent financial statements prepared in accordance with U.S. Generally Accepted Accounting Principles. The preparation of the Schedules and SOFAs required the Trustee to make estimates and assumptions with respect to the reported amounts of assets and liabilities, the amount of contingent assets and contingent liabilities, and the reported amounts of any revenues and expenses during the applicable reporting periods. Actual results could differ from the estimates.
- 4. Any failure to designate a claim on the Debtor's Schedules and/or SOFAs as "disputed," "contingent" or "unliquidated" does not constitute an admission that such claim is "undisputed," "non-contingent" or "liquidated." The Trustee reserves the right to dispute, or to assert offsets or defenses to, any claim reflected on the Debtor's Schedules and SOFAs as to amount, liability, priority, secured or unsecured status, or classification, or to otherwise designate any claim as "disputed," "contingent" or "unliquidated" by filing and serving an appropriate amendment. The Trustee reserves the right to amend the Debtor's Schedules and/or SOFAs as necessary and/or appropriate.
- 5. It would be prohibitively expensive, unduly burdensome, and an inefficient use of estate assets for the Trustee to obtain current market valuations of all of the Debtor's assets. Accordingly, unless otherwise indicated, net book values as of the Petition Date are reflected on the Schedules and SOFAs. For this reason, amounts ultimately realized may vary from net book value, and such variances may be material. In addition, the amounts shown for total liabilities exclude any items identified as "unknown" or "undetermined" and, thus, ultimate liabilities may differ materially from those stated in the Schedules and SOFAs. The Trustee reserves the right to amend or adjust the value of any asset or liability set forth in the Schedules and SOFAs.
- 6. Despite reasonable efforts, the Trustee may not have identified and/or set forth all causes of action or defenses against third parties in the Debtor's Schedules and SOFAs. The Trustee reserves any and all rights with respect to any causes of action or defenses the Trustee or Debtor may have, and neither these Global Notes nor the Schedules and SOFAs shall be deemed a waiver of any such causes of action, nor may they be used in any litigation in this, or related to this, chapter 11 case.
- 7. Information requested by the Schedules and SOFAs requires the Trustee to make judgments regarding the appropriate category in which information should be presented or how certain parties, claims or other data should be labeled. The Trustee's decisions regarding the category or label to use is based on the best information available as of the filing of these Schedules and SOFAs within the time constraints imposed by the Bankruptcy Code, Bankruptcy Rules and orders of the Bankruptcy Court. The Trustee may have excluded certain immaterial or unknown assets and liabilities. The Trustee reserves the right to modify, change or delete any information in the Schedules and

SOFAs by amendment, including to the extent some information currently presented should be moved to a different category or labeled in a different way.

- 8. These Global Notes are in addition to any specific notes set forth in the Schedules, SOFAs and/or herein. The fact that the Trustee may have prepared a specific note with respect to any of the Schedules and SOFAs and not to others should not be interpreted in any way, and specifically should not be interpreted as a decision by the Trustee to exclude the applicability of any Global Note to any of the Debtor's Schedules and SOFAs.
- 9. To the best of the Trustee's knowledge, the Debtor did not prepare formal financial statements or maintain an accurate accounting system. The information presented in the SOFA's and Schedules is on a best efforts basis given the time constraints imposed by the Bankruptcy Code, Bankruptcy Rules and orders of the Bankruptcy Court.
- 10. All totals that are included in the Schedules and SOFAs represent totals of the liquidated amounts for the individual schedule and/or SOFA entry for which they are listed. To the extent there are unknown or undetermined amounts, the actual total may be materially different than the listed total. The description of an amount as "unknown," "TBD," or "undetermined" is not intended to reflect upon the materiality of such amount.
- 11. Potential deferred and/or unaccrued taxes have not been included in the Schedules and SOFAs to the extent the Trustee did not have sufficient information to include at the time of preparation of the Schedules and SOFAs.
- Although the Trustee may have scheduled claims of various creditors as 12. secured claims on Schedule D, except as otherwise agreed pursuant to a stipulation, agreed order, or general order entered by the Bankruptcy Court, the Trustee reserves the right to dispute or challenge the secured nature or the validity of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument related to such creditor's claim. The descriptions provided in Schedule D are intended only to be a summary. Without limiting the foregoing, the inclusion on Schedule D of creditors that have asserted liens of any nature is not intended to be an acknowledgement of the validity, extent, or priority of any such liens, and the Trustee reserves her rights to challenge such liens and the underlying claims on any ground whatsoever, except as otherwise agreed pursuant to a stipulation, agreed order, or general order entered by the Bankruptcy Court. Reference to the applicable agreements and other related relevant documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in the Global Notes or the Schedules and SOFAs shall be deemed a modification or interpretation of the terms of any such agreements.
- 13. The Trustee reserves the right to dispute or challenge whether creditors listed on Schedule E are entitled to priority claims. Schedule E does not include priority employee claims that were paid pursuant to the Order Granting Debtor's Motion

Authorizing Debtor To Pay Certain Pre-Petition Wage And Employee Benefit Claims [Docket Entry No. 56] Also, the Trustee has omitted from the responses to SOFA question #3b payments made to employees within 90 days of the Petition Date.

- 14. The liabilities identified in Schedule F are derived from the Debtor's books and records. The Trustee has made a commercially reasonable attempt to set forth the Debtor's unsecured obligations, although the actual amount of claims against the Debtor may vary materially from those liabilities represented on Schedule F. The listed liabilities may not reflect the correct amount of any unsecured creditor's allowed claim or the correct amount of all unsecured claims. Parties in interest should not anticipate that the relationship of aggregate asset values and aggregate liabilities set forth in the Schedules and SOFAs will reflect their ultimate recoveries in this case. Parties in interest should consult their own professionals and/or advisors with respect to pursuing a claim. Actual liabilities and assets may deviate materially from the Schedules and SOFAs due to many factors including events that occur throughout the duration of this chapter 11 case and upon the potential discovery of additional information.
- 15. The claims listed on Schedule F arose or were incurred on various dates. In certain instances, the date on which a claim arose may be unknown or subject to dispute. The Trustee does not list a date for each claim listed on Schedule F as such efforts would be unduly burdensome or cost prohibitive.
- 16. In certain instances, the Debtor may be a co-obligor with respect to scheduled claims, and no claim set forth on Schedule F is intended to acknowledge or bind the Debtor or the Trustee to pay or recognize claims of creditors that are otherwise satisfied or discharged by other entities.
- 17. The descriptions provided in Schedule F are intended only to be a summary. Nothing in the Global Notes or the Schedules and SOFAs shall be deemed to be a modification or interpretation of the terms of such agreements. The claims of individual creditors for, among other things, merchandise, goods, or services are listed based on the amounts listed on the Debtor's books and records and may not reflect credits or allowances due from such creditor. The Trustee reserves all of her rights respecting such credits or allowances.
- 18. The dollar amounts listed in Schedule F may be exclusive of contingent and unliquidated amounts. All parties to executory contracts and unexpired leases, including those listed on Schedule G, are holders of contingent and unliquidated unsecured claims arising from (i) obligations under those executory contracts and unexpired leases and/or (ii) rejection damages in the event that any such executory contracts and unexpired leases are rejected. Not all such claims are duplicated on Schedule F.
- 19. The Debtor's business is complex. While commercially reasonable efforts have been made to ensure the accuracy of Schedule G regarding the Debtor's executory contracts and unexpired leases, inadvertent errors, omissions, or over-inclusions may

have occurred. Listing a contract, lease or agreement on Schedule G does not constitute an admission that such contract, lease or agreement is an executory contract or unexpired lease or that such contract, lease or agreement was in effect on the Petition Date or is valid or enforceable. The Trustee reserves all of her rights to dispute the validity, effectiveness, status, or enforceability of any contracts, agreements, or leases set forth in Schedule G (including, but not limited to, whether any lease is a true lease or financing arrangement) and to amend or supplement Schedule G as necessary.

- 20. The contracts, agreements, and leases listed on Schedule G may have expired or may have been modified, amended, and supplemented from time to time by various amendments, restatement, waivers, estoppel certificates, letter and other documents, instruments, and agreements which may not be listed therein. Where the Debtor may be party to an agreement that has expired by its terms, but where all parties thereto continue to operate under the agreement, out of an abundance of caution the Trustee may have listed such agreement on Schedule G. The inclusion of such contracts or agreements on Schedule G is not an admission that any such contract or agreement is an executory contract or unexpired lease.
- 21. Certain of the leases and contracts listed on Schedule G may contain certain renewal options, guarantees of payment, options to purchase, rights of first refusal, and other miscellaneous rights. Such rights, powers, duties, and obligations may not be set forth separately on Schedule G. Nothing in Schedule G shall operate as a bar to the right to treat such agreements as severable. In addition, the Debtor may have entered into various other types of agreements in the course of the Debtor's business, such as easements, rights of way, subordination agreements, nondisturbance agreements, supplemental agreements, amendments, letter agreements, title agreements, and confidentiality agreements. Such documents may not be set forth on Schedule G. Schedule G may not include certain stand alone purchase orders for goods or equipment or nondisclosure agreements.
- 22. Omission of a contract, lease or agreement from Schedule G does not constitute an admission that such omitted contract, lease or agreement is <u>not</u> an executory contract or unexpired lease. The Trustee's or the Debtor's rights under the Bankruptcy Code with respect to any such omitted contracts or agreements are not impaired by any such omission.
- 23. The responses to SOFA questions #17a, 17b, and 17c and other SOFA questions were made to the best of the Trustee's knowledge and by reviewing documents contained in the Debtor's files. The answers to these questions do not take into account or reflect, as to the Debtor's facilities and assets, information from any time period before the Debtor's acquisition or occupation of such facilities and assets or any outside research.
- 24. Except as may be otherwise indicated in the SOFAs or the Schedules, the Trustee has included payments made by the Debtor during the one-year period preceding the Petition Date to persons deemed an "insider," as that term is defined in section 101(31)

of the Bankruptcy Code. The Trustee does not take any position with respect to (a) any such person's influence over the control of the Debtor, (b) the management responsibilities or functions of any such person, (c) the decision-making or corporate authority of any such person, or (d) whether any such person could successfully argue that he or she is not an "insider" under applicable law.

25. The Trustee specifically reserves the right to amend, modify, supplement, correct, change, or alter any part of the Schedules, SOFAs and Global Notes as and to the extent necessary and as she deems appropriate.
