VERIFIED STATEMENT OF DUANE MORRIS LLP AND TARLOW & STONECIPHER, PLLC PURSUANT TO FEDERAL RULE OF BANKRUPTCY PROCEDURE 2019

Duane Morris LLP ("<u>Duane Morris</u>") and Tarlow & Stonecipher, PLLC ("<u>Tarlow</u>" and, together with Duane Morris, "<u>Counsel</u>"), as counsel to certain parties-in-interest (the "<u>Mineral Interest Holders</u>") and in connection with the above-captioned chapter 11 cases (the "<u>Chapter 11 Cases</u>") of Triangle USA Petroleum Corporation ("<u>TUSA</u>") and its affiliated debtors and debtors-in-possession (collectively, including TUSA, the "<u>Debtors</u>"), submit this verified statement (the "<u>Verified Statement</u>") pursuant to Rule 2019 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") and respectfully state as follows:

1. The Mineral Interest Holders are parties who seek, among other things, declaratory judgment recognizing their ownership of certain mineral interests claimed by TUSA. The Mineral Interest Holders contest TUSA's claims against their mineral interests for the reasons set forth in the Amended Complaint attached as Exhibit A to the *Reservation of Rights in Response to Debtors' Motion for Final Order Under Bankruptcy Code Sections 105(a), 363*,

- 2. On June 29, 2016, the Debtors filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code. No official committee of unsecured creditors, trustee, or examiner has been appointed in the Chapter 11 Cases.

In addition, all other rights, claims, actions, defenses, setoffs, or recoupments to which the Mineral Interest Holders are or may be entitled under agreements, in law, or in equity, all of which rights, claims, actions, defenses, setoffs, and recoupments are expressly reserved, and nothing contained in this Verified Statement (or Exhibit A hereto) should be construed as a limitation upon, or waiver of, any of the Mineral Interest Holders' rights to assert, file and/or amend their claims or statements of interests in accordance with applicable law and any orders entered in the Chapter 11 Cases.
- 5. Counsel reserves the right to amend or supplement this Verified Statement in accordance with the requirements set forth in Bankruptcy Rule 2019.
