**FINAL ORDER CONFIRMING
CHAPTER 11 TRUSTEE'S LIQUIDATING PLAN FOR
UNIVERSAL HEALTH CARE GROUP, INC. DATED APRIL 16, 2015**

[Doc. No. 1442, Doc. No. 1498]

This Chapter 11 case initially came on for hearing on April 23, 2015 to consider confirmation of the Amended Liquidating Chapter 11 Plan proposed by Soneet R. Kapila, as Chapter 11 Trustee, for the Debtor, Universal Health Care Group, Inc., dated April 16, 2015 (the "Universal Amended Plan") (Doc. No. 1442).¹

At that time, the Court heard and considered (i) the argument and proffers of counsel for Soneet R. Kapila, Chapter 11 Trustee for Universal Health Care Group, Inc. (the "Trustee"); (ii)

No. 1286); (iii) the Order Approving Amended Disclosure Statement of Universal Health Care Group, Inc., Fixing Time to File Applications for Professional Administrative Expenses, Setting Hearing on Confirmation of Plan and Setting Deadlines with Respect to Confirmation Hearing (Doc. No. 1284); (iv) the Certificate of Service with Respect to Universal Health Care Group, Inc. Solicitation Package (Doc. No. 1293); (v) the Trustee's first Motion to Modify Chapter 11 Liquidating Plan for Universal Health Care Group, Inc. and Notice of Hearing, dated April 2, 2015 (Doc. No. 1396); (vi) the Trustee's Amended Chapter 11 Plan, as Modified, for Universal Health Care Group, Inc., dated April 16, 2015 (Doc. No. 1442); (vii) the Trustee's Second Motion to Modify Chapter 11 Liquidating Plan for Universal Health Care Group, Inc. and Notice of Hearing, dated April 16, 2015 (Doc. No. 1441); (viii) the Certificate of Service for the Amended Chapter 11 Plan, as Modified, for Universal Health Care Group, Inc. (Doc. No. 1451); (ix) the Ballot Tabulation for Universal Health Care Group, Inc. (Doc. No. 1449); (x) the Chapter 11 Trustee's Confirmation Affidavit in Support of the Liquidating Chapter 11 Plan for Universal Health Care Group, Inc. (Doc. No. 1459); as well as other relevant portions of the record in this Chapter 11 case and Case No. 8:13-bk-5952, including the March 2015 monthly operating report filed by the Trustee for Universal Health Care Group, Inc. ("Universal") (Doc. No. 1430).

By Order dated May 4, 2015, the Universal Amended Plan was conditionally confirmed in all respects, subject only to separate approvals of the WARN Act Settlement incorporated into the Universal Amended Plan (the "Universal Conditional Confirmation Order") (Doc. No. 1498).

The Court specifically incorporates into this Order all of the Findings of Fact and Conclusions of Law set forth in the Universal Conditional Confirmation Order and makes the following additional findings:

1. On May 4, 2015, this Court entered its Order Granting Chapter 11 Trustee's Motion to Approve Compromise of Controversy of WARN Act Litigation. (Doc. No. 1493).

2. On May 28, 2015, this Court conducted a fairness hearing in *De La Concha, et al. v. American Managed Care, LLC, et al.*, Adv. No. 8:13-ap-00273-KRM. At the conclusion of the fairness hearing, this Court approved the WARN Act Settlement as fair and equitable, and consistent with the WARN Act Settlement: (a) certified the class of former employees as provided in the WARN Act Settlement; (b) approved proposed Class Counsel; and (c) approved the Class Representatives and their Incentive Awards. The Order Approving Class Representatives, Class Counsel, Class Certification and Related Relief was entered on June 15, 2015 (Doc. No. 80, Adv. No. 8:13-ap-00273-KRM).

3. All of the required WARN Act Settlement Approvals have been obtained and there are no further conditions or contingencies to final confirmation of the Universal Amended Plan.

Accordingly, it is

ORDERED, ADJUDGED AND DECREED as follows:

A. The Universal Amended Plan is CONFIRMED, in all respects, in accordance with 11 U.S.C. § 1129.

B. Pursuant to the Universal Amended Plan, the WARN Act Class shall have the following Allowed Claims, which are limited and more particularly described in the WARN Act Settlement and the Universal Amended Plan:

1. An Allowed Class Administrative Claim in the total amount of a single recovery of \$200,000.

2. An Allowed Class Priority Claim in the amount of a maximum single priority recovery of \$7.0 million to be funded exclusively from payments received from (a) the Contingent WARN Act Claims of Universal and American Managed Care, LLC (“AMC”) filed in the receivership proceedings for Universal Health Care, Inc. and Universal Health Care Insurance Company, Inc. and (b) the WARN Act claims filed by Universal and AMC in the receivership proceedings for Universal HMO of Texas, Inc. and Universal Health Care of Nevada, Inc. (the “WARN Act Recoveries”).

3. An Allowed Class Unsecured Claim in the amount of a single maximum recovery of \$1.5 million, subject to being increased by the difference between \$6.0 million and the actual gross WARN Act Recoveries.

C. The claims attached as **Exhibit A** to this Order are hereby assigned to the UHC WARN Act Settlement QSF for the benefit of the Allowed WARN Act Class Claim.

D. All of the provisions of the Universal Amended Plan are approved, including explicitly the “Exculpation from Liability” provision at section 12.2 of the Universal Amended Plan.

E. The injunction and release provisions contained in Article 12 of the Universal Amended Plan are specifically approved and incorporated into this Order.

F. The Escrowed Funds held by counsel for the Trustee pursuant to the FDFS Settlement shall be transferred to the Trustee.

G. Upon the filing of a Notice of the Effective Date of the Universal Amended Plan, (i) Soneet R. Kapila is appointed as the Liquidating Agent for Universal’s Liquidating Estate and

(ii) Mr. Kapila's duties and responsibilities as the Chapter 11 Trustee are fully discharged and any bond posted in connection with his services as the Chapter 11 Trustee in this case may be discharged and released.

H. Any supplemental fee applications by the Trustee and his professionals arising through the date of this Order shall be filed with the Court no later than fourteen (14) days from the date of this Order.

Attorney Roberta A. Colton is directed to serve a copy of this order on interested parties who are non-CM/ECF users and to file a proof of service within three days of entry of the order.

Settlement Agreement

The Trustee, the WARN Act Plaintiffs and BankUnited (the "Parties") enter into the following Settlement Agreement (the "WARN Act Settlement").


Introduction. This WARN Act Settlement is based upon in part and incorporates certain provisions of the approved global settlement among (i) the Trustee on behalf of Universal Health Care Group, Inc. ("Universal") and American Managed Care, LLC ("AMC"); (ii) the Florida Department of Financial Services ("DFS"), as receiver for Universal Health Care, Inc. ("UHC") and Universal Health Care Insurance Company, Inc. ("UHCIC"), and (iii) BankUnited ("Bank") (the "DFS Settlement").

The Parties agree to the following.


1. The class will be certified as "all employees terminated as a result of the receiverships of UHCG's subsidiaries who have WARN Act claims of any type against AMC and/or UHCG" (the "Class")
2. Barack, Williamson and Meyers will be approved as Class Counsel. Frankie Pantuso will be approved as representatives of the Class.
3. This settlement is subject to approval by the Bankruptcy Court under Bankruptcy Rule 9019 (or as part of the liquidating Chapter 11 plans for Universal and AMC), and pursuant to an appropriate "fairness" hearing.
4. If 10% or more of the former employees of the Class opt out of the Class, the settlement will be null and void, at the Trustee's discretion. If more than 5%, but less than 10%, of the former employees of the Class opt out, the Allowed Class Administrative Claim (as defined below) will be reduced by \$50,000.
5. Class Counsel shall be responsible for notification of members of the Class and the "fairness" hearing and all costs associated therewith. The Trustee shall be responsible for the Rule 9019 motion, or the Chapter 11 plans, and notice to creditors and parties in interest in the bankruptcy cases, and all costs associated therewith.
6. The Class will have an allowed "class" priority claim in the bankruptcy case of Universal and AMC (the "Allowed Class Priority Claim"). The amount of the Allowed Class Priority Claim will be a maximum single priority recovery of \$7.0 million. Funding for the Allowed Class Priority Claim will be exclusively from payments received on (i) the WARN Act contingent claims against UHC and UHCIC that are described in the DFS Settlement, and (ii) any recoveries received on account of the contingent WARN Act claims filed by Universal and AMC in the receivership proceedings for Universal HMO of Texas, Inc. ("UHMOTX") and Universal Health Care of Nevada, Inc. ("UHCNV"). Collectively, these recoveries are referred to as the "WARN Act Recoveries." The contingent WARN Act claims filed against UHMOTX and UHCNV shall be assigned to the Class.

7. The Class will have an allowed administrative claim in the Chapter 11 case of Universal and AMC for \$200,000 (the "Allowed Class Administrative Claim"). The Allowed Class Administrative Claim shall be a single recovery of \$200,000 and not two separate claims for \$200,000. Any amount received from AMC will be credited to Universal and vice versa. The Allowed Class Administrative Claim will be paid from the assets of the respective bankruptcy estates and will not be reduced by the WARN Act Recoveries. The Class agrees that if Universal and/or AMC prove to be administratively insolvent at confirmation, then the Allowed Class Administrative Claim will be paid pro rata with other allowed administrative claims until each allowed class administrative claim is paid in full.
8. The Class will have an allowed unsecured claim in the Chapter 11 case of Universal and in the Chapter 11 case of AMC of \$1.5 million (the "Allowed Class Unsecured Claim"). If the WARN Act Recoveries are less than \$6.0 million, then the Allowed Class Unsecured Claim shall be increased by the difference between \$6.0 million and the actual gross WARN Act Recoveries. The Allowed Class Unsecured Claim shall be filed in both bankruptcy cases, but there shall only be a single recovery, and any payment received in one case will be credited in the other.
9. The Orders confirming the Chapter 11 Plans for AMC and Universal will incorporate the terms of this WARN Act Settlement and will provide for a WARN Act Fund to be administered by Class Counsel. The WARN Act Fund will consist of (i) funds received from Universal and AMC on account of the Allowed Class Administrative Claim; (ii) funds received from receivers on the WARN Act Recoveries in satisfaction of the Allowed Class Priority Claim; and (iii) funds received from Universal and AMC on account of the Allowed Class Unsecured Claim.
10. The WARN Act Fund will be treated as a "common fund" or a Qualified Settlement Fund. Accordingly, any attorneys' fees for Class Counsel, any Class representative fees (if any), and any taxes to be paid or withheld as a result of this settlement, will be deducted and paid exclusively from the WARN Act Fund. Any attorneys' fees for Class Counsel will be approved as part of the fairness hearing. Class Counsel will distribute all funds from the WARN Act Fund, after the payment of allowed attorneys' fees and taxes, to members of the Class on a pro rata basis. The Trustee will work with Class Counsel to properly identify members of the Class and the amount of their WARN Act claim. Interim distributions may be made at the discretion of Class Counsel. The Trustee and the liquidating estates of Universal and AMC shall not be responsible for any attorneys' fees to Class Counsel, any tax compliance matters, including W-2s or other tax forms to any former employees, or any taxes or tax withholdings.
11. The pending application for administrative claim will be granted to the extent set forth herein. Proofs of claim filed by any individual WARN Act claimants will be denied, without prejudice to receive payment from the WARN Act Fund. The pending adversary proceedings will be dismissed.

- 12. The WARN Act Claimants, by and through Class Counsel, will agree to support the Chapter 11 liquidating plans for Universal and AMC with the proposed treatment and payment structure for the Allowed WARN Act Class Claim.
- 13. The settlement proposal is on a no admissions basis and is made by the Trustee on behalf of Universal and AMC to avoid the expense and risk of the pending class action litigation. Should any former employee opt out and attempt to pursue an independent claim, the Trustee shall object to such claim on numerous grounds, including the fact that the terminations were ordered by the receivership orders.

Settlement Agreement

The Trustee, the WARN Act Plaintiff's and BankUnited (the "Parties") enter into the following Settlement Agreement (the "WARN Act Settlement").

Introduction. This WARN Act Settlement is based upon in part and incorporates certain provisions of the approved global settlement among (i) the Trustee on behalf of Universal Health Care Group, Inc. ("Universal") and American Managed Care, LLC ("AMC"); (ii) the Florida Department of Financial Services ("DFS"), as receiver for Universal Health Care, Inc. ("UHC") and Universal Health Care Insurance Company, Inc. ("UHCIC"), and (iii) BankUnited ("Bank") (the "DFS Settlement").

The Parties agree to the following.

1. The class will be certified as "all employees terminated as a result of the receiverships of UHCG's subsidiaries who have WARN Act claims of any type against AMC and/or UHCG" (the "Class")
2. Barack, Williamson and Meyers will be approved as Class Counsel. Frankie Pantuso will be approved as representatives of the Class. AFS ✓ PAB
RA
3. This settlement is subject to approval by the Bankruptcy Court under Bankruptcy Rule 9019 (or as part of the liquidating Chapter 11 plans for Universal and AMC), and pursuant to an appropriate "fairness" hearing. P
4. If 10% or more of the former employees of the Class opt out of the Class, the settlement will be null and void, at the Trustee's discretion. If more than 5%, but less than 10%, of the former employees of the Class opt out, the Allowed Class Administrative Claim (as defined below) will be reduced by \$50,000.
5. Class Counsel shall be responsible for notification of members of the Class and the "fairness" hearing and all costs associated therewith. The Trustee shall be responsible for the Rule 9019 motion, or the Chapter 11 plans, and notice to creditors and parties in interest in the bankruptcy cases, and all costs associated therewith.
6. The Class will have an allowed "class" priority claim in the bankruptcy case of Universal and AMC (the "Allowed Class Priority Claim"). The amount of the Allowed Class Priority Claim will be a maximum single priority recovery of \$7.0 million. Funding for the Allowed Class Priority Claim will be exclusively from payments received on (i) the WARN Act contingent claims against UHC and UHCIC that are described in the DFS Settlement, and (ii) any recoveries received on account of the contingent WARN Act claims filed by Universal and AMC in the receivership proceedings for Universal HMO of Texas, Inc. ("UHMOTX") and Universal Health Care of Nevada, Inc. ("UHCNV"). Collectively, these recoveries are referred to as the "WARN Act Recoveries." The contingent WARN Act claims filed against UHMOTX and UHCNV shall be assigned to the Class.

7. The Class will have an allowed administrative claim in the Chapter 11 case of Universal and AMC for \$200,000 (the "Allowed Class Administrative Claim"). The Allowed Class Administrative Claim shall be a single recovery of \$200,000 and not two separate claims for \$200,000. Any amount received from AMC will be credited to Universal and vice versa. The Allowed Class Administrative Claim will be paid from the assets of the respective bankruptcy estates and will not be reduced by the WARN Act Recoveries. The Class agrees that if Universal and/or AMC prove to be administratively insolvent at confirmation, then the Allowed Class Administrative Claim will be paid pro rata with other allowed administrative claims until each allowed class administrative claim is paid in full.
8. The Class will have an allowed unsecured claim in the Chapter 11 case of Universal and in the Chapter 11 case of AMC of \$1.5 million (the "Allowed Class Unsecured Claim"). If the WARN Act Recoveries are less than \$6.0 million, then the Allowed Class Unsecured Claim shall be increased by the difference between \$6.0 million and the actual gross WARN Act Recoveries. The Allowed Class Unsecured Claim shall be filed in both bankruptcy cases, but there shall only be a single recovery, and any payment received in one case will be credited in the other.
9. The Orders confirming the Chapter 11 Plans for AMC and Universal will incorporate the terms of this WARN Act Settlement and will provide for a WARN Act Fund to be administered by Class Counsel. The WARN Act Fund will consist of (i) funds received from Universal and AMC on account of the Allowed Class Administrative Claim; (ii) funds received from receivers on the WARN Act Recoveries in satisfaction of the Allowed Class Priority Claim; and (iii) funds received from Universal and AMC on account of the Allowed Class Unsecured Claim.
10. The WARN Act Fund will be treated as a "common fund" or a Qualified Settlement Fund. Accordingly, any attorneys' fees for Class Counsel, any Class representative fees (if any), and any taxes to be paid or withheld as a result of this settlement, will be deducted and paid exclusively from the WARN Act Fund. Any attorneys' fees for Class Counsel will be approved as part of the fairness hearing. Class Counsel will distribute all funds from the WARN Act Fund, after the payment of allowed attorneys' fees and taxes, to members of the Class on a pro rata basis. The Trustee will work with Class Counsel to properly identify members of the Class and the amount of their WARN Act claim. Interim distributions may be made at the discretion of Class Counsel. The Trustee and the liquidating estates of Universal and AMC shall not be responsible for any attorneys' fees to Class Counsel, any tax compliance matters, including W-2s or other tax forms to any former employees, or any taxes or tax withholdings.
11. The pending application for administrative claim will be granted to the extent set forth herein. Proofs of claim filed by any individual WARN Act claimants will be denied, without prejudice to receive payment from the WARN Act Fund. The pending adversary proceedings will be dismissed.

- 13. The settlement proposal is on a no admissions basis and is made by the Trustee on behalf of Universal and AMC to avoid the expense and risk of the pending class action litigation. Should any former employee opt out and attempt to pursue an independent claim, the Trustee shall object to such claim on numerous grounds, including the fact that the terminations were ordered by the receivership orders.
- 14. ~~The terms of this letter agreement will be memorialized in a comprehensive settlement agreement acceptable in form to both Class Counsel and the undersigned.~~
