# NOTES REGARDING THE DEBTOR'S BANKRUPTCY SCHEDULES AND STATEMENTS

#### **General Notes**

The Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "SOFA" and, collectively with the Schedules, the "Bankruptcy Materials") of The Young Men's Christian Association of Metropolitan Milwaukee, Inc. (the "Debtor") were prepared pursuant to 11 U.S.C. § 521 and Rule 1007 of the Federal Rules of Bankruptcy Procedure by management of the Debtor.

While Debtor's management has made reasonable efforts to ensure that the Bankruptcy Materials are accurate and complete, based upon information that was available to them at the time of preparation, subsequent information may result in material changes to the Bankruptcy Materials. If the Debtor becomes aware of any errors, inaccuracies or omissions in the Schedules, it will promptly file appropriate amendments.

<u>Basis of Presentation.</u> The Debtor has an affiliate, YMCA Youth Leadership Academy, Inc. ("YLA"), that is also a Chapter 11 debtor. The Bankruptcy Materials reflect the unconsolidated assets and liabilities of the Debtor and YLA to the extent distinguishable. Similarly, the revenues depicted in these Bankruptcy Materials have been presented on an accrual basis, unconsolidated for the Debtor and YLA. The Bankruptcy Materials do not purport to represent financial statements prepared in accordance with U.S. Generally Accepted Accounting Principles or any other recognized financial reporting framework, nor are they intended to reconcile to any financial statements otherwise prepared or distributed by the Debtor or YLA.

<u>Consolidated Accounting and Disbursements System.</u> In conducting their financial affairs, the Debtor frequently acts on behalf of YLA. In the Bankruptcy Materials, payments are listed by the entity making such payment notwithstanding that many such payments may have been made on behalf of another entity.

<u>Dates.</u> Unless otherwise indicated, all asset and liability information is listed as of June 4, 2014 (the "Petition Date").

<u>Insiders</u>. In places where the Bankruptcy Materials require information regarding "insiders," the Debtor has interpreted that term as limited to (a) the Debtor's directors, (b)

employees that are, or were during the relevant period, "officers" of the Debtor, as such term is defined by applicable law, and (c) YLA.

<u>Totals.</u> All totals that are included in the Bankruptcy Materials represent totals of all the known amounts included in the Schedules.

<u>Current Values</u>. Values shown in Schedule A and B28 reflect Management estimates of current value for these assets based on preliminary indications of interest for certain of the Debtor's properties and factoring in known deed restrictions, or other limitations of use, and other market factors where Management deemed appropriate. Unless otherwise indicated, the basis for all other current values included in these Bankruptcy Materials was the estimated net book value from the Debtor's books and records as of the Petition Date where identifiable or, in some cases, as of May 31, 2014 month end close. The estimated net book values may not reflect the actual current value of the respective asset. Amounts ultimately realized from a disposition of the Debtor's assets may vary from net book value, and such variance may be material.

#### Notes to the Schedules of Assets and Liabilities

<u>Schedule B: Personal Property.</u> The Debtor may not have included certain assets with a net book value of zero within Schedule B.

<u>Schedule B.2: Checking, Savings and Other Financial Accounts.</u> Bank account balances included on B.2 are reflective of the closing bank balances as at June 3, 2014. On and after the Petition Date, a number of previously issued checks were not honored. As a result, the bank balances may differ slightly from the book balances due to these returned checks and other common reconciling items.

<u>Schedule B.9: Interests in Insurance Policies.</u> The Debtor has not yet made a determination as to the surrender or refund value of each insurance policy, so the balance is listed as undetermined.

<u>Schedule B.16</u>: <u>Accounts Receivable</u>. Accounts Receivable are presented without consideration for any liabilities related to mutual counterparty accounts payable, open or terminated contract liabilities, liquidated damages, setoff rights or collateral held by the Debtor, unless otherwise stated.

Schedule D: Creditors Holding Secured Claims. The Bankruptcy Court has granted a motion filed by BMO Harris Bank N.A. ("BMO") that will have the effect of causing U.S. Bank as bond trustee to draw on a BMO letter of credit to pay off the bonds outstanding. As a result, the amounts outstanding shown on these Bankruptcy Materials reflect the expectation that debt held on the Petition Date by a group of disparate bondholders will become obligations of the Debtor owed to BMO.

The descriptions provided in Schedule D are intended only to be a summary. Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Except as specifically stated herein, real property lessors, utility companies and other parties that may hold security deposits have not been listed on Schedule D. Certain of the Debtor's agreements listed on Schedule G may be in the nature of conditional sales agreements or secured financing agreements; no attempt has been made to identify such agreements for purposes of Schedule D.

Schedule E: Priority Claims Already Paid Pursuant to Court Orders. The Bankruptcy Court has authorized the Debtor to pay certain prepetition claims, including but not limited to, employee wages, payroll taxes and expense reimbursements. Consequently, certain prepetition priority claims have been paid following the Petition Date. Additional payments may be made to prepetition claimants following the filing of the Bankruptcy Materials, pursuant to further orders of the Court.

Schedule F: Creditors Holding Unsecured Non-Priority Claims. Schedule F does not include certain deferred charges, deferred liabilities or general reserves. Such amounts are general estimates of liabilities and do not represent specific claims as of the Petition Date; however, they may be reflected on the Debtor's books and records as required in accordance with GAAP.

In addition, certain claims listed on Schedule F may be entitled to priority under 11 U.S.C. § 503(b)(9). The Debtor has made its best efforts to include all trade creditors on Schedule F; however, the Debtor believes there are instances where vendors have yet to provide proper invoices for prepetition goods or services.

<u>Schedule G: Executory Contracts.</u> Some of the contracts and agreements identified on Schedule G may have expired or may have been modified, amended and supplemented from time to time by various documents, instruments and agreements which may not be listed therein.

#### **Notes to Statement of Financial Affairs**

<u>SOFA 1: Income from Operations of Business.</u> Income represents revenue presented on an accrual basis, unconsolidated for the Debtor. January 1, 2014 through June 4, 2014 represents a preliminary estimate of income.

<u>SOFA 3C: Payments to Creditors Who Were Insiders.</u> While these Bankruptcy Materials contain Intercompany balances outstanding as of the petition date, SOFA 3C does not include intercompany transaction history as a majority of the daily activity between the two entities is recorded directly through journal entry revisions throughout the year.

SOFA 9: Payments Related to Debt Counseling or Bankruptcy. Payments relating to bankruptcy professionals have been made by the Debtor behalf of both itself and YLA.
