RESOLVED, authorizing DIZ to file a Chapter 11 reorganization bankruptcy in the State of Arizona.

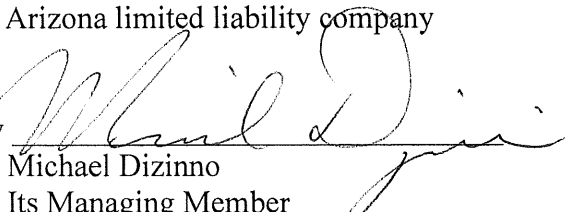

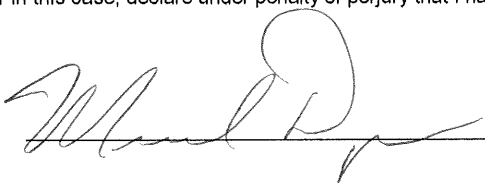
