  - 15 3. Within the time limits imposed by the Bankruptcy Rules 2002(b) and 3017(a), the  
16 proponent of the plan shall transmit the Disclosure Statement and plan to any  
17 committee appointed pursuant to §1102 of the Code; the Securities and Exchange  
18 Commission, Attn: Bankruptcy Counsel, 5670 Wilshire Blvd., 11<sup>th</sup> Floor, Los  
19 Angeles, CA 90036-3684 if it has filed a notice of appearance or a request to  
20 receive notices; and any party in interest who has requested or requests in writing  
21 a copy of the Disclosure Statement and plan, and shall mail this order to the above  
22 parties and to all creditors and other interested parties. The proponent shall file a  
23 certificate or affidavit evidencing such transmission.
