Century City Doctors Hospital, LLC ("CCDH") filed a Chapter 7 case on August 22, 2008 and bears Case No. 2:08-23318. The case is pending in the Central District of California, Los Angeles Division, and has been assigned to the Honorable Samuel Bufford. Although the Debtor does not appear to be an "affiliate" of CCDH pursuant to section 101 of the Bankruptcy Code, substantial ties exist between the two entities such that their cases should be heard by the same court. The founder of the Debtor, Randy Rosen, M.D. ("Dr. Rosen"), owns an approximately 23.6% equity stake in the Debtor as well as an approximately 5.2% equity stake in CCDH.

Both CCDH and the Debtor also share connections with Salus Surgical Group, LLC ("Salus"), which was founded by Dr. Rosen. As of the Petition Date, Dr. Rosen owned an approximately 16.2% equity interest in Salus. Salus managed the Debtor until September 2008, and the Debtor is informed and believes that Salus was the founder and general partner of CCDH. As of August 22, 2008 when CCDH filed its chapter 7 bankruptcy petition, Salus owned approximately 70% of the stock of CCDH.

Finally, Dr. Rosen was for significant periods during the past five years the President of the Debtor, the Chief Executive Officer of Salus, and a member of the board of managers of CCDH. Dr. Rosen also signed the Schedules and Statement of Financial Affairs for CCDH.

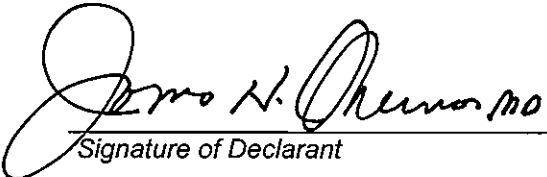

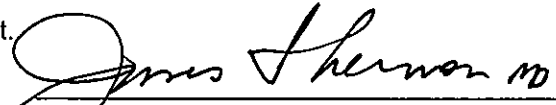

Century City Doctors Hospital, LLC ("CCDH") filed a Chapter 7 case on August 22, 2008 and bears Case No. 2:08-23318. The case is pending in the Central District of California, Los Angeles Division, and has been assigned to the Honorable Samuel Bufford. Although the Debtor does not appear to be an "affiliate" of CCDH pursuant to section 101 of the Bankruptcy Code, substantial ties exist between the two entities such that their cases should be heard by the same court. The founder of the Debtor, Randy Rosen, M.D. ("Dr. Rosen"), owns an approximately 23.6% equity stake in the Debtor as well as an approximately 5.2% equity stake in CCDH.

Both CCDH and the Debtor also share connections with Salus Surgical Group, LLC ("Salus"), which was founded by Dr. Rosen. As of the Petition Date, Dr. Rosen owned an approximately 16.2% equity interest in Salus. Salus managed the Debtor until September 2008, and the Debtor is informed and believes that Salus was the founder and general partner of CCDH. As of August 22, 2008 when CCDH filed its chapter 7 bankruptcy petition, Salus owned approximately 70% of the stock of CCDH.

Finally, Dr. Rosen was for significant periods during the past five years the President of the Debtor, the Chief Executive Officer of Salus, and a member of the board of managers of CCDH. Dr. Rosen also signed the Schedules and Statement of Financial Affairs for CCDH.

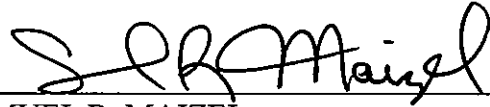

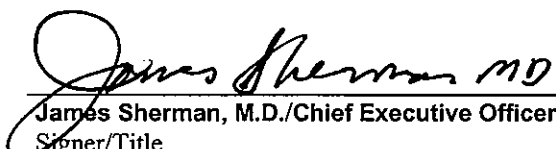
